INDEPENDENT AUDITOR'S REPORT

The Benefits Committee
Sanderson Farms, Inc. and Affiliates Welfare Benefit Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sanderson Farms, Inc. and Affiliates Welfare Benefit Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (cash basis) in liquidation as of October 31, 2024 and 2023, the related statement of changes in net assets available for benefits (cash basis) in liquidation for the year ended October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of October 31, 2024 and 2023, and for the year ended October 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to and derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualifying institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis

As discussed in Note 1 to the financial statements, the Board of Directors of Sanderson Farms, Inc. and Affiliates, the Plan's sponsor, voted on August 26, 2023 to terminate the Plan, and management determined liquidation is imminent as of October 13, 2023. As a result, the accompanying financial statements have been prepared using the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Note 1. Description of the Plan

The following description of the Sanderson Farms, Inc. and Affiliates Welfare Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a welfare benefit plan that provides hospitalization, major medical benefits, dental benefits, vision benefits, basic life insurance, voluntary life insurance, whole life insurance, accidental death and dismemberment coverage and long-term disability coverage to substantially all employees of Sanderson Farms, LLC (formerly, Sanderson Farms, Inc., the Plan's sponsor) and its affiliated companies (collectively, the "Company") and retirees electing to continue coverage under the Plan.

Certain Plan assets are held in a voluntary employees' beneficiary association ("VEBA") trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Plan Termination

On October 13, 2023, the Board of Directors of the Plan's sponsor adopted resolutions to terminate the Plan effective January 1, 2024. As a result, management determined liquidation was imminent as of October 13, 2023.

Benefits

Salaried employees become eligible after a 30-day waiting period. Hourly employees become eligible after a 90-day waiting period. Participants are required to work a minimum of 30 hours per week to maintain coverage. The Plan also covers eligible dependents of participants. Employees who retire after 30 years of continuous service or after reaching the earliest social security retirement age (provided they have five years of continuous service immediately preceding the retirement date) are eligible to retain health insurance, dental benefits, basic life and accidental death and dismemberment coverage. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act ("COBRA").

The Company purchases annual insurance contracts for these benefits. Premiums for major medical benefits are paid from the assets of the VEBA trust. Premiums for all other benefits are paid to the insurance company from the general assets of the Company.

Contributions

The Plan agreement provides that the Company and employees will make contributions to the Plan. Employee contributions are withheld through payroll deductions and remitted by the Company. In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of dental benefits, vision benefits, voluntary life insurance, whole life insurance and long-term disability coverage and half of the cost of accidental death and dismemberment coverage based on the current group rate premium cost.

The Company pays the full cost of basic life insurance and stop loss insurance and half of the cost of accidental death and dismemberment coverage based on the current group rate premium cost. The Company has established the level of funding for major medical benefits by the participants based on past claims experience and estimates of future fluctuations in cost.

Note 2. Significant Accounting Policies

Basis of Accounting

The accounting records of the Plan are maintained on the cash basis. Health claims, reinsurance and other premiums and administrative and other expenses are recognized when paid. Contributions are recognized when received.

The accompanying financial statements of the Plan have been prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments as of October 31, 2024 and 2023 are reported at liquidation value. For all investments, fair value approximates the amounts the Plan expects to collect at liquidation. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recognized when received.

Payment of Benefits

Benefits are recorded when paid.

Plan Benefits

Plan obligations are estimated by the Company based on claims history.

Reinsurance and Other Premiums

The Plan has an administrative services agreement with Blue Cross Blue Shield of Mississippi, Inc. ("Blue Cross") to process all medical health claims. Such claims are paid by Blue Cross and subsequently reimbursed by the Plan's VEBA trust after approval from the Company has been granted. The Plan pays expenses charged by Blue Cross for administering the Plan. The Plan has a reinsurance policy to cover medical health claims over specified limits. Premiums for this policy are paid by the Plan.

Premiums for stop loss insurance are included in reinsurance and other premiums in the accompanying statement of changes in net assets available for benefits. Stop loss refunds totaling \$2,289,301 have been netted with health claims, net in the accompanying statement of changes in net assets available for benefits.

Administrative and Other Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the trustee, and actuary as well as professional fees. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. Other expenses include severance payments made to employees of the Company in the amount of \$765,541.

Note 3. Information Certified by Regions Bank

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at October 31, 2024 and 2023 and interest income for the year ended October 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Regions Bank, the trustee of the Plan.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. As discussed in Note 2, fair value as of October 31, 2024 and 2023 approximates the amount the Plan expects to collect at liquidation.

Interest bearing deposit account: Valued at net asset value as determined by the fair market value of all securities owned by the fund (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Income Tax Status

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service dated June 30, 1995, stating the trust is tax-exempt under the provision of Section 501(c)(9) of the Internal Revenue Code (the "Code") as a VEBA. The Plan has been amended since the issuance of the exemption letter. The Plan and the VEBA trust are required to operate in conformity with the Code to maintain the tax-exempt status of the VEBA trust. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the related VEBA trust is tax-exempt.

Note 7. Related Party Transactions

During the year ended October 31, 2024, certain Plan investments were interest bearing deposit funds managed by Regions Bank. Regions Bank is the trustee of the Plan assets as defined by the Plan and therefore, these transactions qualify as exempt party-in-interest transactions. The Plan paid Regions Bank fees totaling \$750 for such investment management services during the year ended October 31, 2024.

Note 8. Risks and Uncertainties

The Plan invests in interest bearing deposit accounts; however, the accounts are not insured or guaranteed by the Federal Deposit Insurance Corporation or any other government agency. The fund's objective is to maintain fair market value at \$1 per share by investing in high quality, short-term securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits in liquidation.

The adequacy of Plan assets available to cover future claims, combined with estimated funding, is dependent on future claims experience, which may fluctuate significantly from year to year.

Note 9. Plan Termination

The Board of Directors of the Plan's sponsor voted on August 26, 2023 to terminate the Plan as of January 1, 2024, and management determined liquidation is imminent as of October 13, 2023 as discussed in Note 1. Beginning on January 1, 2024 claims paid from the VEBA trust are limited to those incurred prior to January 1, 2024 through the run-out period of December 31, 2026.

Note 10. Subsequent Events

The Plan has evaluated subsequent events through August 11, 2025, the date the financial statements were available to be issued and incorporated all subsequent events within the financial statements.
