## Independent Auditor's Report

To the Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hedrick Brothers Construction Co., Inc. Thrift and Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information so held are prepared and certified to by the qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of and for the years ended October 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The information included in the supplemental information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## NOTES TO FINANCIAL STATEMENTS

### Note 1 – Description of Plan

The following description of the Hedrick Brothers Construction Co., Inc. Thrift and Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General and eligibility

The Plan was established on November 1, 1997, as a defined contribution plan available to eligible employees of Hedrick Brothers Construction Co., Inc. (the Company, Employer, or Plan Sponsor). The Plan has since been amended and restated throughout the years to comply with certain tax legislation. Employees who have reached age eighteen (18) and completed three months of credited service are eligible to participate in the Plan. Eligible employees may participate in the Plan on the first day of the calendar quarter following the date the eligibility requirements are satisfied.

The Company is the Plan Administrator. ADP Retirement Services (ADP) is the Plan's recordkeeper and third-party administrator providing recordkeeping, compliance, and reporting services to the Plan. Reliance Trust Company (RTC or the Trustee), serves as the trustee of the Plan, holds the Plan's investment assets, and executes investment transactions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may voluntarily contribute up to 90% of their eligible annual compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants may make Roth 401(k) elective deferrals in accordance with the Plan's provisions.

The Company may make discretionary matching contributions to participants who have completed at least three (3) months of service. The Company's discretionary matching contribution for each of the years ended October 31, 2024 and 2023 were equal to 25% of individual participant contributions up to a maximum of 6% of the participant's eligible compensation, as defined by the Plan. For the years ended October 31, 2024 and 2023, the Company made discretionary matching contributions totaling \$195,037 and \$149,035, respectively.

The Company may also make a profit-sharing contribution under the Plan's profit-sharing provisions which is determined by the Company's executive management. Participants who have completed at least one (1) year of service and are employed on the last day of the Plan year are eligible to receive profit sharing contributions. There were no profit-sharing contributions made by the Company for the years ended October 31, 2024 and 2023.

Contributions are subject to certain IRS limitations.

#### Participant accounts

Each participant's account is credited with the participant's contribution and an allocation of: (a) the Employer's contributions (if any) and; (b) Plan earnings or losses thereon. Participants are charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options offered by the Plan.

### Note 1 – Description of Plan, Continued

#### Vesting

Participants are immediately vested in their individual contributions, plus actual earnings or losses thereon. Vesting in the Employer's matching and profit-sharing contribution portion of their account, plus earnings or losses thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service, based on a graded vesting schedule.

A participant becomes 100% vested in the Employer's matching and profit-sharing contributions upon: (1) reaching normal retirement (age 65), (2) death, (3) disability, or (4) Plan termination. Participants who terminate for any other reason are entitled to the vested amount of their accounts.

#### Forfeitures

Forfeited nonvested accounts may be used to reduce future Employer contributions or to offset certain Plan administrative expenses. Forfeitures used to reduce Employer contributions for the years ended October 31, 2024 and 2023, approximated \$57,000 and \$4,000, respectively. As of October 31, 2024 and 2023, available forfeited non vested account balances totaled \$21,197 and \$9,287, respectively.

#### Notes receivable from participants

Plan participants may borrow from their accounts between \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. Loan originations and repayments are treated as transfers between investment funds and the participant's loan fund. Loan terms range from one (1) to five (5) years unless the loan is used to acquire the principal residence of the participant. The Plan Administrator may permit a longer repayment term, which may not be greater than 30 years. Loans are secured by the vested account balance in a participant's account and bear a reasonable rate of interest. A participant may only have two (2) loans outstanding at any given time. Principal and interest are paid through regular payroll deductions and remitted to the Trustee. Delinquent notes receivable from participants are recorded as distributions.

#### Payments of benefits

Upon termination of service for any reason or resulting from death, disability, or retirement, a participant may elect one of the following forms of distribution if the total value of the participant's vested account is greater than \$5,000 (excluding the balance of the participant's rollover contribution subaccount, if any): (a) an amount equal to the value of the participant's vested interest in his or her account in a single lump-sum payment, (b) in the form of a paid-up nontransferable annuity contract for the participant's life expectancy or the joint and survivor life expectancies of the participant and the participant's beneficiary, or (c) roll-over to another qualified plan. If the participant's vested account balance is greater than \$5,000, the participant may also elect to maintain his or her account in the Plan. If the total value of a participant's vested account is \$5,000 or less, the entire vested account balance will be distributed to the participant in a single payment within a reasonable period of time.

#### Plan administration

The Company is the Plan Administrator, and as such, controls and manages the operations of the Plan. Plan management has contracted with ADP to provide recordkeeping and third-party administrative services to the Plan. RTC serves as the Trustee of the Plan. The Trustee invests cash received, interest and dividend income and makes distributions to participants (subject to the direction of participants). Fees from covered service providers of the Plan are in compliance with Department of Labor's (DOL) regulations regarding ERISA Section 408(b)(2).

#### Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan investment assets. Certain administrative expenses are paid by the Employer and are not reflected in these financial statements.

**Note 2 – Summary of Significant Accounting Policies**

Basis of accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and the Plan's Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and such differences could be material.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the high level of risk associated with certain investment securities including uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participants' account balances and the amounts reported in the financial statements.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included as administrative expenses when incurred. Any delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan agreement.

Payment of benefits

The Plan records benefits when paid.

Plan expenses

For all periods presented, the Plan has classified certain Plan expenses as administrative expenses rather than as a reduction of investment income. Substantially all administrative expenses for maintaining the Plan are paid by the Employer and are not reflected in these financial statements. Certain expenses paid by the Plan consist of recordkeeping, trustee, and third party administrator fees. Certain participant directed transactions such as loan processing and withdrawal fees are charged directly to the participant's accounts.

**Note 2 – Summary of Significant Accounting Policies, Continued**

Uncertain tax positions

U.S. GAAP requires Plan management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan Administrator has determined it does not have any positions at October 31, 2024 and 2023, that it would be unable to substantiate.

**Note 3 – Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified that the following data included in the accompanying financial statements and supplemental information is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of October 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended October 31, 2024 and 2023; and
- Investment information included in the Schedule H, line 4i – Schedule of Assets (held at end of year) as of October 31, 2024, as shown on the ERISA-required supplemental information.

At the request of the Plan's Administrator, the Plan’s independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements, including the disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental information is in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 4 – Fair Value Measurements**

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

Level 1	Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.
Level 2	Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.
Level 3	Significant unobservable inputs.

### Note 4 – Fair Value Measurements, Continued

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at October 31, 2024 and 2023. During the years ended October 31, 2024 and 2023, there were no transfers of financial instruments into or out of Level 3.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds* – are valued at the daily closing prices, as reported by the fund. Mutual funds held by the Plan are open-ended funds that are traded on national exchanges. These funds are required to publish their daily net asset value (NAV) and transact at those prices. The mutual funds are deemed to be actively traded.

*Self-directed brokerage account* – is comprised of common stocks and mutual funds. Common stocks are valued at the published market prices on active markets. The mutual funds are valued at the NAV that is quoted on an active market and is determined based on the fair value of the underlying assets at the end of each day.

*Collective investment trust fund* – valued daily at NAV per share (or its equivalent), by the respective collective investment trust's trustee, is used as a practical expedient to estimate fair value. NAV is determined by the respective collective investment trust fund manager based on the fair value of the underlying investments held at the end of the Plan year. This practical expedient is not used when it is determined to be probable that the collective trust will sell its underlying investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily at NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Fidelity Bond**

The Plan has complied with the fidelity bonding requirements of ERISA.

**Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the Employer’s contribution portion of their accounts.

**Note 7 – Tax Status**

The non-standardized pre-approved profit-sharing plan with CODA that the Plan adopted received a favorable opinion letter from the IRS on October 6, 2020, stating that the form of the prototype non-standardized pre-approved profit sharing plan with CODA was designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 8 – Party-In-Interest Transactions**

The Plan’s investments include shares of a collective investment trust fund, a self-directed brokerage account and mutual funds administered by Reliance Trust Company, the Plan’s Trustee. Therefore, transactions in these investments qualify as party-in-interest transactions. ADP is the Plan’s recordkeeper and third-party administrator, and fees charged by ADP for these services qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules under ERISA.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, which were not covered by revenue sharing. The Plan also made direct payments to service providers which were not covered by revenue sharing.
