Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of Southern Wesleyan University DC Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF PLAN:

The following brief description of the Southern Wesleyan University DC Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan document, as amended, for a more complete description of the Plan's provisions.

GENERAL

The Plan, established January 1, 1971, is a defined contribution employee benefit plan providing retirement benefits to eligible employees of Southern Wesleyan University (the University) under section 403(b) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The University's finance committee is responsible for oversight of the Plan. The finance committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the University's board of directors.

PARTICIPATION

Employees may enroll and make elected deferrals into the plan on their hire date excluding students who are enrolled and regularly attending classes offered by the University or part-time employees working less than 20 hours per week. In order to receive employer contributions, the employee must be 21 years of age and must have one year of service. Plan entry dates are the first payroll period following completion of the eligibility requirements.

CONTRIBUTIONS

The Plan is a contributory plan whereby an employee who elects to participate can contribute a percentage of their compensation into the Plan, subject to limitations as defined by the Internal Revenue Code (the Code). Participants direct the investment of their contributions into various investment options offered by the Plan.

Employee contributions are subject to the maximum amount allowed by law (\$23,000 and \$22,500 per participant for 2024 and 2023, respectively). Participants with 15 years of service at a qualified institution or who are age 50 or older before the close of the plan year are eligible to make catch-up contributions, subject to certain Internal Revenue Code limits. Participants may also contribute rollover amounts representing distributions from other defined benefit or defined contribution plans.

The University makes non-elective employer contributions of three percent of the participant's contribution to the Plan, upon completion of one year of service. In addition, the Plan document allows for matching contributions in an amount to be determined each year at the employer's discretion; no matching contributions were made during the years ended December 31, 2024 and 2023.

1. DESCRIPTION OF PLAN, continued:

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution and allocations of (a) the University's contributions, and (b) the Plan earnings and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. All amounts in participant accounts are participant-directed.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their TIAA-CREF accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as transfers between the investment fund and notes receivable from participants. These loans are carried at the loan's unpaid principal balance plus accrued interest and are recorded as notes receivable from participants in the statements of net assets available for benefits. The loans bear interest at a rate of the Prime rate plus 1%. Participant loans from TIAA-CREF accounts as of December 31, 2024 and 2023, totaled \$45,577 and \$33,228, respectively.

VESTING

Participants are immediately vested in all contributions plus actual earnings thereon.

BENEFIT PAYMENTS

The Plan provides that a participant may begin receiving normal retirement benefits upon termination of employment, death or reaching age 59 1/2. Rollover balances may be withdrawn at any time. The Plan allows for hardship withdrawals if proper qualifications are met. Participants may elect a lump sum payment, partial payment, installment payment, or annuity payment of the vested interest in the participant's account. Participants may withdraw from their elective salary deferral contributions upon reaching age 59 1/2, termination of employment, hardship, death or disability. Employer matching or nonelective contributions may be withdrawn upon termination.

2. SIGNIFICANT ACCOUNTING POLICIES:

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Significant accounting policies adopted by the Plan are described below.

USE OF ESTIMATES

The preparation of financial statements in conformity with GAAP requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements and Note 5 for a discussion of fully benefit-responsive investment contracts.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes are reclassified as distributions based upon the terms of the Plan document.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

All expenses of maintaining the Plan are paid by the University. Investment related expenses are included in net appreciation of fair value of investments.

RECLASSIFICATION

Certain balances from the prior year have been reclassified to conform to the current year presentation.

3. INFORMATION PREPARED AND CERTIFIED BY THE QUALIFIED INSTITUTION:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, investments, notes receivable, and related investment income and interest on notes receivable from participants included in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023, and supplemental schedule as of December 31, 2024, have been compiled from statements certified as complete and accurate by Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF), the qualified institution, in accordance with DOL regulations.

4. FAIR VALUE MEASUREMENTS:

The *Fair Value Measurements and Disclosure* topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

VALUATION TECHNIQUES

Variable annuity contracts are valued at the net asset value (NAV) of units held by the Plan at year end based on the fair value of the underlying investments. NAV is a readily determinable fair value which is published daily and is the basis for current transactions. Non benefit-responsive fixed annuity contracts are not actively traded, and significant other observable inputs are not available. Therefore, the fair value of the fixed annuity contracts is determined using an income approach by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer. These contracts have liquidity restrictions and are non-benefit responsive. The fair value of the pooled separate account units is principally derived from the market value of the underlying real estate holdings or other real estate-related investments.

Changes in valuation techniques: There were no changes in valuation techniques during the year.

5. GUARANTEED INVESTMENT CONTRACTS WITH INSURANCE COMPANIES:

The Plan has a fully benefit-responsive guaranteed investment contract with TIAA. TIAA maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$201,095 and \$170,193, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1%-3%, depending on the specific contract. Such interest rates are declared on a monthly basis.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. RISK AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. PLAN TERMINATION:

Although it has not expressed any intent to do so, Southern Wesleyan University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will become fully vested.

8. TAX STATUS:

The Plan has adopted a prototype plan document sponsored by TIAA. The prototype plan document has obtained an opinion letter from the Internal Revenue Service dated August 7, 2017, in which it states that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is operating in compliance with the applicable requirements of the Internal Revenue Code.

9. PARTIES-IN-INTEREST:

All assets of the Plan are invested in funds managed by the TIAA and CREF, the Plan's third party administrator. Such investments involving TIAA and CREF qualify as party-in-interest transactions for the 2024 and 2023 Plan years. Indirect fees of \$116,277 and \$102,051 were incurred by the Plan for the years ended December 31, 2024 and 2023, respectively, for investment management services, and are included in net appreciation in fair value of investments.

10. SUBSEQUENT EVENTS:

Subsequent events have been evaluated through August 6, 2025, which represents the date the financial statements were available to be issued. Subsequent events after that date have not been evaluated.
