**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the Intelligent Management Solutions, Inc. 401K Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan generally covering substantially all employees of Intelligent Management Solutions, Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is designed to comply with Section 404 (C) of the Internal Revenue Code. The Plan is administered by Intelligent Management Solutions, Inc. However, various record-keeping, compliance, and financial reporting requirements are performed through a third-party administrator and John Hancock as of December 31, 2024.

Contributions – Participants may contribute a percent of their annual compensation to the Plan not to exceed the limits allowable by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options. The company offers a safe harbor match, contributing 100 percent of the first 3 percent of employee contributions, and 50 percent of the next 2 percent, up to a total of 5 percent. All contributions are directed by the participant.

Participant Accounts – Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their contributions and employer safe-harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service. The vested benefit for terminated employees was \$2,832,039 and \$4,109,809 for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits – Benefit payments are made in a lump sum payment in cash upon the participant's death, disability, or retirement. For termination of service due to other reasons, a participant may receive the value of their vested interest as a lump-sum distribution. Normal retirement is at age 65. Early retirement can be elected at age 59.5. Prior to termination of employment, participants satisfying certain conditions may be allowed certain in-service distributions subject to certain limitations.

Participant loans – Participants may borrow from their accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 4.25 – 9.50 percent, which is commensurate with local prevailing rates. The Plan restricts participants to one loan outstanding at any time.

Forfeited Accounts - There were \$-0- in forfeited non-vested accounts for the years ended December 31, 2024 and 2023. Forfeited accounts are used first to pay Plan expenses, then to reduce future employer contributions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for plan benefits, the net appreciation in the fair value of its investments which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation on investments held at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when properly executed requests for distribution are received.

Administrative Expenses

The Plan permits the payment of Plan administrative expenses to be made from the Plan assets. These expenses will generally be allocated among the accounts of all participants in the Plan based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan.

Subsequent Events

The Plan has evaluated subsequent events through the date the financial statements were available to be issued. There were no material subsequent events which require disclosure at December 31, 2024.

**NOTE 3      UNAUDITED INFORMATION**

John Hancock Life Insurance Company holds the Plan investment assets and executes transactions therein. Financial information for 2024 and 2023 relating to these assets is included in the accompanying financial statements and is based on information provided by the trustees. The financial information presented below and on pages 3 and 4 and in Note 4 has not been audited by independent auditors.

**NOTE 4      FAIR VALUE MEASUREMENTS – UNAUDITED**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds – Valued using the net asset values provided by John Hancock at year end.

Participant Loans – Valued at amortized cost, which approximates fair value.

The Plan received an advisory opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The income tax returns of the Plan are subject to examination by taxing authorities, generally for three years after they were filed.

**NOTE 6 PLAN AMENDMENTS AND TERMINATIONS**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in all employer contributions.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit.
