To the Trustees and Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Hallam Associates, Inc. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due, or which may become due, to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audits section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal-control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and are not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from, and relates directly to, the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to, or derived from, the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to, or is derived from, the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to, or derived from, the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan

The following brief description of the Hallam Associates, Inc. Profit Sharing and Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General: The Plan is a defined contribution plan, covering all full-time employees of Hallam Associates, Inc. (the Company) who have completed at least six consecutive months and 500 hours of service, as defined by the Plan, except union and nonresident alien employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may contribute up to 100% of their compensation, as defined by the Plan. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain limitations under the Internal Revenue Code (IRC). Participants may also contribute amounts representing rollover distributions from other qualified plans.

The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their initial deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The deferral rate is automatically increased by 1% each January 1 up to a maximum of 20%.

The Company may make discretionary matching contributions, as determined by the Company. For 2024, the Company matched 100% of each participant's deferral contributions up to 3% of the participant's eligible compensation, for a maximum match of 3% of eligible compensation.

The Company may elect to contribute a discretionary profit sharing contribution. Employees must be employed on the last day of the Plan year to be eligible for profit sharing contributions. The Company did not make a profit sharing contribution for 2024.

Contributions and eligible compensation are subject to certain limitations.

Participant accounts: Each participant's account includes the participant's contributions, the Company's matching contribution, and allocations of the Company's profit sharing contribution and Plan expenses and earnings. Allocations of Plan expenses and earnings are based on a participant's account balance relative to the total account balances of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 20% vested after two years of service, increasing 20% in the third and fourth years, with 100% vesting after five years of credited service. Participants also become 100% vested when they reach the normal retirement age (65), the early retirement age (55) with five years of service, disability or death while under the employment of the Company.

Note 1. Description of Plan (continued)

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are permitted one outstanding loan. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate. Interest rates range from 4.25% to 9.50% as of December 31, 2024. All loans must be repaid within five years or within 15 years for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

Payment of benefits: Benefits are distributed to participants upon the termination of employment by reason of retirement, disability, death or other separation from service. Distributions under the Plan may be made in lump sums or partial withdrawals. A participant may also request a withdrawal upon reaching age 59½ or upon demonstration by the participant to the Plan Administrator that the participant is suffering from hardship, as defined in the Plan document. The Plan also allows for in-plan Roth rollover contributions. Participants may withdraw from their rollover account at any time.

Forfeitures: As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,968 and \$6,473, respectively. These amounts can be used to reduce employer contributions or pay Plan expenses or reallocated to active participants. During 2024, forfeitures of \$9,962 were used to reduce employer contributions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) using the accrual basis of accounting.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and the related matching contributions from the employer are recorded in the year the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Expenses of the Plan: Substantially all expenses of maintaining the Plan are paid by the Company. Certain administrative fees are paid by the Plan. Certain transaction fees are paid by Plan participants.

Note 2. Summary of Significant Accounting Policies (continued)

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events: Plan management has evaluated subsequent events through August 5, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Ascensus, LLC, as an Authorized Representative of Ascensus Trust Company

The following is a summary of the Plan's information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to, or derived from, information certified as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company, a qualified institution:

- All investments and notes receivable from participants;
- All investment income and interest income on notes receivable from participants;
- Information regarding investments in Note 4; and
- Information included on Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year).

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Note 4. Fair Value Measurements (continued)

Level 2: Observable market-based inputs or observable inputs that are corroborated by market data.

Level 3: Unobservable inputs for assets or liabilities that are not corroborated by market data.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used in the current or prior year.

Mutual funds: Valued at the daily closing price as reported by each fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and, therefore, are considered Level 1 investments.

Common collective trust: The common collective trust consists of a stable value fund that is primarily composed of fully benefit-responsive investment contracts and valued at the NAV of units of the common collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The common collective trust provides for daily redemptions by the Plan at the reported NAV per share, with no advance notification requirement.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all of their accounts.

Note 6. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS), stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document; however, the Plan Administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party Transactions

ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the qualified institution or an affiliate are considered party-in-interest transactions. Additionally, the Company pays certain administrative fees for the Plan, as described in Note 2.
