## Independent Auditor's Report

To the Participants and Plan Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of Glenn Thurman, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

#### **Note 1 – Plan Description**

The following description of the Glenn Thurman, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

#### ***General***

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of Glenn Thurman, Inc. and its wholly owned subsidiaries, Thurman Transportation, Inc., and GTI Energy Services, LLC (collectively, the “Company” or “Employer”). The Plan commenced effective May 1, 1986, and was amended and restated effective January 1, 2022, to comply with the latest rules and regulations. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

#### ***Plan Custodians and Trustees***

Empower Trust Company, LLC (“Empower”) and Empower Annuity Insurance Company of America (collectively, the “Custodians”) are the Custodians maintaining custody of all investments held by the Plan. Empower Retirement, LLC (the “Recordkeeper”) maintains the Plan’s participant account balances and provides recordkeeping services to the Plan. Among other duties, the Recordkeeper receives contributions, holds and invests the fund assets in accordance with the direction of participants, and makes distributions as directed by the Plan Administrator. Certain officers of the Company serve as trustees of the Plan.

#### ***Eligibility and Plan Entrance Date***

All employees, except union employees or non-resident aliens, who have completed one year of service, with more than 1,000 hours during a twelve-month period, are eligible to participate in the Plan. Eligible employees are permitted to enter the Plan during the semi-annually entry dates starting on January 1<sup>st</sup> or the same day of the month occurring in each successive 6-month period, coincident with or next following the date the participant satisfies the eligibility requirements.

#### ***Participant Contributions***

Participants may elect to contribute, on a pre-tax basis up to the maximum amount allowed annually by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the maximum amount allowed annually by the IRC, which was \$7,500 for 2024.

#### ***Employer Contributions***

The Plan provides for Safe Harbor Employer matching contribution equal to 100% of the first 3% and 50% of the next 2% of each participant’s eligible compensation contributed to the Plan as employee contributions. In addition, the Company may, at the discretion of the Company’s board of directors, make discretionary non-elective contributions. The Company made no non-elective contributions for the year ended December 31, 2024.

#### Note 1 – Plan Description (continued)

##### ***Vesting***

Participants are vested immediately in their own contributions and Safe Harbor Employer matching contributions plus actual earnings thereon. Vesting in Employer matching, discretionary non-elective contributions and actual earnings thereon, made prior to January 1, 2025, are based on years of service with a participant becoming 20% vested after two years of credited service, and increasing at a rate of 20% per year until reaching full vesting after six years of credited service.

##### ***Participant Accounts***

Each participant account is credited with the participant's contributions, the Company's Safe Harbor Employer matching contributions, plus allocations of Plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Participant-Directed Investments***

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The funds vary in type of investment, rates of return, and investment risk.

##### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have one outstanding loan at a time. The loans must be repaid over a period of no longer than five years. The loans are secured by the balance in the participant's account. The loan interest rate, determined on the first business day of the month the loan is originated, is set at 1% above Prime, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

##### ***Payment of Benefits***

Upon separation of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump sum payment from the vested portion of their account balance. Vested account balances of a terminated employee, with a balance less than or equal to \$5,000, are immediately distributable in a lump sum payment under the terms of the Plan, without the participant's consent. Account balances exceeding \$1,000 but less than or equal to \$5,000 may be distributed to an individual retirement account for the benefit of the participant designated by the Plan Administrator. Account balances less than or equal to \$1,000 may be distributed as a lump sum distribution.

A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59 ½ or from a participant's rollover account.

##### ***Forfeited Accounts***

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$767 and \$757, respectively. These forfeited nonvested accounts may be used to reduce future Employer contributions as permitted under the provisions of the Plan. No forfeitures were used in 2024.

#### **Note 2 – Summary of Significant Accounting Policies**

##### ***Basis of Accounting***

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with the accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### ***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### ***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, Custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

##### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

##### ***Payments of Benefits***

Benefit payments to participants are recorded when paid.

##### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment-related expenses are included in the net appreciation of fair value of investments. Certain expenses incurred by, or attributable to, a specific participant will be paid from that participant's account. Plan expenses could include, but are not limited to, costs to process Plan distributions.

#### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

- **Pooled Separate Accounts** – Valued using the net asset value (“NAV”) of units held by the Plan at year-end as provided by the Custodians. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

#### Note 4 – Information Prepared and Certified by the Plan’s Custodians

As permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA, Empower Trust Company, LLC and Empower Annuity Insurance Company of America have certified to the Plan’s Administrator that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

The Plan’s independent auditor did not perform auditing procedures with respect to this information, except for comparing such information with the related information included in the financial statements and supplemental schedule.

#### Note 5 – Guaranteed Investment Contract with Insurance Company

The Plan has a guaranteed investment contract with Empower Annuity Insurance Company of America (the “Issuer”) in the form of a group annuity contract that invests contributions in the Key Guaranteed Portfolio Fund (the “Fixed Account”). Interest earned on the Fixed Account value is compounded daily to the effective annual interest rate. The interest rate to be credited to the Plan will be determined by the Issuer prior to the last day of the previous calendar quarter. The contract meets the fully benefit-responsive investment contract criteria and is therefore reported at contract value. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

This guaranteed investment contract is a traditional investment contract. The Issuer is contractually obligated to repay the principal and interest at a specified interest rate guaranteed to the Plan. The crediting rate is based on a formula established by the Issuer, but may not be less than 0%, and the rate is reviewed for resetting on a quarterly basis. The contract cannot be terminated before the scheduled maturity date.

#### **Note 5 – Guaranteed Investment Contract with Insurance Company (continued)**

Certain events limit the ability of the Plan to transact at contract value with the Issuer. Such events include the following: (i) amendments to the Plan Document (including complete or partial Plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

#### **Note 6 – Related Party and Party-in-Interest Transactions**

Certain Plan investments consist of pooled separate accounts and a fixed annuity contract managed by the Custodians. These transactions qualify as party-in-interest transactions as defined by ERISA but are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivable from participants at December 31, 2024. These receivables and all transactions relating to these receivables qualify as party-in-interest transactions that are exempt from the prohibition of party-in-interest transactions under ERISA.

#### **Note 7 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

#### **Note 8 – Tax Status**

The Plan operates under a non-standardized, preapproved profit-sharing plan sponsored by RetirementPlans.com ("Retirement Plans"). The Internal Revenue Service ("IRS") has determined and informed Retirement Plans, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS regarding the Plan's qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
