Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Lee Company Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Lee Company Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

NOTE 1 - DESCRIPTION OF PLAN

The following description of The Lee Company Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established in 1953 and provides retirement, death, and disability benefits to eligible employees of The Lee Company and its subsidiary, Canyon Engineering Products (collectively, the Company). Employees who have completed six months of service with the Company and who work at least 1,000 hours per year are eligible to participate in the Plan.

Effective June 26, 2013, Canyon Engineering Products (Canyon) was sold to an unrelated third party. As a result, the Plan was amended to eliminate future benefit allocations to all Canyon participants as of that date. Immediately prior to the closing of the sale transaction, the Company made a discretionary contribution of \$200,000 to the Plan, which was allocated to the Canyon participants in accordance with the terms of the Plan.

Contributions

The Company's annual contribution to the Plan is determined in accordance with the terms of the Plan and is generally the lesser of an amount based on a percentage of the Company's annual net profit, as defined, or on the annual gross compensation paid to participants during the year. At the Company's discretion, additional contributions may be made up to the limits established by the Internal Revenue Code (the Code). Employee contributions are generally not accepted by the Plan. An exception exists for pre-tax rollover funds from an employee's participation in a qualified pension or profit-sharing plan sponsored by another employer.

Participant Accounts

Each participant's account is credited with a proportionate share of the Company's total contribution for the plan year and any forfeitures from the nonvested accounts of former participants, as allocated on a pro rata basis, based upon annual compensation. Earnings and losses on plan investments, and expenses, are allocated daily to each participant's account based on the participant's respective account balance.

Vesting

Vesting in the employer contribution portion of a participant's account, plus actual earnings thereon, is based on continuous service. A participant is 20% vested after two years of service; 60% vested after three years of service; 70% vested after four years of service; 80% vested after five years of service; and 100% vested after six years of service. Participants, or their beneficiaries, become 100% vested in employer contributions, and actual earnings thereon, if the termination of their service is caused by disability or death, or if they terminate employment after reaching age 65. Participants are at all times 100% vested in their rollover contributions and actual earnings thereon.

In connection with the sale of Canyon, all participants employed by Canyon became fully vested in their account balances as of June 26, 2013.

Forfeitures

If a participant terminates employment with the Company at a time when the participant does not have a fully vested interest, the employer contribution and actual earnings thereon are forfeited to the extent of the nonvested percentage interest. Terminated participants who become reemployed by the Company within five years of their termination date are entitled to have all forfeited amounts reinstated. Forfeitures are retained for a total of five years in a suspense account of the Plan and are subsequently allocated to other participant accounts using the same allocation as the Company's contribution. Amounts totaling \$124,430 and \$73,070 were forfeited during the 2024 and 2023 plan years, respectively. Previously forfeited amounts totaling \$177,217 and \$163,233 were allocated to other participants' accounts during the 2024 and 2023 plan years, respectively. Unallocated forfeitures were \$479,018 and \$522,089 at October 31, 2024 and 2023, respectively.

Benefit Provisions

Participants are eligible to receive benefits under the Plan upon termination of employment or upon attaining age 65, if still employed. Benefits are payable at the participant's option in a lump-sum, installment or annuity payment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants terminated due to death or disability prior to retirement are entitled to payment immediately.

Investment Options

Participants may direct employer and rollover contributions in 1% increments into any of the investment options offered to participants by the Plan. The Plan offers mutual funds, collective trust funds, and a cash equivalent fund as investment options. The cash equivalent fund is a stable value fund administered by Voya Retirement Insurance and Annuity Company (Voya). Participants can transfer their account balances between the fund options in increments of 1% at any time.

Administration

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal), a member of Principal Financial Group, serves as the Plan's recordkeeper, trustee and custodian. Additionally, Voya Retirement Insurance and Annuity Company (Voya) serves as the custodian of the Plan's investment in the stable value fund.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments consists of the realized gains and losses and the unrealized appreciation (depreciation) on those investments held at October 31, 2024 and 2023, respectively.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the dates of the financial statements and the changes in net assets available for plan benefits during the reporting periods and, when applicable, disclosures of contingent assets and liabilities at the dates of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options in any combination of mutual funds, collective trust funds, and a stable value fund. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Administrative Expenses

Certain investment management fees are included as a reduction of the Plan's earnings. Other administrative expenses associated with the Plan, including but not limited to recordkeeping, legal, accounting, trustee, and investment advisory fees, are paid by the Company.

Payment of Benefits

Benefit payments to participants or beneficiaries are recorded upon distribution.

Subsequent Events

Subsequent events were evaluated through August 12, 2025, the date the financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value (NAV) practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds

Mutual funds are valued at the quoted price of shares held by the Plan at year-end.

Collective Trust Funds

Collective trust funds are valued at the NAV of units of bank collective trust funds. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust funds, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The Plan did not have any unfunded commitments to these funds at October 31, 2024 and 2023.

Stable Value Fund

The Company has entered into a contract with Voya, the assets of which are maintained in a separate account called the Voya Intermediate Stable Value Fund. The Stable Value Fund is a pooled intermediate duration public bond separate account, the investments of which consist primarily of a diversified portfolio of United States Treasury and agency securities, mortgage pass-through and other asset-backed securities and other publicly traded investment-grade debt securities. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value and approximates the liquidation value of the fund, should the contract be terminated. The liquidation value, as defined by the contract, is the higher of the fund's book value or fair value, as reported by Voya. At October 31, 2024 and 2023, the book value of the fund exceeded its fair value.

The rate of interest credited to participant accounts is reset for the ensuing six-month period on January 1 and July 1 each year. At October 31, 2024 and 2023, the crediting rates were 2.18% and 2.55%, respectively.

There have been no changes in the methodologies used at October 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no transfers between levels of investments during the years ended October 31, 2024 and 2023.

Investments in the stable value fund and collective trust funds provide for daily liquidity and have no redemption features or other restrictions.

NOTE 5 - PLAN TERMINATION PROVISIONS

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts using the same allocation method historically applied to forfeitures.

NOTE 6 - INCOME TAX STATUS

The Internal Revenue Service has determined and advised the Company by a letter dated January 8, 2018 that the Plan is designed in accordance with the applicable sections of the Code. The Plan has been amended since receiving the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal or state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any open tax periods. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE 7 - INACTIVE ACCOUNTS

Participant balances eligible for distributions but remaining in the Plan as of October 31, 2024 and 2023 were \$96,557,775 and \$83,054,460, respectively. These amounts represent deferred benefits due to employees who have terminated their employment with the Company but elected to keep their funds in the Plan.

NOTE 8 - RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Principal and Voya and therefore, these transactions qualify as party-in-interest transactions. Certain investment management fees are also charged to the Plan by Principal and Voya. These amounts are charged directly against the investment income (loss) reported by each investment.

Certain employees of the Company who participate in the Plan provide administrative services to the Plan at no cost to the Plan. The Company, as plan sponsor, also paid certain administrative fees on behalf of the Plan during 2024 and 2023.
