NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 and 2023

**Note A – Description of the Plan**

The following description of the Cornerstone Research 401(k) and Profit Sharing Plan (the Plan) provides only general information. Interested persons should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 1990. The Plan is a participant-directed defined contribution plan established by Cornerstone Research (“the Company”) under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company are eligible to participate as soon as administratively possible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan has been amended since inception to comply with tax law changes and make other changes to the Plan’s design.

Plan Administration

The Company has delegated certain responsibilities for the operation and administration of the Plan to Charles Schwab, as the Plan Trustee. In addition, certain administrative and recordkeeping services were provided by Charles Schwab.

Participation

Employees, other than temporary employees, are eligible to participate the day they are hired. If an eligible employee has not completed a Salary Deferral Agreement within 45 days after their hire date, the Company will automatically enroll the employee in the Plan.

Employee Deferrals and Company Matching Contributions

Employees are automatically enrolled in the Plan after 45 days of employment at a 6% deferral rate. Eligible participants may elect to contribute up to 75%, but not to exceed statutory limits, of their compensation to the plan through payroll deductions. Eligible employee contributions are fully vested when contributed.

The Company matches 50% of employee contributions to the 401(k) portion of the Plan up to the first 6% of compensation, with a maximum Company match of 3% of compensation, subject to IRS limits. The Plan defines eligible compensation as all compensation paid to employees except for bonuses, taxable moving expense reimbursements, taxable group term life insurance benefits, and any compensation received prior to becoming a participant in the Plan. A participant’s nonforfeitable percentage of his matching contributions account equals the percentage in the following vesting schedule:

Participants direct the allocation of their contributions entirely or in percentages to any of the funds. Employee salary deferrals and the Company matching contribution are deposited directly into the appropriate fund by the Company in accordance with the participants' directives and the terms of the Plan.

The employee deferral and Company matching contributions to the Plan are intended to qualify under Sections 401 and related provisions of the Internal Revenue Code.

Profit Sharing Contributions

The Plan provides assistance toward meeting an eligible employee's retirement needs by allowing the Company to make discretionary profit contributions of up to a maximum of 5.7% of eligible compensation and an additional 5.7% of eligible compensation in excess of the social security taxable wage base, subject to IRS limits. The Plan defines eligible compensation as all compensation paid to employees except for bonuses, taxable moving expense reimbursements, taxable group term life insurance benefits, and any compensation received prior to becoming a participant in the Plan. For the years ending December 31, 2024 and 2023, the Company elected to make a profit sharing contribution of 5% of eligible compensation and an additional 5% of eligible compensation in excess of the social security taxable wage base, subject to IRS limits. The Company made profit sharing contributions in the amount of \$7,295,886 and \$6,421,883 for the plan years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, Plan earnings or losses, and rollovers from other qualified plans. Plan earnings and losses are allocated based upon each participant's account balance. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

Payment of Benefits

Upon a participant's termination of employment, death, or disability, the participant (or the participant's beneficiary in the event of death) may elect to receive a lump sum distribution equal to the value of his or her account, equal installment payments over a specified period of time, or direct trustee to trustee rollovers. If the participant's account balance is less than \$1,000, a lump sum distribution will be made without regard to the consent of the participant or the participant's spouse. All distributions elected by terminated participants during the Plan year have been paid by the Plan at December 31, 2024 and 2023.

Hardship Withdrawals

Participants may withdraw their vested contributions in the event of hardship as defined in the Plan agreement.

Notes Receivable from Participants

Participants may borrow against their vested balances for any reason. The loan provisions are structured to allow access to vested balances without incurring distribution penalties. The loan amount, length of loan repayment terms and interest rates are limited by statutory restrictions incorporated in the Internal Revenue Code and related regulations.

The Plan allows participants to borrow not less than \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested balance. Such loans bear interest at the available market financing rates and must be repaid to the Plan within a five year period, unless the loan is used for the purchase of a principal residence in which case the maximum repayment period may be repaid over 15 years. The specific terms and conditions of such loans are established by the Plan administrator. Outstanding loans at December 31, 2024, carry interest at rates of 4.25% to 9.50%.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$281,420 and \$252,131, respectively. These accounts will be used to reduce employer contributions and pay administrative expenses of the Plan. During the year ended December 31, 2024 employer contributions were reduced by \$252,836 from forfeited non-vested accounts.

**Note B – Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted (“GAAP”) in the United States of America. Contributions from participants are recorded when withheld from the participant. Benefit payments to participants are recorded when paid.

Investment Valuation and Income Recognition

The Plan's registered investment companies (mutual funds) and common collective trust investments are stated at fair value. The shares of mutual funds are valued at quoted market prices, which represent the net asset values of shares held by the Plan at year-end. Common collective trusts are valued at fair value using the following valuation approaches: market approach, income approach, and cost approach. Stable value funds are reported at contract value, see Note D. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Fair Value Measurements

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures*. Refer to Note E for the fair value measurement disclosures associated with the Plan's investments.

Net Appreciation in Fair Value of Investments

The earnings, expenses, realized gains and losses, and unrealized appreciation (depreciation) in registered investments companies and other investments are recorded in the accompanying financial statements as net appreciation/(depreciation) in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Note C – Information Certified by the Plan’s Trustee and Custodian**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by the trustee, except for comparing such information certified by the trustee to information included in the Plan’s financial statements and supplemental schedule of assets held for investment purposes.

**Note D – Investment Contract with Insurance Company**

In 2006, the Plan entered into a benefit-responsive investment contract with New York Life Insurance Company (NYL). NYL maintains the contributions in an Anchor Account. The “Anchor Account” is the marketing name for New York Life’s Pooled Separate Account No. 25, which consists of the Stable Value Account and the Pooled Separate Account. The Plan’s investments are only in the Stable Value Account. The Stable Value Account represents the guarantee that NYL is making to the plan sponsors participating in the group annuity contract. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Contract value is the relevant measurement attributable for that portion of the net assets available for benefits of a defined contribution plan attributable to fully-benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The contract provides that withdrawals for benefit payments as permitted by the Plan are at contract value. Transfers to other funds are also made at contract value. At contract termination, a participating plan may receive a book value distribution of the Plan’s interest in the Stable Value Account, provided the Plan sponsor provides twelve-months’ advance notice to NYL. Certain distributions (e.g., distributions resulting from employer-initiated events such as plan termination, group lay-offs, early retirement incentives, etc.) may be subject to a market value adjustment. An event that limits the Plan’s ability to transact at contract

value with participants in the Plan must be probable of not occurring for the contract to be considered benefit-responsive. The Plan sponsor is responsible for making this determination. Transfers to a competing fund are subject to a 90-day equity wash; however, short-term administrative restrictions such as an equity wash do not necessarily affect a contract's categorization as benefit-responsive.

**Note E – Fair Value Measurements**

Financial Accounting Standards Board (FASB) *Accounting Standards Certification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Common stocks, corporate bonds and U.S. government securities:* Valued at the closing price reported on the active market on which the individual securities are traded.

*Mutual funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year end. It is not probable that the mutual funds will be sold at amounts that differ materially from the NAV of shares held.

Guaranteed Investment Contract

*Index funds – Common/collective trust:* Valued at fair value as determined by the common/collective trust trustee. The fair valuation approaches that may be utilized to determine fair value include market approach, income approach, and the cost approach. The valuation techniques used under these approaches take into consideration factors that include but are not limited to (i) attributes specific to the investment; (ii) the principal market for the investment; (iii) the customary participants in the principal market for the investment; (iv) data assumptions by market participants for the investment, if reasonably available; (v) quoted prices for similar investments in active markets; and (vi) other factors, such as future cash flows, interest rates, yield curves, volatilities, prepayment speeds, loss severities, credit risks and default rates.

*Stable value funds:* Composed primarily of fully benefit-responsive investment contracts and is reported at contract value. The determination of a stable value fund's relevant measurement is net assets which include the fully benefit-responsive investment contracts held by the fund at contract value, see Note D.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note F – Income Tax Status**

The Plan obtained its latest determination letter on September 21, 2020, in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the Internal Revenue code.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**Note G – Related-Party Transactions and Party-in-Interest Transactions**

Certain Plan investments in mutual funds are managed by Charles Schwab, the custodian and third party administrator of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

Substantially all of the legal, accounting and administrative expenses of the Plan are paid by the Company.

**Note H – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and participant accounts will be distributed in accordance with the Plan document and ERISA.

**Note I – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note J – Subsequent Events**

The Plan has evaluated subsequent events through July 22, 2025, which is the date the financial statements were available to be issued.
