NOTE 1 **DESCRIPTION OF PLAN**

The following description of the Gursey Schneider LLP Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document or the Summary Plan Description for a more complete description of the Plan's provisions.

GENERAL

The Plan is a defined contribution plan that covers all eligible employees of Gursey Schneider LLP (Firm) who are at least 20.5 years old and who complete six months and 500 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS

Participants currently are not permitted to make wage-deferral contributions to the Plan. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Firm may make a discretionary profit-sharing contribution to the Plan as determined by the Firm. Participants must be actively employed on the last day of the Plan year to share in these contributions.

PARTICIPANT ACCOUNTS

Each participant's account is credited with any discretionary profit-sharing contributions and an allocation of Plan earnings and charged with an allocation of investment and administrative expenses. Allocations are based on participants' eligible compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

INVESTMENT OPTIONS

Participants may direct their funds into various investment options offered by the Plan.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested balance. Loan terms require amortization of principal and interest over a period not to exceed five years. Loans used to acquire a principal residence may extend beyond a five-year term. Loans are repaid through payroll deductions and may be repaid in full at any time.

PAYMENT OF BENEFITS

Benefits are payable as soon as practicable following normal retirement, permanent disability, death, or termination of employment, subject to the specific benefit payment provisions in the Plan Document. All account balances not exceeding \$1,000 may be immediately distributed in a lump-sum payment.

VESTING

A participant's interest in the Firm's profit-sharing contributions becomes fully vested and nonforfeitable upon six years of service, retirement, disability, or death, as defined by the Plan.

FORFEITURES

The non-vested portion of a terminated participant's account will be forfeited and used to pay Plan expenses or aggregated with and allocated in the same manner as Firm contributions. During the year ended December 31, 2024, Firm contributions were reduced by \$103,783 from forfeited non-vested accounts.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

ACCOUNTING STANDARDS CODIFICATION

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities. Actual results could differ from those estimates.

PLAN FEES AND ADMINISTRATIVE EXPENSES

Plan fees and administrative expenses are generally paid by the Plan unless paid by the Firm.

VALUATION OF INVESTMENTS

Investments are reported at fair value. See Note 4 for a discussion of fair value measurements.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

RISK AND UNCERTAINTIES

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

SUBSEQUENT EVENTS

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through August 5, 2025, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE

The Plan's investments were held by the Trustee, Reliance Trust Company, at December 31, 2024 and 2023. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Trustee. The information was not audited by the Plan's independent auditor.

NOTE 4 FAIR VALUE MEASUREMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

(See Independent Auditors' Report)

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Common and Collective Trusts: Valued using NAV per unit. NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 **TAX STATUS**

The Plan obtained its latest determination letter from the Internal Revenue Service on October 6, 2020, wherein the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan’s financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded there were no uncertain tax positions as of December 31, 2024.

NOTE 6 **PLAN TERMINATION**

Although the Firm has not expressed any intent to do so, the Firm has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the value of the interests of all participants and beneficiaries shall be determined and distributed to them in a lump sum.

NOTE 7 **RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid approximately \$70,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
