**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of Bachman's 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

#### **NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Bachman's 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### ***General***

The Plan was established on September 1, 1979 by Bachman's Inc. (the "Company", "Plan Sponsor" or "Plan Administrator") to provide retirement benefits for eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was amended in its entirety effective May 1, 2022. The Plan adopted the Empower Trust Company, LLC (formerly known as Great -West Trust Company, LLC) Defined Contribution Pre-Approved Plan. Effective January 1, 2023, the Plan was amended to remove the rule of parity from the plan documents. The Trustee of the Plan is Empower Trust Company, LLC ("Empower" or "Custodian"). Empower holds, invests, and distributes the assets of the Plan to the participants.

##### ***Eligibility***

Employees of the Company who have completed 30 consecutive days of employment, excluding variable pay employees and members of a collective bargaining unit, can become participants of the Plan upon the first day of the month after reaching age 20. Variable pay employees are eligible to participate in the Plan if they are credited with 500 hours of service during any year and meet the Plan's other eligibility requirements. In addition, employees who meet the above requirements and complete 1,000 hours of service in the year are eligible for a discretionary match and profit sharing contribution in the following Plan year.

##### ***Contributions***

Participants may contribute up to 100% of their eligible compensation on a pre-tax basis to the 401(k) portion of the Plan, as defined by the Plan. Participants may change their contribution percentage at any time. The Plan has an automatic enrollment arrangement in that the participant enters the plan at a 3% deferral with 1% increases per year, not to exceed 10% if the participant does not elect otherwise or opt out of deferring in the Plan.

The Company may make a discretionary match contribution to the Plan based on a percentage of the participant's salary deferral or a uniform dollar amount. During the years ended 2024 and 2023, the Company made a contribution equal to 25% of the first 4% of salary deferral for each participant, plus 50% on any additional 2% of the participant's Plan compensation. The Company may designate certain matching contributions as a qualified matching contribution.

The Company may make discretionary and/or qualified nonelective contributions to the Plan. These contributions, if made, are allocated to eligible participants based on either a uniform percentage of Plan compensation or as a uniform dollar amount. In addition, qualified nonelective contributions are allocated to all non-highly compensated participants (as determined under the Plan). There were no discretionary or qualified nonelective contributions for the years ended December 31, 2024 and 2023.

Participants may roll over amounts representing distributions from other qualified plans into the Plan. The Plan also allows for catch-up contributions.

Contributions are subject to a compensation ceiling and annual limitations prescribed by the Internal Revenue Code ("IRC").

#### ***Investment Funds***

Assets of the Plan are held in various funds as determined by the Company. Participants may direct and redirect the balances of their accounts into any of the Plan's investment options. Participants may change their investment allocation daily.

Net investment gains and losses are allocated based on participant balances in each fund.

#### ***Vesting***

Participants are immediately fully vested in their elective deferral contributions, qualified matching contributions, Company qualified nonelective contributions, and any rollover to the Plan plus earnings thereon. Participants vest 20% each year in their respective portion of the Company's discretionary contributions until fully vested after the fifth year of qualified service. Participants become fully vested upon death, disability, or attainment of age 65.

#### ***Notes Receivable from Participants***

Participants are permitted to borrow up to 50% of their vested account balance with a minimum of \$1,000 up to a maximum loan amount of \$50,000. The notes are secured by the participant's vested account balance. The terms require, at minimum, quarterly principal and interest payments. Notes generally have a term of not more than five years, unless the note is for the purchase of a principal residence, in which case the note repayment period may not extend beyond 10 years. The interest rate is fixed at inception of the note at 1.0% over the prime lending rate. Upon termination of employment, the outstanding balance of a note becomes immediately payable. At December 31, 2024, notes receivable have an interest rate of 4.25% to 9.5% with maturity dates through 2029. At December 31, 2023, notes receivable have an interest rate of 4.25% to 9% with maturity dates through 2028.

#### ***Forfeitures***

Forfeitures occur when a participant terminates employment prior to becoming fully vested. Forfeited amounts are allocated annually among the remaining participants based upon eligible compensation. Prior to applying forfeitures to participants, forfeitures will be used to pay Plan expenses. For the years ended December 31, 2024 and 2023, forfeited amounts utilized to pay plan expenses totaled approximately \$21,820 and \$17,265, respectively.

#### ***Plan Termination***

Although it has not expressed any intention to do so, the Company has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement or other termination, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in his or her account or annual installments or annuity payments over a period not to exceed the participant's lifetime or the joint lifetime of the participant and spouse. In addition, participants may elect in-service withdrawals after reaching age 59½ or for hardship purposes, as defined in the Plan documents. If the participant's vested benefit is \$7,000 or less, the participant will receive an involuntary lump sum distribution, unless the participant timely elects a direct rollover of the vested account balance.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting***

The Plan's financial statements are prepared under the accrual method of accounting.

***Use of Estimates***

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in assets available for benefits during the reporting period, and the changes therein, and when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. The most significant estimate is the valuation of the investment contract with the insurance company at contract value and the fair value of other investments. Actual results could differ from those estimates; the effects of any changes could be material.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for those that are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Net Appreciation (Depreciation) in Fair Value of Investments***

Net appreciation (depreciation) in fair value of investments represents the net realized gains (losses) and net unrealized appreciation (depreciation) of investments. Realized gains are the difference between the proceeds received and either the cost of investment sold, determined on an average-cost basis, or the fair value at the end of the previous year, whichever is applicable. Unrealized appreciation (depreciation) is the change in difference between fair value and the cost of the investment or the fair value at the end of the previous year, whichever is applicable.

***Risks and Uncertainties***

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associate with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

***Benefits***

Benefits are recorded when paid.

#### **Administrative Expenses**

Substantially all administrative expenses are paid by the Plan, except for the administrative costs of obtaining participant loans and distribution payments which are paid by the participant obtaining the loan or distribution.

#### **NOTE C - FAIR VALUE MEASUREMENTS**

Under Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, there exists a formal hierarchy and framework for measuring fair value and making disclosures about fair value measurements and the reliability of valuation inputs. Measurement assumes the transaction to sell an asset or transfer a liability occurs in the principal or at least the most advantageous market for that asset or liability. Within the hierarchy, Level 1 instruments use observable market prices for the identical item in active markets and have the most reliable valuations. Level 2 instruments are valued through broker/dealer quotation or through market-observable inputs for similar items in active markets, including forward and spot prices, interest rates and volatilities. Level 3 instruments are valued using inputs not observable in an active market, such as entity-developed future cash flow estimates, and are considered the least reliable.

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual funds* - Valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.

*Pooled separate account* - is valued using the NAV provided by the fund trustee based on the value of the underlying assets owned by the trust, minus its liabilities, and then divided by the number of shares outstanding. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The fund allows for daily liquidity with no additional days' notice required for redemption for participant-directed transactions. If the Plan were to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust for up to 12 months in order to

ensure that securities liquidations will be carried out in an orderly manner. There were no unfunded commitments as of December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - GUARANTEED FUND**

The Plan has a fully benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract is included in the financial statements at contract value as reported to the Plan by Empower. Contract value represents contributions made under contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There is no reserve against contract value for credit risk of the contract issuer or otherwise.

The investment return is dependent on, among other factors, the underlying financial viability of the issuer of the contracts (Empower) but may not be lower than 3.0%. Such interest is evaluated every six months. The rate for the guaranteed fund was 3% at both December 31, 2024 and 2023. The average yield earned, and interest credited to participants was 3% for both the years ended December 31, 2024 and 2023.

The Plan's ability to execute transactions at contract value is limited in certain circumstances as detailed in the group annuity contract. These circumstances include the following: (1) Plan termination or partial

termination; (2) Participant's separation from employment resulting from a reorganization, merger, or layoff; (3) The Internal Revenue Service determines the Plan no longer meets requirements of applicable code sections; (4) The Plan breaches the group annuity contract. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

#### **NOTE E - INFORMATION CERTIFIED BY THE TRUSTEE OR CUSTODIAN**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee or Custodian, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and
- Schedule H, line 4i - schedules of assets (held at end of year) as of December 31, 2024.

#### **NOTE F - RELATED-PARTY TRANSACTIONS**

Pooled separate accounts and the guaranteed fund of the Plan are managed by Empower. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Notes receivable from participants also qualify as party-in-interest transactions. However, the ERISA regulations provide an exemption for such transactions.

#### **NOTE G - TAX STATUS**

The Plan previously obtained the opinion letter for the Massachusetts Mutual Life Insurance Company Defined Contribution Volume Submitter Plan dated March 31, 2014. In 2022, the plan adopted the Empower Trust Company, LLC Defined Contribution Pre-Approved Plan and obtained its latest opinion letter dated November 14, 2022, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan Administrator believes that the Plan is currently designed and being operated in all material respects in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
