INDEPENDENT AUDITORS' REPORT

TO THE PLAN ADMINISTRATOR AND PARTICIPANTS OF CHINOOK THERAPEUTICS, INC. 401(k) PLAN

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of CHINOOK THERAPEUTICS, INC. 401(k) PLAN (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits for the period from January 1, 2024 to October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of October 31, 2024 and December 31, 2023 and for the period from January 1, 2024 to October 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Merger

As discussed in Note 1, effective October 31, 2024, the Plan was merged into the Novartis Corporation Investment Savings Plan (“Novartis Plan”). As a result, all Plan net assets available for benefits were transferred out to the Novartis Plan on October 31, 2024.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Chinook Therapeutics, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan was a defined contribution plan available to all employees of Chinook Therapeutics, Inc. (the “Company”) who had attained 21 years of age, except those individuals who were covered by a collective bargaining agreement, leased employees, or non-resident aliens. The Plan was established on January 1, 2000, and was most recently restated on April 21, 2022, to provide retirement benefits to eligible employees. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and certain provisions of the Internal Revenue Code (“IRC”).

The Plan provided for a plan administrator who was responsible for keeping accurate and complete records with regard to the Plan, informing participants of changes or amendments to the Plan, ensuring that the Plan conformed to the law and to government regulations and providing participants with any reports and documents required by law. The investment committee oversaw the Plan’s operations, which included determining the appropriateness of the Plan’s investments offerings and monitoring investment performance.

Plan Merger – In August 2023, Chinook Therapeutics, Inc, the Plan Sponsor, was acquired by Novartis Corporation. Effective October 31, 2024, the Plan was merged into Novartis Corporation Investment Savings Plan (“Novartis Plan”), which is a defined contribution plan maintained by Novartis Corporation. All participants became eligible to participate in the Novartis Plan effective October 31, 2024.

On October 31, 2024, all assets available for benefits held by the Plan totaling \$25,290,805, including notes receivable from participants, were transferred from the Plan to the Novartis Plan. As a result, the Plan no longer holds investment assets or receives contributions, and the Plan administrator intends to terminate the Plan and the related trust.

Participant Contributions – Participants could voluntarily contribute up to 100% of annual eligible compensation limited to \$23,000 of elective deferrals for the taxable year ended December 31, 2024. Participants could elect to contribute, on a pre-tax basis or post-tax basis (“Roth”), either a percentage or set dollar amount of annual eligible compensation, as defined by the Plan document. Participants who had attained 50 years of age by the end of the Plan year and who were making contributions to the Plan could also make a catch-up contribution limited to \$7,500 for the taxable year ended December 31, 2024. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan had an automatic enrollment provision that enrolled all new eligible participants at 6% pre-tax elective deferral rate, upon meeting eligibility requirements. The eligible participants could affirmatively elect to “opt out” of the automatic enrollment or elect a different deferral rate.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Employer Contributions – The Company could make discretionary matching and discretionary non-elective contributions determined annually by the Company. For the period from January 1, 2024 to October 31, 2024, the Company elected to match 50% of an employee’s elective deferrals up to \$5,000. There were no non-elective contributions for the period from January 1, 2024 to October 31, 2024.

Participant Accounts – Each participant’s account was credited with the participant’s contributions and Company matching contributions, as well as allocations of discretionary non-elective contributions and investment earnings. Participant accounts were charged with an allocation of investment losses and administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Vesting – Participants were immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Participants were also immediately vested in employer matching contributions. Employer non-elective contributions were vested according to the following schedule:

Investment Options – The Plan offered various mutual funds and a fixed asset stable value fund as investment options for participants. Each investment option had its own investment strategy, which could be obtained through the prospectus of the respective fund. Participants could change their investment options at any time.

Upon enrollment in the Plan, participants could direct the investment of their accounts among the funds available through the Plan.

Notes Receivable from Participants – Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years, or up to ten years for the purchase of a primary residence. The loans were secured by the vested balance in the participant's account and bore interest at the prime rate plus 2.00%, as established by the Plan administrator. Interest remained fixed throughout the term of the loan. Principal and interest were paid ratably through payroll deductions and notes were due immediately upon default, death or termination of employment. Effective July 28, 2024, the plan was amended to remove the requirement that notes be due immediately upon termination of employment.

Payment of Benefits – Upon termination of service due to death, disability, retirement, or for other reasons, a participant (or beneficiary) could receive a lump-sum distribution, a direct rollover distribution, or a combination of cash and direct rollover distribution equal to the value of the participant's vested interest in his or her account. A participant could also be eligible for withdrawals due to financial hardship in certain circumstances and in-service distributions could be made to a participant who had not separated from service provided that the participant had attained 59½ years of age. Mandatory distributions were required to begin no later than April 1st of the calendar year following the calendar year the participant turned 73 years of age.

In accordance with SECURE 2.0 Act, effective January 1, 2024, if a terminated participant's account balance was between \$1,000 and \$7,000, and no instructions had been received from such participant, the amount would be rolled over to an individual retirement account as designated by the plan administrator. In 2023, the upper limit was \$5,000. However, if the vested benefit in the participant's account did not exceed \$1,000, the participant would receive the full value of the vested interest in the account as a lump sum distribution.

Forfeited Accounts – Any portion of a terminated employee's account that was not vested was forfeited, subject to the possibility of reinstatement. Forfeited accounts could be used to pay for the Plan's administrative expenses and employer contributions. As of October 31, 2024 and December 31, 2023, forfeited nonvested accounts amounted to \$0 and \$1,041, respectively. For the period from January 1, 2024 to October 31, 2024, \$696 and \$313 of the forfeitures balance were used to offset employer contributions and pay for the Plan's administrative expenses, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – These financial statements are prepared on the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determined the Plan's valuation policies utilizing information provided by the trustee of the Plan. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions – Contributions from Plan participants, matching contributions and profit sharing contributions from the Employer were recorded in the year in which the employee contributions were withheld from compensation.

Notes Receivable from Participants – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when incurred. No allowance for credit losses had been recorded as of October 31, 2024 and December 31, 2023.

Payment of Benefits – Benefits were recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Fees paid by the Plan for investment management services were included in net appreciation or depreciation in fair value of the investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy were described as follows:

Level 1: Inputs to the valuation methodology were unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology included:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology were unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximized the use of relevant observable inputs and minimized the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There had been no changes in the methodologies used at October 31, 2024 and December 31, 2023. There were no investments held by the Plan at October 31, 2024, as a result of the Plan merger discussed in Note 1. At December 31, 2023, the Plan's investments were mutual funds and a collective trust fund.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 3 – FAIR VALUE MEASUREMENTS (Continued)

Collective Trust Fund: Valued at the NAV of the units of a collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal in order to ensure that securities liquidations will be carried out in an orderly business manner. As a result of the Plan merger, the issuer permitted redemption from the collective trust in order to facilitate the transfer of funds during October 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2023, three investment funds accounted for approximately 41% of the Plan’s investment assets, respectively.

NOTE 4 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN

The plan administrator had elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (“Fidelity”), the trustee of the Plan, had certified the completeness and accuracy of all investments and notes receivable from participants presented on the Statements of Net Assets Available for Benefits as of October 31, 2024 and December 31, 2023, and the related investment income and interest income on notes receivable from participants reflected in the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2024 to October 31, 2024.

The Plan’s independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by Fidelity Investments, a related entity to Fidelity, the trustee of the Plan and, therefore, these transactions qualified as party-in-interest transactions.

The Company had entered into a service agreement whereby Fidelity provided certain administrative services to the Plan. Fidelity received revenue from mutual fund service providers, including Fidelity Investments, for these services they provide. This revenue was used to offset certain amounts owed to Fidelity for its administrative services to the Plan and was credited back to the eligible participants directly. Because these fees were paid through this revenue sharing arrangement, rather than a direct payment, they were netted against the net appreciation or depreciation in fair value of investments.

NOTE 6 – TAX STATUS

The Plan had adopted the FMR pre-approved plan. FMR is an affiliate of Fidelity, the trustee. The IRS has determined that the FMR pre-approved plan is designed in accordance with the applicable guidelines of IRC Section 401 and informed FMR of such in a letter dated June 30, 2020. The Plan had not filed for a separate determination letter; however, the Plan administrator believed that the Plan was designed and was currently being operated in substantial compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risk.

NOTE 8 – PLAN TERMINATION

As discussed in Note 1, effective October 31, 2024, the Plan was merged into the Novartis Plan, and all participants became eligible to participate in that plan. As a result, all Plan assets were transferred out on October 31, 2024. The Plan no longer holds investment assets or receives contributions, and the Plan administrator intends to terminate the Plan and the related trust in accordance with ERISA.

NOTE 9 – SUBSEQUENT EVENTS

The Company has evaluated subsequent events through August 12, 2025, which is the date the financial statements were available to be issued.
