NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Sellenriek Holding Company, Inc. 401(k) Salary Savings Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General: The Plan is a defined contribution plan covering employees of Sellenriek Holding Company, Inc. and affiliated companies (the Company). The Plan was established November 1, 1989 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees who completed one year of service in which they have 1,000 or more hours of service and have attained the age of 18 were eligible to participate in the Plan through May 31, 2023. Effective June 1, 2023, the Plan was amended to allow eligibility after 60 days of service using the elapsed time method.

Contributions: Each year, participants may contribute a portion of pre-tax annual compensation, as defined in the Plan, not to exceed maximum amounts specified by the Internal Revenue Service (IRS), in accordance with a participant salary deferral agreement. Effective April 1, 2022, participants were also permitted to make after-tax (Roth) elective deferrals to the Plan. Participants who are at least 50 years of age may make an additional contribution to the Plan not to exceed \$7,500 in both 2024 and 2023, under certain conditions. Participants may also contribute amounts representing rollover distributions from other qualified plans. Matching contributions are determined annually at the discretion of the Company's Board of Directors. In 2024 and 2023, the Company's matching contributions were 50% of participant contributions, not to exceed 6% of eligible compensation. Additional profit sharing amounts may be contributed at the discretion of the Company. There were no additional discretionary profit-sharing contributions during 2024 or 2023. Participants direct the investment of contributions into various investment options offered by the Plan.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contributions, earnings of the participant's selected investment accounts, and the participant's rollover contributions from other qualified benefit plans, if any. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are automatically 100% vested in the portion of their accounts resulting from participant salary deferrals and earnings thereon. Participants vest in employer discretionary contributions at a rate of 20% after two years of service and in 20% increments each subsequent year with full vesting in employer contributions occurring after six years of service. A participant is considered to have one year of service for each one-year period in which he or she has worked 1,000 hours or more. Participants become automatically 100% vested in employer discretionary contributions upon attaining normal retirement age of 65, total disability, or death.

Forfeitures: Forfeitures of Company discretionary contributions are used to pay plan expenses or used to reduce employer contributions to the Plan. At October 31, 2024 and 2023, forfeited nonvested amounts available to pay plan expenses or reduce future employer contributions totaled \$52,987 and \$49,818, respectively. During the years ended October 31, 2024 and 2023, forfeitures of \$60,912 and \$32,039, respectively, were used to pay plan expenses.

Asset holding account: The Plan maintains an asset holding account to pay certain administrative expenses. The account receives quarterly credits from the Plan's service providers that are available to pay the Plan's record-keeping service fees. During both the years ended October 31, 2024 and 2023, no amounts were used to pay administrative expenses. At October 31, 2024 and 2023, \$4,019 and \$7,840, respectively, remained in the holding account to pay future administrative expenses.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are payable ratably through payroll deductions.

Payment of benefits: Upon termination of service, a participant or his/her beneficiary may receive benefit distributions in a single lump sum payment (required for vested balances less than \$1,000), which may be in the form of a cash payout or rolled over into another qualified pension plan, annuity payments, or installment payments.

Administration: Capital Bank and Trust Company holds the Plan's assets, administers investment activity, and invests contributions into funds designated by each participant. American Funds maintains the individual participant accounts and provides records of balances and transactions to the Plan administrator and participants. Ascensus serves as the Plan's third-party administrator and provides general professional and administrative services to the Plan. Certain administrative and record-keeping costs are being absorbed by the Company. The Company's Board of Directors is responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Valuation of investments: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the declaration date. Interest is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities of the Plan are exposed to various risks, such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits: Benefits are recorded when paid.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events: Events that have occurred subsequent to October 31, 2024, have been evaluated through August 8, 2025, which represents the date the Plan's financial statements were approved by management and therefore available to be issued.

3. TERMINATED PARTICIPANTS

Net assets available for benefits at October 31, 2024 and 2023 included \$2,423,711 and \$1,584,743, respectively, allocated to the accounts of individuals who, as of or prior to that date, had withdrawn from actively participating in the operations of the Plan, generally as a result of terminating employment. These amounts may be paid within the next year, at the request of the participant. These participants receive no further contributions but do receive allocations of investment income and Plan expenses.

4. TAX STATUS

The IRS has determined and informed Ascensus LLC by a letter dated June 30, 2020, that the non-standardized pre-approved profit-sharing plan as amended through December 31, 2018 is in a form acceptable under section 401 of the Internal Revenue Code (IRC). The Plan adopted this Cycle 3 Restatement effective November 1, 2021, as an amendment and restatement of the existing plan to bring the Plan into compliance with legislative and regulatory changes. As part of this amendment, the plan sponsor was changed from Sellenriek Construction, Inc. to Sellenriek Holding Company, Inc., and the Plan was renamed the Sellenriek Holding Company, Inc. 401(k) Salary Savings Retirement Savings Plan. In addition, Selcon Construction, LLC was added as a participating employer.

Effective April 1, 2022, the Plan was amended to include Roth contributions. Effective August 1, 2022, the Plan was amended to add Croft Electrical Contractors, Inc. as a participating employer. Effective June 1, 2023, the Plan was amended to reduce the eligibility requirement from 1 year of service to 60 days of time elapsed. Effective April 1, 2024, the Plan was amended to add Anderson Underground, LLC as a participating employer. Effective October 1, 2024, the Plan was amended to add recognition of service with ACSI Construction, LLC for eligibility and vesting purposes.

The Company may rely on the opinion letter issued by the IRS as evidence the Plan is qualified under the applicable sections of the IRC. The Plan is relying on the opinion letter. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position

that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. CERTIFICATION OF INVESTMENT INFORMATION

Certain information in the accompanying financial statements and ERISA-required supplemental schedule of assets held at year-end related to investments and notes receivable from participants held as of October 31, 2024 and 2023, and net appreciation in fair value of instruments, dividend income, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, a qualified institution.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

7. FAIR VALUE OF INVESTMENTS

Plan investments are held in custodial accounts managed by Capital Bank and Trust Company, the Plan's custodian, and are unsecured. Investments are participant-directed and held by parties-in-interest.

A fair value hierarchy is used that prioritizes the inputs to valuation techniques used to measure fair value of balances that are required or permitted to be measured at fair value for reporting in financial statements. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to the unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets recorded at fair value.

Mutual funds: Valued at daily closing price as reported by the fund on an active market which is based on the underlying net asset value (NAV) of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include transactions with fiduciaries or employees of the Plan, any person providing services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer, and relatives of parties-in-interest. The Plan has various parties-in-interest. Investments are held with parties-in-interest and certain fees are paid to parties-in-interest.

9. PROHIBITED TRANSACTIONS

During the year ended October 31, 2024, the Company inadvertently failed to remit certain November 2023, December 2023, April 2024, June 2024, August 2024, September 2024 and October 2024 employee deferrals totaling \$56,257 and participant loan repayments totaling \$4,222 to the Plan. The Company remitted the late employee deferrals and participant loan repayments to the Plan in December 2023, January 2024, May 2024, July 2024, September 2024, and October 2024, respectively. No determination of any amounts due to participants for missed earnings has yet been made.

During the year ended October 31, 2023, the Company inadvertently failed to remit certain August 2023 employee deferrals totaling \$25,146 and participant loan repayments totaling \$1,206 to the Plan. The Company remitted the late employee deferrals and participant loan repayments to the Plan in September 2023. No determination of any amounts due to participants for missed earnings has yet been made.
