Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AmSpec, LLC Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

1. Description of Plan

The following brief description of the AmSpec, LLC Retirement Savings Plan (the Plan) is for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1997. The Plan is a defined contribution plan that covers substantially all employees of AmSpec, LLC (the Company or the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective July 1, 2024, the Company added a new entity named Grain Inspection Services of Texas, LLC to the Plan. This entity was created by the Company. Employees from the Company who were originally included in the plan were transferred to this entity as employees. Employees of both Grain Inspection Services of Texas LLC and the Company are included and participate under the Plan.

Transfer from Plan Merger

Effective April 1, 2023, Marine Technical Surveyors, Inc. 401(k) Profit Sharing Plan was merged into the current Plan and all the plan assets were transferred in. The total amount transferred in of \$3,824,316 is recorded as transfers in from other plans in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2023.

Eligibility

Employees of the Company are eligible to participate in the Plan on the first day of the month coinciding with or next following the date of completion of three months of service and upon the attainment of 18 years of age. Effective March 1, 2018, the Plan was amended to exclude union employees. Accordingly, union employees were not considered as eligible employees for all contribution types. Residents of Puerto Rico are also excluded from participation in the Plan.

Contributions

The Plan provides each participant with an opportunity to make elective pre-tax salary deferral contributions and Roth (after-tax) contributions to the Plan. Participants' salary deferral contributions are not to exceed 85% of compensation, subject to the limitations of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Effective April 1, 2025, the plan allows for both in-plan Roth rollovers and transfers.

The Company is required to make safe harbor matching contributions equal to 100% of the participants' salary deferral contributions up to 3% of their compensation and 50% of the participants' salary deferral contributions that exceed 3% of their compensation, not to exceed 5%. The Company may also make a discretionary profit-sharing contribution to the Plan in accordance with the provisions contained in the Plan document. The Company contributed safe harbor matching contributions totaling \$4,837,434 and \$4,409,831 for the years ended December 31, 2024 and 2023, respectively. The Company did not make a discretionary profit-sharing contribution to the Plan for the years ended December 31, 2024 and 2023.

Vesting

Participants are fully vested in their own contributions and safe harbor matching contributions and earnings thereon. Participants vest 20% after one year of service and an additional 20% each subsequent year until fully vested after completing five or more years of service for the Company's discretionary profit-sharing contributions.

Forfeited Accounts

Forfeited nonvested accounts are used to pay Plan expenses or to reduce future Employer contributions. The Plan had balances in forfeited nonvested accounts of \$33,361 and \$32,394 at December 31, 2024 and 2023, respectively. Included in both balances is \$25,128 of stale checks, at December 31, 2024 and 2023, which were not deposited by the intended participants in a timely manner. The Plan is working with the third-party administrator to locate these participants and return the funds, plus earnings, to them.

Participant Accounts

Each participant's account is credited with their contributions, Company contributions (safe harbor matching and discretionary profit sharing), and the earnings thereon and charged with withdrawals and an allocation of Plan expenses. Contributions to the Plan are invested by the trustee as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested amount.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$500 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The term of the loan cannot exceed five years except when the loan is used to purchase a principal residence, which can be repaid over a longer period. No more than three loans are allowed outstanding at any time. Loans are repaid through payroll deductions and monitored by the Plan administrator. The loans are collateralized by the balance in the participant's account and bear interest at a rate of prime plus 1%. The interest rates on notes outstanding at December 31, 2024 and 2023 ranged from 4.25% and 9.75%.

Contributions Receivable

Participant contributions and any related safe-harbor matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Benefits

A participant's vested interest in their account balance is distributable generally upon termination, disability, retirement, or death. In-service distributions are available to a participant who has not separated from service and has attained age 59½. Participants may withdraw from their individual accounts pursuant to specific guidelines as set forth in the Plan document. The participant may postpone the benefit distribution to a later date, provided the participant is not a 5% owner, as

defined. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. The Plan is responsible for administrative expenses relating to the management of Plan assets incurred by the Plan except for certain transactions fees such as loan and distribution requests, which are paid by the participants. These fees are allocated either proportionally based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense.

3. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

4. Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

GAAP establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring the most observable units to be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumption about inputs market participants would use at the measurement date.

The fair value hierarchy is categorized into three levels based on inputs as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation techniques include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for asset measurement at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common Collective Trust (CCT) - CCT funds are valued using the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Related Party and Party-in-Interest Transactions

Reliance Trust Company, the trustee, and ADP Retirement Services, the third-party administrator and the recordkeeper of the Plan, are parties-in-interest with respect to the Plan under the provisions of ERISA. Notes receivable from participants also qualify as party-in-interest transactions. Plan investments include shares of registered investment companies managed by the trustee; therefore, these transactions qualify as party-in-interest transactions. Investment-related fees are reflected as an offset of net investment income and are not readily determinable. Fees paid to ADP Retirement Services and Hancock Whitney Bank, investment advisor, amounted to \$269,340 and \$251,869 for the years ended December 31, 2024 and 2023, respectively.

6. Plan Termination

Although it has not expressed any intention to do so, the Company reserves the right to amend, alter, or terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, the amount credited to the account of each participant will be fully vested.

The Company may reduce or suspend Employer safe harbor contributions upon satisfaction of certain requirements, including a 30-day advanced notice to all eligible employees.

7. Tax Status

The Plan obtained the latest opinion letter for the volume-submitter plan sponsored by ADP, LLC which the Plan adopted, on October 6, 2020 in which the Internal Revenue Service (IRS) stated that the pre-approved profit-sharing plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

Subsequent events were evaluated by the Plan's management through July 29, 2025, the date the financial statements were available to be issued. There were no subsequent events requiring adjustment to the financial statements or disclosures.
