Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nordon, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Nordon, Inc. 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Nordon, Inc. 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. NOTE A: DESCRIPTION OF THE PLAN

The following description of the Nordon, Inc. 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Nordon, Inc. (the “Company”). Participation in the Plan is elective at the discretion of the employee. The requirements, as defined by the Plan agreement, are that an employee must be 21 years of age, have completed at least one year of eligible service, and are not covered under collective bargaining agreements. The Plan defines one year of eligible service as 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 15% of their pre-tax annual compensation, as defined by the Plan, subject to Internal Revenue Service limitations. Participants can also roll over amounts representing distributions from other qualified plans.

The employer will make matching contributions based on the participant’s elected deferral. The match is calculated as 25% of the participant’s elected deferral up to a maximum of 4%. The Company may also contribute and allocate to each participant’s account a discretionary profit-sharing contribution. For the years ended December 31, 2024 and 2023, the Company did not make a profit-sharing contribution.

Participant accounts

Each participant's account is credited with the participant’s contribution, employer matching contribution and the Plan’s earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants may direct the investment of their account balances into various investment options offered by the Plan. At December 31, 2024 and 2023, all amounts allocated to accounts of participants who have withdrawn from the Plan have been paid.

Vesting

Participants are immediately vested in their elective contributions and actual earnings thereon. Participants vest in employer matching contributions, profit-sharing contributions and actual earnings and losses thereon at a rate of 20% per annum upon completion of the second year of service. Participants are fully vested in employer matching contributions after six years of service.

Payment of benefits

Funds may be withdrawn by participants under circumstances of retirement at the normal retirement age, death, disability, termination of employment, or qualified military service. Participants may also withdraw an amount at age 59½ if certain criteria are met. Vested account balances that are less than \$5,000 upon termination of employment will be paid in one lump-sum distribution in accordance with the provisions of the Plan. In May 2024, the Plan was amended to state that vested account balances that are less than \$7,000 upon termination of employment will be paid in one lump-sum distribution in accordance with the provisions of the Plan.

Participant notes receivable

Participants are entitled to borrow from their accounts subject to certain limitations. In general, participants may borrow up to 95% of one-half of their vested account balances, but not more than \$50,000 and not less than \$1,000 subject to restrictions set forth in the Plan document. In May 2024, the Plan was amended to state that participants may borrow up to 50% of their vested account balances, but not more than \$50,000 and not less than \$1,000 subject to restrictions set forth in the Plan document. The notes bear interest at the prime rate plus 1% and must be repaid over a maximum term of fifty-four months. Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. Principal and interest payments are generally made through payroll withholdings.

Accounts forfeited

Participants who terminate employment prior to the vesting of the employer contributions to their retirement accounts forfeit such contributions. Such forfeitures are re-allocated to active participants based on the ratio of the individual wages to total plan wages. During 2024 and 2023, \$13,566 and \$2,468, respectively, were re-allocated to participants. There were unallocated forfeiture balances of \$10 and \$3,287 at December 31, 2024 and 2023, respectively.

Diversification and transfers

Under the Nordon, Inc. Employee Stock Ownership Plan document, participants meeting certain age and service requirements may elect to diversify the eligible portion of the Company stock held in their account. The funds elected to be diversified are transferred to the Plan and invested into funds as chosen by the participant. During 2024 and 2023, there were no amounts transferred by participants.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements and supplemental schedule are prepared under the accrual method of accounting.

Cash and cash equivalents

Cash and cash equivalents include money market funds and all highly liquid debt instruments with original maturities of three months or less. The Plan maintains cash and cash equivalents which periodically may exceed federally insured amounts.

Investment value and income recognition

The Plan's investments are valued at fair value. Mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. The net asset value is determined using the quoted market prices of the investments in which the portfolio has invested.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold during the year as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Use of estimates in the preparation of financial statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through July 22, 2025, which is the date the financial statements are available to be issued. No subsequent events requiring disclosure were noted.

NOTE D: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their accounts and their accounts will be paid to them as provided for in the plan document.

NOTE E: TAX STATUS

The Plan is a non-standardized pre-approved plan. The plan has received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, which states that the non-standardized pre-approved plan, as designed, qualified for federal income tax exempt status. The Plan has not individually sought a determination letter from the IRS on its qualification status. However, the Plan's third-party administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE F: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G: TRANSACTIONS WITH PARTY-IN-INTEREST

Participant loans qualify as party-in-interest transactions. Additionally, as described in Note A the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

NOTE H: FAIR VALUE MEASUREMENTS

GAAP establishes a framework for measuring fair value of financial assets and liabilities and non-financial assets and liabilities. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Instruments whose significant inputs are unobservable.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market: Valued at cost which approximates fair value.

Mutual Funds: Valued at the daily closing price listed by the fund. Mutual funds held by the Plan are actively traded, open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to report their daily net asset value and to transact at that price.

NOTE H: FAIR VALUE MEASUREMENTS, Cont'd

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
