INDEPENDENT AUDITOR'S REPORT

To the Retirement Plan Committee and participants of the
Formetco, Incorporated Profit Sharing and 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Formetco, Incorporated Profit Sharing and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section of the report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements December 31, 2024 and 2023

1. Description of the Plan

The following description of the Formetco, Incorporated Profit Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, copies of which are available from the plan administrator, for a more detailed description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees except union employees, nonresident aliens, and leased employees of Formetco, LLC (the Company or Plan Sponsor). Employees of the Company become eligible to join the Plan after two months of service and enter the Plan on the first day of the first payroll period of the month following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make pre-tax and/or Roth contributions from eligible compensation, as defined by the Plan document, up to a maximum of \$23,000 in 2024, plus an additional \$7,500 catch-up deferral for those participants who have attained age 50 by the end of the Plan year. All eligible employees will be automatically enrolled in the Plan after meeting service requirements at a contribution rate of 6% of eligible compensation unless they elect otherwise. Beginning in their third year of employment, this will be increased annually by 1% of eligible compensation not to exceed 10% unless they elect otherwise. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company makes a safe harbor matching contribution equal to 100% of participant contributions up to 1% of eligible compensation, plus an additional 50% of participant contributions which exceed 1% but do not exceed 6% of eligible compensation.

The Company may make discretionary profit sharing and discretionary matching contributions. In general, the participant must have died, retired, or completed one year of service with the Plan Sponsor and be an employee of the Plan Sponsor on the last day of the plan year to share in the allocation of discretionary profit sharing and discretionary matching contributions. Such additional discretionary contributions are subject to limitations under the Internal Revenue Code (IRC) and allocated to employees based on each participant's compensation. There were no Company discretionary contributions in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, the Company's contributions, earnings or losses on the investments in their account, and is charged with transaction fees for services received by the participant and certain administrative expenses. Upon enrollment in the Plan, a participant may direct any contributions to any of the investment

options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and rollovers plus actual earnings thereon. Safe harbor matching contributions are fully vested after two years of service. The participants are 0% vested until reaching two years of service at which time they become 100% vested. For Company discretionary profit sharing contributions and discretionary matching contributions, participants vest 20% per year beginning with the completion of their second year of service and are fully vested after 6 years of service. A participant's entire account balance immediately vests in cases of death or disability while an employee of the Plan Sponsor, retirement at or after the age of 65, or termination of the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the vested balance of their account. A participant may have only one note outstanding at any time. The notes are secured by the balance in the participant's account and bear a fixed rate of interest equal to the prime rate plus 2% at the time the note is made. During 2024, notes outstanding had fixed rates between 5.25% to 10.50% for the term of the note, not to exceed 5 years unless used for the purchase of a primary residence. Principal and interest are paid through payroll deductions.

Payment of Benefits

At the time of death, disability, termination of service or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum distribution. The participant's contributions may also be withdrawn for in-service distributions upon reaching age 59½ or for certain hardship situations. Additionally, a participant may request an in-service withdrawal of their non-safe harbor vested balances upon reaching age 52 and completing at least 240 months of service. Vested account balances less than \$5,000 may be automatically distributed without participant consent upon termination of service.

Forfeited Accounts

Forfeited non-vested accounts totaled \$10 and \$11 at December 31, 2024 and 2023, respectively. These accounts can be used to reduce future Company contributions or pay administrative expenses. During 2024, the Plan used \$13,195 of forfeited non-vested accounts to reduce Company contributions and no amounts were used to pay administrative expenses.

Administrative Expenses

Participant fees are paid by participants on a pro-rata basis. Participants also pay fees for distributions, notes receivable, and other transactions. Certain administrative expenses are permitted to be paid by the Plan in accordance with the Plan's provisions. Fees paid to service providers of the Plan qualify as party in interest transactions. The Company pays all other administrative expenses of the Plan. The Company does not expect reimbursement from the Plan for these expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates, and such differences may be material to the financial statements.

Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. Company safe harbor matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan. Company discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and after approval by the Retirement Plan Committee. Company discretionary profit-sharing contributions are considered payable to the Plan after approval by the Retirement Plan Committee. Any unfunded participant or employer contributions are included as a participant or employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023.

The Plan estimates the current credit risk associated with the contributions receivable. After giving consideration to the risk characteristics, historical payment experience, current conditions, and reasonable forecasts, the Plan determined that no allowance for credit losses was necessary and there was no current year activity in the allowance for credit losses.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion on fair value measurements.

Net change in fair value of investments includes interest, dividends, realized and unrealized gains and losses on those investments, and fees charged for investment management and administrative services on those investments.

Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received by the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant's note balance is reduced, and a benefit payment is recorded. Notes receivable from participants also qualify as party-in-interest transactions.

Payment of Benefits

Benefits are recorded when paid by the Plan.

Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 11, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net change in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Plan's qualified institution.

4. Investments

Investments are exposed to several risks, such as interest rate, market, currency, and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include healthcare crises, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cybersecurity attacks, and other similar events. It is at least reasonably possible that changes in fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are valued at quoted market prices for the identical security in an active market (Level 1).

5. Plan Termination

Although it has not expressed any intent to do so, the Company has a right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company contributions.

6. Income Tax Status

The Plan uses a non-standardized pre-approved plan document sponsored by Automatic Data Processing, LLC (ADP). ADP received an opinion letter from the Internal Revenue Service, dated October 6, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan has not received an individual determination letter and has been amended since ADP received the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. The Plan's income tax returns for the past three years are subject to examination by taxing authorities and may change upon examination.
