INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of

Opinion

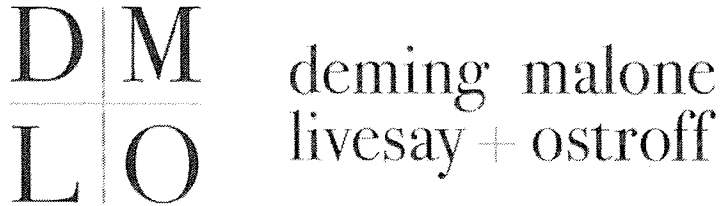




