## NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Anesthesia & Pain Specialists of Bowling Green PLC 401K Profit Sharing Plan Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### *General*

The Plan is a defined contribution plan covering eligible employees. The Plan is subject to the provisions of ERISA. All regular full-time and part-time employees of Anesthesia & Pain Specialists of Bowling Green PLC except employees covered by collective bargaining agreements, leased employees and temporary employees are eligible to participate in the Plan at age 21. Participants are eligible to participate in elective deferral and safe harbor contributions after one hour of service. Participants are eligible to participate in employer matching and profit-sharing contribution after 1 year of service.

The Plan was terminated effective December 31, 2023.

### *Contributions*

Each year participants may contribute maximum allowable amount of IRC 402(g) limit of \$23,000 for 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified plans. Roth elective deferrals are permitted under the Plan.

Annually the plan sponsor shall make a safe harbor matching contribution equal to 100% of the first 3% and 50% up of the next 2% of the eligible participants elective deferral contributions. The plan sponsor may also make a discretionary matching contribution and profit-sharing contribution. The maximum IRC 415 limit for total contributions made on behalf of a participant (deferrals and employer contributions) is \$69,000 for 2024. Catch-up contributions can be made in excess of this limit.

Participants direct the investment of their contributions into various investment options offered by the plan. The plan currently offers various mutual funds and common collective trust as options for participants.

### *Participant Accounts*

Each participant's account is credited with the participant's contribution and Company matching contributions as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that were paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

***Vesting***

Participants are vested immediately in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in employer matching contributions and profit-sharing contributions are based on a 6-year graded schedule as such:

***Notes Receivable from Participants***

Participants may only acquire loans on amounts that were rollovers into their account. No loans were made in 2024 and 2023.

***Payment of Benefits***

On termination of service due to death, disability, retirement or other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Ins service withdrawals are permitted at age 59 ½ and for hardship.

The distributable amount is equal to the value of the participant's vested interest in his or her account. Employees who elect to have their benefit payments deferred continue to share in allocations of investment income and losses but do not share in subsequent allocations of discretionary contributions. Hardship distributions are permitted.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$392 respectively. These accounts will be used to reduce administrative expenses. In 2024, company match and administrative expenses were reduced by \$1,191 from forfeited non-vested accounts.

**NOTE 2. SUMMARY OF ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements as of and for the year ended December 31, 2023, were prepared using the liquidation basis of accounting in accordance with ASC 205-30, due to the Plan Sponsor's decision to terminate the Plan and begin the process of liquidating its assets.

For the year ended December 31, 2024, the Plan had no net assets remaining as of year-end, but had activity related to final distributions and administrative expenses. The 2024 financial statements are presented on the accrual basis of accounting, consistent with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded in the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payments of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investments related expenses are included in net appreciation (depreciation) of the fair value of investments.

***Subsequent Events***

The plan has evaluated subsequent events through July 24, 2025, the date of the financial statements were available to be issued.

These funds are required to publish at their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective trust:* Valued at NAV of units of a bank collective trust fund. The NAV as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust fund, the investment adviser reserves the right to temporarily delay withdrawal from the fund in order to ensure that the securities' liquidations will be carried out in an orderly business.

**NOTE 4. FAIR VALUE MEASUREMENTS (Continued)**

The Invesco Stable Value Fund (“the Fund”) is a common collective trust (“CCT”) offered by Bank of America Merrill Lynch (“the trustee”). The CCT invests mainly in Guaranteed Investment Contracts, which earns an issuer’s guarantee of a specific rate and portfolio of financial instruments that are owned by the issuer, Bank of America Merrill Lynch. Participants will receive the principal and accrued earnings credited to their accounts upon withdrawal for allowed events. These events include transfers to other Plan investment options, payments because of retirement, termination of employment, disability, death, and in-service withdrawals as permitted by the Plan. Certain events, such as Plan termination or a Plan merger initiated by the Plan sponsor, may limit the ability of the Plan to transact at contract value. The Plan sponsor does not believe any events that may limit the ability of the Plan to transact at contract value are probable.

The Plan Trustee receives fees from administration and investment management.

On December 31, 2023, the Plan Sponsor approved the termination of the Plan.. All Plan assets were distributed to participants and beneficiaries in accordance with the Plan document and applicable regulations of the Internal Revenue Code. The final distributions were completed during the year ended December 31, 2024.

**NOTE 8. TAX STATUS**

The IRS has determined and informed the Company by letter June 30, 2020 in which the Internal Service stated that the Plan, is designed, in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and therefore, believe that the Plan is qualified and tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 9. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.
