### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Superior Electric Great Lakes 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Superior Electric Great Lakes 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### **Basis for Opinion**

### **1. Description of Plan**

The following description of the Superior Electric Great Lakes 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

#### **General**

The Plan was formed effective August 1, 1995, as a defined contribution savings plan pursuant to Section 401(k) of the Internal Revenue Code (IRC). The plan covers all Superior Electric Great Lakes Company (employer) employees 18 years or older with 2 months of service that are not members of a collective bargaining unit, leased employees, nonresident aliens, interns, or self-employed individuals.

#### **Contributions**

Each employee who participates in the Plan is entitled to enter into a compensation reduction agreement with the employer. The amount of reduction shall be contributed by the employer on behalf of the participant into the Plan for allocation to the participant's account. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an auto-enrollment provision whereby all newly eligible employees hired after October 1, 2014 are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation until changed by the participant. If a participant does not select a different deferral percentage than the auto-enrolled percentage, the percentage will be automatically increased each January 1 by 1% up to a maximum percentage of 15%. Participant contributions are fully vested. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions.

The employer may make discretionary matching contributions and/or discretionary profit-sharing contributions, to be determined by the employer. Employer contributions made subsequent to year-end related to the preceding year are classified as employer contributions receivable. For the years ended December 31, 2024 and 2023, the employer made matching contributions of 100% of participant elective deferral contributions up to \$3,200 and 50% of participant elective deferral contributions above \$3,200. The employer also made discretionary profit-sharing contributions totaling approximately \$779,500 for the year ended December 31, 2024 and \$651,500 for the year ended December 31, 2023, which covered all participants employed on the last day of the Plan year. The cash contributed for the 2024 profit-sharing contribution of approximately \$779,500 was reduced to approximately \$765,800 through the application of forfeitures when paid in early 2025.

#### **Contributions (continued)**

The profit-sharing calculation considered the dollar limitation for total contributions per participant to a qualified retirement plan under Section 415(c) of the IRC. The profit-sharing percentages selected for use each year are based on not exceeding the 415(c) limits for any participant of the Plan, while remaining in compliance with the nondiscrimination requirements of Section 401(a)(4) of the IRC.

#### **Participant Accounts**

Participant accounts are credited with participant contributions, employer contributions, rollover contributions, and an allocation of plan earnings and expenses. Participants shall direct their contributions and the employer contributions to one or more of the Plan's investment funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Notes Receivable from Participants**

Participants shall be permitted to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Such loans are secured by the balance of the participant's account and shall be charged an annual prevailing rate of interest to be fixed by the Plan Administrator, based on 1% over the prime interest rate. Such loans shall be fully repaid on or before five years from the date of disbursement, except for home loans which shall be fully repaid on or before ten years from the date of disbursement.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service, with 25% vesting after one year, 50% vesting after two years, and 100% after three years.

#### **Payment of Benefits**

Upon attainment of normal retirement age (65) or other separation of employment, because of death, disability, or for other reasons, participants receive their benefits as a lump-sum payment or partial withdrawal. Early retirement is allowed at age 55 with at least three years of service. Participants that separate employment because of death will have their benefits paid via lump-sum payment or partial withdrawal to their named beneficiary or to their estate if no beneficiary has

been named. Participants are eligible to make in-service withdrawals of their vested account balance upon reaching age 59 ½.

Participants may request that all or a portion of their accounts be distributed in the case of severe financial hardship, as defined by the Plan Document. The Company must approve any such hardship withdrawals.

### **2. Summary of Significant Accounting Policies**

#### **Forfeited Accounts**

Forfeitures of employer contributions shall be used to restore forfeitures, reduce employer contributions, or pay reasonable Plan expenses. The balance of forfeited nonvested accounts was \$19,881 as of December 31, 2024 and \$16,619 as of December 31, 2023. During 2024, \$24,685 of forfeitures were used to reduce employer contributions (including \$13,640 used to reduce the employer profit sharing contribution for 2024 paid in 2025) and no forfeiture amounts were used to defray Plan expenses. In 2023, forfeitures were not used to defray Plan expenses or reduce employer contributions.

#### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. See Note 8 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Benefits Paid to Participants**

Benefits paid to participants are recorded as deductions upon distribution.

#### **Administrative Expenses**

Plan administrative expenses are paid by either the Plan or the employer, as provided in the plan document.

#### **Use of Estimates**

The process of preparing financial statements in accordance with U.S. GAAP requires management of the Plan to make estimates and judgments that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from estimated amounts.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 7, 2025, the date which the financial statements were available to be issued.

### **3. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **4. Income Tax Status**

The Plan obtained its latest opinion letter on November 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

Generally, tax years 2021 through the current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

### **5. Plan Termination**

Although they have not expressed any intent to do so, the employer reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

### **6. Transactions with Parties-in-Interest**

The Plan Sponsor, participants, Charles Schwab Trust Bank, Sentinel, CAPTRUST Financial Services, Plante Moran, and Andrews Hooper Pavlik PLC have all been identified as parties-in-interest.

Certain Plan investments are managed by Charles Schwab Trust Bank (Schwab), the custodian of the Plan, therefore, these transactions qualify as party-in-interest. Expenses and revenue sharing arrangements with Schwab are also considered to be party-in-interest transactions. Sentinel provides recordkeeping services for the Plan and expenses for these services are considered party-in-interest transactions. CAPTRUST Financial Services provides investment advisory services which are considered to be party-in-interest transactions. Plante Moran provides consulting services related to performance of the profit-sharing calculation which is considered to be a party-in-interest transaction. Andrews Hooper Pavlik PLC provides external financial statement audit services for the Plan which is considered to be a party-in-interest transaction.

Certain expenses, including salaries and services required for Internal Revenue Service reporting and related to the administration of the Plan were paid by the Plan Sponsor and therefore, these transactions qualify as party-in-interest.

In addition, notes receivable from participants are considered party-in-interest transactions.

### **7. Financial Information Certified by The Custodian (unaudited)**

The Plan's 2024 and 2023 financial information and data was certified by Charles Schwab Trust Bank in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the cash, investment balances, interest and dividends, and net appreciation (depreciation) in fair value of investments included in the financial statements and supplemental schedules were obtained by management and agreed to or derived from information certified as complete and accurate by the custodian. This certified information has not been audited by independent auditors.

### 8. Fair Value Measurements

As defined in the current authoritative guidance, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The guidance applies to all financial instruments that are measured and reported on a fair value basis. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.
- Level 2 – Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect a company's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. For the years ended December 31, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds and Money Market Fund:* Valued at quoted market prices based on shares held by the Plan at year-end.

*Stable Value Fund:* Stable value fund is comprised of shares or units in commingled funds that are not publicly traded. The underlying assets in these funds are primarily publicly traded equity securities, fixed income securities, and commodity-related securities and are valued at their net asset value (NAV), as a practical expedient, that is calculated by the investment manager or sponsor of the fund and have varying liquidity, redemption period notices and other restrictions. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
