NOTE 1 - DESCRIPTION OF PLAN

The following description of Family Enrichment Network 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. A complete description of the Plan may be obtained from the Plan Administrator, Family Enrichment Network, Inc.

General

The Plan is a defined contribution profit sharing plan under Section 401(k) of the Internal Revenue Code that was established on November 1, 1993 for the purpose of providing retirement benefits for eligible employees of Family Enrichment Network, Inc. (the Company). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate in the Plan's salary deferral option when they reach the age of 21 and have been employed with the Company for three months.

Contributions

The Plan allows participants to defer up to 100% of their eligible compensation, but participants are limited to the annual threshold set by the Internal Revenue Service. Participants have the option of making Roth elective deferrals.

Participants may also contribute funds representing distributions from other qualified plans or individual retirement accounts in the form of direct rollover contributions.

The Company matches 100% of each participant's deferral, up to a maximum of 2% of compensation.

The Plan provides that all employee contributions to the Plan will be invested in certain individual funds as directed by each participant. The Plan currently offers twenty-three mutual funds and one investment contract as investment options for participants to choose from.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contributions, (b) Plan earnings, and (c) forfeitures of terminated participants' non-vested accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan is a participant-directed Plan.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their voluntary contributions. There is a six-year graded vesting schedule with regard to the Company's contributions of 20% vesting after two years of services, and an additional 20% vesting for each additional year of service. In addition, a participant's account balance will become fully vested upon reaching retirement age, becoming disabled or dying while employed by the Company. Normal retirement age is 60.

Payment of Benefits

Upon termination of employment, participants may receive all or part of their vested account balance paid at any time. If the value of the participant's vested interest is \$5,000 or less, the value is automatically distributed to the participant in a lump-sum amount. Active participants may receive a portion of their vested accounts once they reach age 60. Required minimum distributions are made once a participant reaches age 70½. Additionally, active participants may make hardship withdrawals to satisfy financial hardships as specified in the Plan document.

Forfeited Accounts

Forfeited, non-vested accounts are retained in the Plan and are first used to pay administrative expenses. The remaining forfeitures shall be allocated to participants' accounts and used to reduce the contribution of the employer. During the years ended October 31, 2024 and 2023, forfeitures were used to reduce administrative expenses by \$7,510 and \$10,050, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on an accrual basis in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The Plan uses estimates and assumptions in preparing financial statements in accordance with generally accepted accounting principles. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair market value. If there is no readily available market, the investment's value is the fair value of the underlying investments held in the separate account as determined by the Plan custodian using generally accepted accounting practices and applicable law.

The fair value of the various pooled separate account (PSA) investments is a publicly quoted pricing input and is used to determine the net asset values of the PSA, which are not publicly quoted.

The net realized and unrealized appreciation (depreciation) in fair value of investments reflects the change in market value from beginning of year to end of year, realized gains and losses on sale of underlying investments, and investment earnings.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management has evaluated events and transactions that have occurred through August 11, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - CERTIFICATION

The Plan Administrator has obtained a certification from Principal Life Insurance Company, that the following information provided in the annual report to the Plan Administrator is complete and accurate.

Generally accepted accounting principles establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 3 Fair Value Measurements

The investment contract is not actively traded, and significant other observable inputs are not available. Thus, the fair value is the amount plan participants or plan sponsors would receive currently if they were to withdrawal or transfer funds with the Plan prior to their maturity.

Pooled Separate Accounts

All pooled separate accounts (PSAs) held by the plan are measured at net asset value (NAV) per share of the underlying assets of the fund. The NAV is not a publicly quoted price in an active market and is computed in accordance with investment company measurement principles. Currently all redemptions for PSAs are at that day's computed NAV.

NOTE 5 - RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Principal Financial Group. Principal Financial Group has physical and administrative control of certain assets of the Plan and executes transactions therein. Fees paid by the Plan for the investment management services amounted to \$47,002 and \$39,771 for the years ended October 31, 2024 and 2023, respectively.

These party in interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - INCOME TAX STATUS

The Plan is a prototype plan. The Internal Revenue Service has determined and informed the trustee by a letter dated July 22, 2003 that the prototype plan and the related trust established under the plan are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - PLAN ADMINISTRATION

In addition to administrative tasks performed by the Trustee, certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.
