***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Infusion Associates 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets in liquidation as of October 29, 2024, the statement of net assets available for benefits as of December 31, 2023 (ongoing), and the related statement of changes in net assets in liquidation for the period from January 1, 2024 to October 29, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 29, 2024 and December 31, 2023, and for the period from January 1, 2024 to October 29, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Basis for Opinion***

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matters — Plan Termination and Liquidation Basis of Accounting***

As further discussed in Note 3 to the financial statements, the Plan Sponsor of the Plan approved a plan of liquidation on July 12, 2024 and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. As described in Note 7, pursuant to the Plan's termination, the net assets of the Plan were fully distributed as of October 29, 2024. Our opinion is not modified with respect to these matters.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. #### **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Infusion Associates 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a single-employer, defined contribution plan, which covers substantially all of the employees of Infusion Associates (the Company), excluding employees covered by a collective bargaining agreement. Employees are eligible to participate in the Plan on the date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan. Upon becoming eligible to participate in the Plan, they are automatically enrolled to defer 5% of pay. They may elect to change or discontinue deferrals at any time. Participants may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Company may, at its discretion, make additional profit-sharing contributions to the Plan on an annual basis. There were no profit-sharing contributions for the current Plan year.

The Company provides a match contribution of 100 percent of the first 3 percent and 50 percent of the following 2 percent of base compensation that a participant contributes to the Plan. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of (a) the applicable Company's contribution, and (b) Plan earnings and (c) is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, participant earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their voluntary and employer match and non-elective contributions plus actual earnings thereon. Participants are fully vested after 3 years of employment in discretionary contributions.

Payment of Benefits: The Plan provides benefits for eligible participants upon retirement, death, termination, or permanent disability according to the form of payment elected by the participant within the limitations defined in the Plan. Distributions shall be made in the form of a lump sum or in equal periodic installments. The Plan allows hardship withdrawals in accordance with Internal Revenue Service (IRS) regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes. The Plan allows in-service withdrawals for participants over the age of 59 ½. Upon the effective date of the Plan termination, July 12, 2024, all Plan participants became fully vested in their benefits.

Forfeitures: Forfeitures can be used to pay plan administrative expenses or reduce future employer contributions to the Plan. During the period ending October 29, 2024, there were no forfeitures used to reduce Plan expenditures. There were no forfeitures available as of October 29, 2024 and December 31, 2023.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), as established by the Financial Accounting Standards Board (“FASB”), and in conformity with the financial reporting requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”). Effective July 12, 2024 the Plan was terminated and Plan management determined that liquidation was imminent, therefore the basis of accounting was changed from the accrual basis of accounting for an ongoing plan as of December 31, 2023, to the liquidation basis of accounting as of October 29, 2024 and for the period from January 1, 2024 to October 29, 2024. Under the liquidation basis of accounting, assets are reported at estimated net realizable value and liabilities at estimated settlement amounts, including estimated liquidation costs, if reasonably determinable. There was no material impact to the Plan’s net assets as a result of the application of the liquidation basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan’s investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan’s principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan utilizes various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risk, including risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments disclosed in the accompanying financial statements, including investments held at October 29, 2024 and December 31, 2023, and net appreciation in fair value of investments for the period ended October 29, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Common/Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

Pooled Separate Accounts: The fair values of participation units held in pooled separate accounts are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. Each pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit.

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Transactions during the year with parties-in-interest include administrative services. Investment management fees are paid for by the Plan to investment managers who qualify as parties-in-interest, including Principal Life Insurance Company. Certain investments are managed by Principal Life Insurance Company; therefore, these transactions qualify as party-in-interest transactions. Fees of \$58,129 were paid by the Plan to the Plan's recordkeeper during the plan year for certain services related to the Plan. These investment management fees are reflected in the financial statements as a reduction of the return on the Plan's investments. Professional fees for the audit of the Plan and the majority of administrative fees of the Plan are paid for by the Company.

**NOTE 6 – TAX STATUS**

The IRS issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of October 29, 2024 and December 31, 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**NOTE 7 – PLAN TERMINATION**

On July 12, 2024, the Plan Sponsor executed an amendment to terminate the Infusion Associated 401(K) plan in connection with the sale of the Plan Sponsor to a strategic buyer. In accordance with the termination:

1. All participants became 100% vested in their account balances as of the termination date.
2. The final contributions to the Plan were made in July 2024. No further contributions were accepted after that date.
3. The Plan began the process of distributing all assets to participants and beneficiaries, with final distributions completed in October 2024.
4. Participants were provided with detailed information regarding their distribution options, including the ability to roll over their account balances to an Individual Retirement Account (IRA) or another qualified retirement plan.
5. The Plan administrator will file a final Form 5500 with the Department of Labor.

The Plan was fully terminated on October 29, 2024 following the completion of all required distributions and administrative processes. As of October 29, 2024, there are no remaining assets or obligations associated with the Plan.

**NOTE 8 – SUBSEQUENT EVENTS**

The Company has evaluated subsequent events and their related disclosures through August 15, 2025, the date the financial statements were available to be issued.
