Independent Auditors' Report

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kendall Packaging Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Kendall Packaging Corporation 401(k) Plan's internal control. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A | DESCRIPTION OF PLAN

The following description of the Kendall Packaging Corporation (Company) 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan was adopted January 1, 1990. It was amended and restated effective April 23, 2021, and is a profit sharing 401(k) plan under Section 401(k) of the Internal Revenue Code covering all eligible employees of the Company.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Administrative Expenses

The Company has elected to pay a portion of the Plan's administrative expenses, while the remainder of the expenses are paid by the Plan. Total administrative expenses paid by the Plan were \$66,626 and \$61,015 for the years ended December 31, 2024 and 2023, respectively.

3. Contributions

Each year, participants may contribute up to 100% of their compensation up to the limit prescribed by the Secretary of the Treasury, as defined in the Plan. Participants are permitted to designate a portion or all of their deferral contributions as Roth 401(k) contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Automatically enrolled participants have their deferral rate increased at a rate of 1% per year on January 1 up to a maximum of 15% of eligible compensation, unless otherwise elected by the participant.

For the plan year or any other contribution period, the Company, in its sole discretion, may make a matching contribution which will be allocated to eligible participants' matching contributions accounts. For the year ended December 31, 2023, the profit sharing match percentage was determined quarterly based upon the Company's pre-tax income for the previous quarter. During the year ended December 31, 2024, the Company changed to a match of 50% of the first 6% of participants' contributions. Total Company contributions were \$289,176 and \$71,854 for the years ended December 31, 2024 and 2023, respectively.

4. *Participant Accounts*

Each participant's account is credited with the participant's contribution, the Company matching contribution, and an allocation of Plan earnings. Plan earnings are allocated to each of the participants at the end of the day on the basis of the individual participant's balances at the beginning of the day as a percent of total participants' beginning balances. Forfeitures may be used to offset employer contributions to the Plan or used to offset Plan expenses. Forfeitures were \$19,880 and \$14,657, for the years ended December 31, 2024 and 2023, respectively. The Company offset employer contributions with forfeitures of \$24,050 and \$38,196 for the years ended December 31, 2024 and 2023, respectively. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's account.

5. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Interest rates range from 5.25 percent to 10.50 percent. Principal and interest are paid ratably through payroll deductions.

The Plan deems all participant notes receivable to be fully collectible; therefore, no allowance for uncollectible accounts is required. Participant notes receivable are treated as distributions when they are determined to be uncollectible.

6. Vesting

Vesting is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Amounts credited to a participant's salary deferral account and rollover account are 100 percent vested and non-forfeitable at all times.

7. Payment of Benefits

On termination of service, death, disability, or retirement, a participant may receive a lump sum amount equal to the value of the participant's interest in his or her account. Distributions may also be taken as installments or applied to the purchase of an annuity contract. A participant that terminates employment whose account balance is less than \$7,000 will receive a distribution of their account in the form of an IRA or annuity; if their account balance is less than \$1,000, they will receive the distribution in the form of lump sum cash without their consent. In-service withdrawals of all or a portion of the participant's vested account balance are also permitted upon the participant's attainment of age 59 ½. Under certain conditions participants may receive a hardship distribution.

8. Use of Estimates

Management uses estimates and assumptions in preparing financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

9. *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

10. *Income Tax Status*

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS), stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

11. *Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through August 7, 2025, which is the date the financial statements were available to be issued. No subsequent events were noted that required recognition or disclosure.

NOTE B | INVESTMENTS

All of the Plan's investments are participant directed and held by a trust company. Participants may direct their contributions into any of the investment options offered by the Plan. Investment option changes and transfers may be made by the participants on a daily basis.

NOTE C | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE D | FAIR VALUE MEASUREMENT

The Plan follows the fair value measurement guidance for financial assets and financial liabilities. The guidance defines fair value, establishes a framework for measuring value, and expands disclosure about fair value measurements. In addition, the guidance permits an entity to measure eligible financial instruments and other items at fair value. The Plan has not made any fair value elections.

Fair value is defined to be the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. A three-level hierarchy has been established for fair value measurements based upon the inputs to the valuation of an asset or liability as follows:

- Level 1 - Valuation is based on quoted prices for identical assets and liabilities in active markets.
- Level 2 - Valuation is derived from inputs, other than quoted prices included in Level 1, which are observable for the asset or liability either directly or indirectly. Investments classified as Level 2 are generally valued by benchmarking model-derived prices to quoted market prices and trade data for identical or comparable securities. The significant inputs used in this approach include interest rates, prepayment timing, yield spreads, maturities, credit losses, and credit ratings of the securities.
- Level 3 - Valuation is derived from unobservable inputs that are not corroborated by market data.

The fair value of mutual funds is equal to the net asset value of the funds multiplied by the number of shares held by the Plan, primarily using quoted market prices. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan invests in a collective trust, which provides for various investment options. Fair values of the collective trust are reported to the Plan based on the NAV of the units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

NOTE F | PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE G | CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividend income for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).
