Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Digital Check Corp. 401(k) Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) [“ERISA Section 103(a)(3)(C) audit”]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section:

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Digital Check Corp. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a qualified defined contribution plan covering employees of Digital Check Corp., Benchmark Technology Group, Inc, and Avivatech, LLC (collectively, "the Company"). The Plan covers all employees, excluding certain classes of employees as indicated in the Plan document, who have reached 18 years of age and who have completed 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may contribute up to the maximum dollar amount allowable as established by the Internal Revenue Service, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect another deferral rate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, subject to a 1% annual increase until the deferral rate percentage equals 6%. The Plan currently offers investment choices through Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan's investments, which include mutual funds through various registered investment companies, common collective trust funds, and a group annuity contract. The Company contributes an employer safe harbor contribution amounting to 3% of compensation of eligible participants. Employer profit-sharing contributions may be made at the discretion of the Company on behalf of each participant allocation group. The Company made or accrued safe harbor matching contributions of \$742,436 to the Plan for the year ended December 31, 2024. The Company made or accrued discretionary profit-sharing contributions of \$84,287 to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions; qualified rollover contributions; allocations of the Company's contributions, if any; and Plan earnings. It is also charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined in the Plan. Forfeited balances of terminated participants' nonvested accounts are treated based on the discretion of the Company. Forfeitures can be used to either reallocate as additional contributions, as reduction of employer contribution, or as payment of Plan expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. Vesting in discretionary profit-sharing contributions allocated to individual participants, plus actual earnings thereon, is based upon years of continual service as defined in the Plan. A participant is 100% vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1 to 5 years, or 20 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest ranging from 4.25% to 9.5% as of December 31, 2024. Principal and interest are paid ratably through regular payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or any other reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In addition, hardship withdrawals and in-service distributions are permitted if certain criteria are met. The plan document also requires post-severance mandatory force-out distributions for account balances under \$7,000.

Forfeited Accounts

The Plan maintains a non-vested forfeiture account. Forfeited balances of terminated participants' non-vested accounts may be used by the Company to pay Plan expenses or used to reduce future employer contributions. Forfeited non-vested accounts totaled \$982 and \$17,343 at December 31, 2024 and 2023, respectively. Forfeitures were used to reduce employer contributions by \$20,358 during the year ended December 31, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for loan losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the note receivable to be in default, the participant loan balance is reduced; and a benefit payment is recorded.

Excess Contributions

Amounts payable to participants for contributions made in excess of allowable amounts are recorded as a liability with a corresponding reduction to participant contributions. Excess contributions payable totaled \$9,158 as of December 31, 2023. The Plan refunded the excess contributions to participants in 2024.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included as a reduction in net appreciation of fair value of investments or as an addition in net depreciation of fair value of investments. The Plan made direct payments for administration fees of \$82,095 for the year ended December 31, 2024.

SECURE Act 2.0 Provisions

The Plan adopted certain Setting Every Community Up for Retirement Enhancement Act ("SECURE Act 2.0") provisions.

Updating Dollar Limit for Mandatory Distributions

Employers may transfer former employees' retirement accounts from a workplace retirement plan into an individual retirement plan (IRA) if their balances are between \$1,000 and \$7,000. The new provision increased the dollar limit from \$5,000 to \$7,000, effective for distributions made after December 31, 2023.

Increase in Age for Required Beginning Date for Mandatory Distributions

Participants are generally required to begin taking distributions from their retirement plans at age 72. The new provision increased the required minimum distribution age to 73 starting on January 1, 2023 – and increases the age further to 75 starting on January 1, 2033.

SECURE Act 2.0 Provisions (continued)

Roth Plan Required Minimum Distribution Rules

Under previous law, required minimum distributions are not required to begin prior to the death of the owner of a Roth IRA. However, pre-death distributions are required in the case of the owner of a Roth designated account in an employer retirement plan (e.g. 401(k) plan). The new provision eliminated the pre-death distribution requirement for Roth accounts in employer plans, effective for taxable years beginning after December 31, 2023. This provision does not apply to distributions which are required with respect to years beginning before January 1, 2024, but are permitted to be paid on or after such date.

Although no formal amendment has yet been made related to these provisions, the Plan sponsor intends to amend the Plan for the SECURE Act 2.0 provisions adopted prior to December 31, 2026.

Subsequent Events

Management has evaluated subsequent events through August 13, 2025, the date on which the financial statements were available to be issued. There were no subsequent events requiring recognition or disclosure in these financial statements, except as described in Note 10.

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification 820, *Fair Value Measurements and Disclosures* (“ASC 820”), provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include the following:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (“SEC”). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Units are valued using the NAV practical expedient of the common/collective trust (“CCT”) as reported by the CCT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The CCT may be redeemed at NAV daily without notice or restrictions and has no unfunded commitments. The Plan invests in separate funds with differing investment objectives within the Great Gray Collective Investment Trust.

NOTE 5 – GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan is invested in a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (“Empower”) totaling \$1,861,924 and \$1,771,853 at December 31, 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but will never be less than 0%. The actual average yield was 1.41% and 1.23% in 2024 and 2023, respectively. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan; and therefore, these transactions qualify as party-in-interest transactions under ERISA. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each investment.

As described in Note 2, the Company may pay certain administrative expenses related to Plan operations to various service providers. In addition, employees of the Company provide administrative services to the Plan for which no fees are charged. Notes receivable from participants also qualify as party-in-interest transactions under ERISA.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 8 – TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualified under Section 401(a) of the Internal Revenue Code (“IRC”). Although the Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since the prototype plan was adopted, the plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. No assets or liabilities relative to uncertain tax positions are recorded as of December 31, 2024 or 2023. The Plan is subject to routine audits by taxing jurisdictions. However, as of December 31, 2024, there were no audits in progress for any open tax periods.

NOTE 9 – RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment securities. Investment securities are exposed to various risks such as interest rate risk, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 – PLAN AMENDMENTS AND SUBSEQUENT EVENT

Effective June 10, 2024, the Plan was amended to allow in-service distributions upon the attainment of age 59 ½ instead of the attainment of normal retirement age as previously set forth in the Plan document.

Effective February 1, 2025, the Plan was amended to remove the restrictions on the number of loans a participant may have outstanding at any time.

NOTE 11 – PROHIBITED TRANSACTIONS

During the year ended December 31, 2022, the plan sponsor failed to deposit certain participant contributions within the required timeframe as stipulated by the U.S. Department of Labor ("DOL"). The DOL considers late deposits to be prohibited transactions as disclosed in the accompanying supplementary information. The plan sponsor has made voluntary corrections related to the 2022 late remittances to the Plan in 2023 and 2024.
