Qualified Opinion

We have audited the financial statements of Graphic Communications Union Local 17-M Pension Trust Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, except for the omission of the information described in the *Basis for Qualified Opinion* paragraph, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of October 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Qualified Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

The Plan's financial statements do not disclose the actuarial present value of accumulated benefits as of October 31, 2024 and 2023, and the changes in the actuarial present value of accumulated benefits for the years ended October 31, 2024 and 2023. Disclosure of this information is required by accounting principles generally accepted in the United States of America. The Plan administrator has not quantified the amount of, or change in, the Plan's accumulated plan benefits and, in the absence of an actuarial determination, these amounts and their effect on the financial statements are not reasonably determined.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Plan is being operated by Plan management under the supervision and funding of the Pension Benefit Guaranty Corporation ("PBGC"). The PBGC has the right to take over the payment of benefits and liquidate the Plan at its discretion; however, has not indicated an intent to do so. The financial statements are prepared assuming funding will continue. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, which raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1—Description of the Plan

The following brief description of the Graphic Communications Union Local 17-M Pension Trust Fund (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a defined benefit pension plan established for the members of a collective bargaining unit represented by the Graphic Communications Union Local 17-M (the "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective September 30, 2008, all employers elected to withdraw from the Plan and no longer participate. Under the rules and regulations of ERISA and the Pension Benefit Guarantee Corporation ("PBGC"), this mass withdrawal resulted in a technical termination of the Plan. In effect, this means the Plan is frozen except for the run out of benefit payments to those eligible in October 2008. The estimated mass withdrawal liabilities of each affected employer was calculated by the Plan's actuary based upon the unfunded vested benefits as of October 31, 2008. The rules and regulations required each employer to pay their mass withdrawal liability in a lump sum payment or in quarterly installments.

During 2016, the Plan applied for and received financial assistance from the PBGC to fund the benefits and operating expenses of the Plan. The Plan will therefore continue to collect PBGC and employer withdrawal payments, pay all administrative costs and administer the Plan according to the terms of the trust agreement. The PBGC can, at any time, discontinue paying the Plan and take over payment responsibilities if they determine this method of operation is more feasible. The Plan will cease to exist at the death of the last Plan participant.

Contributions – Since the mass withdrawal date, there have been no employer contributions other than the collection of the employer withdrawal liability. Employee contributions were not permitted.

Vesting – As of the mass withdrawal date, all participants became fully vested in their accumulated benefits earned under the Plan.

Retirement – Normal retirement is age 65, or the first day of any month following age 65. Early retirement is age 60 after completion of two years of credited service.

An employee's normal retirement benefit is equal to the sum of \$1.00 for each past service credit and \$2.25 for each current service credit. One past service credit was earned for each completed year of covered employment prior to November 1, 1971, with a maximum of 20 years.

An employee's early retirement benefit is determined the same as normal retirement but reduced by early retirement factors.

Form of Payment – The benefit formula provides for a life annuity benefit with a modified cash refund death benefit. However, each participant married at retirement who does not elect otherwise, will receive a joint annuity in a reduced amount providing for a 50% continuation to a surviving spouse.

Beneficiary Benefits – Participants eligible for early retirement benefits are eligible for a pre-retirement spouse's benefit equal to 50% of the joint annuity benefit, which the participant would have received upon early retirement or at the date of death automatically. If not currently eligible for early retirement, this benefit will be deferred to what would have been the earliest age at which the participant could have retired.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). The Accounting Standards Codification ("ASC") as produced by the Financial Accounting Standards Board is the sole source of authoritative U.S. GAAP.

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

Actuarial Present Value of Accumulated Plan Benefits – Accumulated plan benefits are those future periodic payments that are attributable under the Plan's provisions to the participants. Accumulated plan benefits include benefits expected to be paid to retired or terminated participants or their beneficiaries. Benefits under the Plan were based on various rates applicable to each participant's credited service.

The actuarial present value of accumulated plan benefits as presented in Note 3 was determined using PBGC regulations for terminating plans by Milliman, the Plan's actuary at October 31, 2020, and is that amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation as of October 31, 2020, were:

- Appendix B to Part 4044 for:
 - Discount rate - per 29 CFR Appendix B to Part 4044: 1.62% (first 20 years); 1.40% (after 20 years)
 - Mortality rates - per 29 CFR Appendix A to Part 4044: PBGC regulations for terminating plans
- Solvency projection basis - 3% investment return
- Retirement age to occur at age 65 for terminated employees

Payment of Benefits – Benefits are recorded when paid.

Subsequent Events – Subsequent events for the Plan have been considered through August 12, 2025, which represents the date the financial statements were available to be issued.

Recently Adopted Accounting Standards – Effective January 1, 2023, the Plan adopted accounting standards update ASU 2016-13, *Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments* ("FASB ASC 326"), which significantly changed how entities measure credit losses for most financial assets. The most significant change in the standard is a shift from the incurred loss methodology to an expected loss methodology. Financial assets held by the Plan that are subject to the guidance in FASB ASC 326 were employer withdrawal liability receivable. There was no material impact to the financial statements as a result of the adoption of ASU 2016-13.

Note 3—Actuarial present value of accumulated benefits

At the direction of the PBGC, Plan management is only required to obtain an actuarial calculation of the accumulated plan benefit obligation every five years. U.S. GAAP requires the presentation of this information yearly. The last valuation was completed for the year ended October 31, 2020. The year-to-year change in accumulated benefits is therefore omitted for the period October 31, 2021 through October 31, 2024.

Note 4—Fair value measurement

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at October 31, 2024 and 2023.

Pooled Separate Account – Valued at the net asset value ("NAV") of units held by the Plan at year-end provided by the issuer of the account. The NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying investment assets held through subaccounts of an insurance company. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV. PSAs are comprised, primarily, of cash equivalents and shares of mutual funds at October 31, 2024 and 2023, respectively. The investments are redeemable at the adjusted NAV on a daily basis under agreements with the insurance company. There are currently no redemption restrictions or unfunded commitments on these investments.

The preceding method described may produce a fair value measurement that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5—Employer withdrawal liability receivable

The Plan's actuary calculated each employer's share of the mass withdrawal liability receivable as of October 31, 2008, totaling \$1,129,865. Each employer was notified of their respective share of this liability and the terms of payment. Due to ERISA regulations, the quarterly payments due from the withdrawing employers was deemed insufficient to cover the related interest on the obligation. Therefore, withdrawing employer payments will continue for an indefinite period of time.

Note 5—Employer withdrawal liability receivable (continued)

After giving consideration to a variety of factors, including the number of employers, the state of the economy, and the period over which the payments are to be received, the trustees of the Plan have established an allowance for credit losses equal to 50% of the value of the recorded receivable. The allowance is evaluated on an annual basis and is considered to be a significant estimate since the actual amount collected, and the timing of collections are dependent upon the financial situation and longevity of the employers required to make payments to the Plan. It is at least reasonably possible that the amount of the allowance will change in the near term.

As of October 31, 2024 and 2023, the withdrawal liability receivable was calculated by the Plan's actuary and valued at \$95,000 and \$106,000, respectively, and the allowance for credit losses totaled \$47,500 and \$53,000, respectively. During each of the years ended October 31, 2024 and 2023, the Plan collected \$5,637 relating to the employer withdrawal liability receivable. The Plan expects to collect \$5,637 each year on the withdrawal liability.

During the years ended October 31, 2024 and 2023, the employer withdrawal liability receivable was revalued causing a decrease of \$(5,363) and \$(20,363), respectively, which is net of interest accretion. The primary cause of the revaluation is a change in discount rates used which were 4.97% and 5.06% for one employer and 5.39% and 4.52% for the other employer at October 31, 2024 and 2023, respectively.

Note 6—Related party and party in interest transactions

Plan investments include a pooled separate account managed by Aetna Life Insurance Company ("Aetna"). Aetna is the Custodian of the Plan and therefore these transactions qualify as party in interest. The Plan paid fees to Aetna totaling \$11,706 and \$10,404 during the Plan years ended October 31, 2024 and 2023, respectively.

The Plan is associated with the Graphic Communications Union Local 17M, the Plan Sponsor. Under an unwritten agreement, the Plan shares its office facilities with the Union office and pays its proportionate share of expenses. Rent expense was \$1,300 and \$1,200 for the years ended October 31, 2024 and 2023, respectively.

The Plan also paid \$8,533 and \$7,843 to the Plan Sponsor during the years ended October 31, 2024 and 2023, respectively, for clerical and bookkeeping services.

Note 7—Income tax status

The Internal Revenue Service ("IRS") has determined and informed the Plan Sponsor by a letter dated September 17, 2003, that the Plan and related trust, as then designed, are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax exempt.

U. S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8—Concentrations, risks, and uncertainties

Due to the level of risk associated with investments, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The employer withdrawal liability receivable is due from two companies in the graphics communication industry in Indiana. One of the companies represents approximately 90% of the total.
