***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Carrols Corporation Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of October 7, 2024 ("Date of Liquidation") and December 31, 2023, and the related statement of changes in net assets available for benefits for the period of January 1, 2024 through October 7, 2024 ("Date of Liquidation") and for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or Federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 7, 2024 ("Date of Liquidation") and December 31, 2023, and for the period of January 1, 2024 through October 7, 2024 ("Date of Liquidation"), and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

## ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the ***Auditor's Responsibilities for the Audits of the Financial Statements*** section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the ***Auditor's Responsibilities for the Audits of the Financial Statements*** section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Emphasis of Matter - Terminating Plan***

As further discussed in Note 1 to the financial statements, the Plan Administrator of Carrols Corporation Retirement Savings Plan chose to terminate the Plan on May 12, 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's

provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audits of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

## CARROLS CORPORATION RETIREMENT SAVINGS PLAN

### NOTES TO FINANCIAL STATEMENTS

#### Note 1 - Description of plan

The following description of the Carrols Corporation Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General - The Plan was a qualified defined-contribution plan under Section 401(a) of the Internal Revenue Code, with a Section 401(k) salary deferral provision. The Plan covered all eligible employees (as defined in the plan document) of Carrols Corporation and its related subsidiaries (collectively known as the “Company”). Eligible employees of the Company were eligible to participate in the Plan immediately upon their date of hire. There were no age requirements for participation. All assets acquired under the Plan were the result of employee and employer contributions thereto and all income and additions thereto were administered, distributed, forfeited or otherwise governed by the provisions of the Plan and the Employee Retirement Income Security Act of 1974 (ERISA).

Plan amendment and termination - The Company had the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants would become 100% vested in their account balances. During 2024, the Company was acquired by a third party. Due to this, the Trustee of the Plan elected to terminate the Plan effective May 12, 2024. All assets of the Plan were distributed through October 7, 2024 (“Date of Liquidation”). The Plan ceased operations at the end of business on October 7, 2024.

Plan provisions - The Plan implemented certain required provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), a law which, among others, extends the age for required minimum distributions to seventy-two.

Eligibility and contributions - Participants were allowed to make elective salary deferral contributions up to the maximum amount allowed by the Internal Revenue Code (IRC). Participants were also allowed to make rollover contributions to the Plan. The Plan contained provisions for Roth 401(k) contributions and after-tax contributions, which allowed a participant to elect that a portion or all of their elective salary deferral contributions be taxed at the time of deferral. Participants who met certain age requirements were allowed to make catch-up elective deferrals.

The Company could make discretionary matching contributions to the Plan as a percentage of participants’ elective salary deferral contributions, as determined annually by the Board of Directors of the Company. Discretionary matching contributions were \$0.75 on the dollar of each participant’s contribution, up to a maximum Company contribution of 3% of the participant’s deferred salary for the period ended October 7, 2024 and the year ended December 31, 2023. Total discretionary employer matching contributions were \$942,970, of which the Company used \$27,057 of forfeitures for the remainder; see below, for the period ended October 7, 2024. Total discretionary employer matching contributions were \$2,093,029, of which the Plan recorded a receivable of \$1,972,587 and the Company used \$120,442 of forfeitures for the remainder, for the year ended December 31, 2023.

Participant accounts - Each participant's account was credited with the participant's elective deferral contributions, the Company's discretionary contributions and plan earnings or losses, and charged with an allocation of administrative expenses. Allocations were based on participants' compensation or account balances, as defined by the plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. Participants could access their account information via Empower's website where they had the ability to change their elective deferrals and investment options, as well as apply for participant notes receivable and request distributions.

Investment options - Upon enrollment in the Plan, a participant could direct contributions in any of the investment options offered by the Plan. Participants could change their investment options online daily.

Vesting - Participants were immediately vested in their elective salary deferral contributions. Vesting in the Company's discretionary contributions plus actual earnings thereon were based on years of continuous service. A participant vested at a rate of 20% after one year of service and 20% each year thereafter, with full vesting upon completion of five years of service. In addition, a participant would be considered 100% vested in the Company's discretionary contributions if any of the following occurred prior to attaining five years of service: attainment of normal retirement age, death, and permanent and total disability. Upon the Plan's termination on May 12, 2024, all participants became immediately 100% vested in their account balances.

Forfeitures and non-vested accounts - Forfeited non vested accounts could be used to reduce future employer contributions to the Plan or could be used to pay administrative expenses in accordance with the governing plan document. The Company used forfeited non-vested accounts of \$27,057 and \$120,442 to reduce discretionary employer contributions for the period ended October 7, 2024 and for the year ended December 31, 2023, respectively. There were no unused forfeitures as of October 7, 2024. Unused forfeitures amounted to \$2,068 as of December 31, 2023.

Payment of benefits - Upon termination of service due to death, disability or retirement, a participant could elect to receive a lump-sum amount equal to the vested value of his or her account. Participants could also elect to rollover funds into another qualified plan or individual retirement account. Additionally, participants were permitted to make in-service withdrawals of account balances from the Plan. To qualify for this type of withdrawal, the participant must have attained the age of fifty-nine and one-half or must have met certain criteria for a hardship withdrawal, as outlined in the plan document.

Hardship withdrawals - A participant could apply for a hardship withdrawal to assist in the payment of several types of personal hardships as defined by the plan document. Any hardship distribution was limited to the amount necessary to meet the financial need.

Notes receivable from participants - Participants could borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, or the amount of elective deferral and rollovers in their account. The notes bore interest at a rate based on prevailing interest rates charged by financial institutions under similar terms at the date of issuance; however, the rate could be changed at the discretion of the plan administrator. The interest rate for loans ranged from 4.25% to 9.50%. The term of the repayment period could not exceed five years, except if the loan was used to acquire a residence, then the repayment period could be extended beyond

five years. Principal and interest were paid ratably through payroll deductions. All loan fees were paid by the participant initiating a loan. The notes were secured by the vested balance in the participant's account. According to requirements of the participant note program, the plan administrator would treat a note in default if any scheduled payment remained unpaid beyond ninety days.

#### Note 2 - Summary of accounting policies

Method of accounting - The Plan maintained its accounting records and financial statements on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Effective May 12, 2024, the Plan Administrator adopted a resolution to terminate the Plan. As a result, the Plan's financial statements as of October 7, 2024, and for the period January 1, 2024 through October 7, 2024 ("Date of Liquidation"), have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of the Plan is probable, and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realizable value and liabilities, if any, are stated at their anticipated settlement amounts.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of plan income and expenses during the reporting period. Actual results could differ from those estimates.

Economic dependency and concentration of credit risk - Approximately 39% of the Plan's investments were invested with Empower and PGIM, Inc. as of December 31, 2023. Accordingly, the Plan was dependent upon the financial condition of these entities.

Investment valuation and income recognition - Investments were stated at fair value (see Note 6), with the exception of the Guaranteed Income Fund investment, which was fully benefit-responsive and therefore valued at contract value and the pooled separate accounts, which were valued at net asset value ("NAV") a practical expedient as reported by Empower, the sponsor of the funds; see below. All investment values were determined and certified by Empower Annuity Insurance Company of America ("EAICA") and Empower Trust Company ("ETC"), the Trustees of the Plan (see Note 4). Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold, as well as held, during the period.

Pooled separate accounts invested primarily in equities, bonds, real estate, and mutual funds, which were mainly publicly traded securities. Pooled separate accounts were valued at NAV per share, which serves as a practical expedient to estimate their fair value. The NAV of each pooled separate account was not publicly quoted in the active markets. Each pooled separate account could be redeemed at NAV as of the measurement date and could be redeemed on a daily basis. There were no unfunded commitments or redemption restrictions on these investments as of October 7, 2024 and December 31, 2023. The investments measured at NAV per share used as a practical expedient were not required to be classified in the fair value hierarchy.

The Plan's investments in the pooled separate accounts included certain Empower select funds, premier funds and target date funds. The premier funds sought to achieve as high a total rate of real return on an annual basis as is considered consistent with prudent investment risk and the preservation of capital by investing in a diversified portfolio of investment grade fixed income and high yield debt and related securities. The select funds sought to achieve long-term growth of capital by investing primarily in equity securities. The target date funds sought total return through asset allocation, which is designed to become more conservative over time. As these funds approached and passed the target retirement date, the fund's objective shifted to seeking current income and some capital appreciation.

Notes receivable from participants - Notes receivable from participants were measured at their unpaid principal balance plus accrued but unpaid interest. Management individually reviewed all notes receivable balances that exceeded ninety days from the date of the most recent payment and based on the assessment of credit worthiness, estimated the portion, if any, of the balances that would not be collected. Currently, there is no valuation allowance recorded; however, management would record an allowance if and when potentially uncollectible notes receivable from participants became material. If a participant defaulted on a note receivable and distribution from the participant's account had been made during the plan year because the participant had left the Plan, the defaulted note receivable will be reported as benefits paid to participants on the statement of changes in net assets available for benefits and deducted from the receivable balance.

Payment of benefits - Benefits were recorded when paid.

Administrative costs - Administrative costs, including maintaining participants' accounts, legal costs, and accounting costs, were the obligation of the Plan; however, the Company could pay for such expenses or reimburse the Plan for any payment of these expenses. Costs of managing the investments were paid directly out of the Plan's assets (see Note 5).

Subsequent events - Management has evaluated subsequent events through August 10, 2025, the date that the financial statements were available for issue.

### Note 3 - Tax status of plan

The Internal Revenue Service had determined and informed the Plan that the "Prototype Non-Standardized Profit-Sharing Plan with CODA" is designed in accordance with applicable sections of the Internal Revenue Code. The Plan was amended since receiving the determination letter. The management of the Company and the plan administrator were not aware of any matters that would disqualify the Plan. Accordingly, the Plan had been accounted for as a tax-exempt plan.

The Plan had reviewed its operations for uncertain tax positions and believes there are no significant exposures. The Plan included penalties and interest on income tax liabilities in administrative expenses if such amounts had arose. The Plan did not incur any penalties and interest for the period ended October 7, 2024 or for the year ended December 31, 2023. The Plan is no longer subject to regulatory examinations by tax authorities for the closed years before 2021.

### Note 4 - Information certified by the Plan's Trustee

The plan administrator had elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and

Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held as of October 7, 2024 and December 31, 2023, and net appreciation in investments, interest and dividends, and interest received on notes receivable from participants for the period ended October 7, 2024 and for the year ended December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by EAICA and ETC, the Trustees of the Plan. Furthermore, the Plan's independent accountants did not perform auditing procedures with respect to the information except to compare such information to the related information included in the financial statements.

#### Note 5 - Party in interest transactions

The Plan's investments were managed by EAICA and ETC, the Trustees of the Plan. Fees paid for these services qualify as party-in-interest transactions and are included in the net appreciation of investments in the accompanying statement of changes in net assets available for benefits.

The Plan paid for certain expenses related to plan operations and investment advisory services to various service providers, which are party-in-interest transactions under ERISA and are included in administrative expenses on the accompanying statement of changes in net assets available for benefits as follows: the Plan contracted with EAICA to provide recordkeeping and third-party administrative services. Fees paid for these services amounted to \$350,058 and \$245,070 for the period ended October 7, 2024 and for the year ended December 31, 2023, respectively.

#### Note 6 - Fair value measurements

The Financial Accounting Standards Board has published authoritative guidance on fair value measurements, which establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described as follows:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's assets measured at fair value:

*Registered Investment Companies (i.e., Mutual Funds)* - The investment portfolios consist of mutual funds, which are valued at the closing price reported on the active market on which the individual security is traded (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used as of October 7, 2024, and December 31, 2024.

Note 7 - Fully benefit-responsive investment contract

The Plan held an investment in Empower's Guaranteed Income Fund, a fully benefit-responsive investment contract, which was reported in accordance with the Financial Accounting Standards Board's authoritative guidance regarding accounting for fully benefit-responsive investment contracts held by certain investment companies, which states that

contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Investments measured at contract value are not required to be classified in the fair value hierarchy.

The crediting interest rates of the contract were based on agreed upon formulas with the issuer, as defined in the contract agreements, but could not be less than 0%. Such interest rates were reviewed on a periodic basis for resetting. The key factors that influence future interest crediting rates could include the following: the level of market interest rates, the amount and timing of participant contributions, transfers and withdrawals into/out of the contract and the duration of the underlying investments backing the contract.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (iii) bankruptcy of the sponsor or other sponsor event (e.g., divestures or spin-offs of a subsidiary) that causes a significant withdrawal from the Plan; (iv) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA; or (v) premature termination of the contract. No events occurred that limited the ability of the Plan to transact at contract value with the contract issuer upon the termination of the contract and the Plan on October 7, 2024.

#### Note 8 - Reconciliation of the financial statements to Form 5500

Form 5500 may have certain investments balances, income and expense items that differ from amounts shown on the accompanying financial statements. These differences relate to classification and rounding only and have no effect on the net assets available for benefits as of October 7, 2024 and December 31, 2023, nor changes in net assets available for benefits for the period and year then ended, respectively.
