1. DESCRIPTION OF PLAN

The following description of the Ascent Solutions 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan documents for a more complete description of Plan provisions.

General

The Plan is a defined contribution profit sharing 401(k) plan sponsored by Ascent Solutions (Company) covering substantially all employees age 21 or older except for union employees, non-resident aliens, and residents of Puerto Rico. Employees with at least one month of service are eligible to participate in the 401(k) portion of the Plan. To participate in matching contributions, employees must be eligible to participate in the 401(k) plan. To participate in employer discretionary contributions, employees must be eligible to participate in the 401(k) plan and complete at least one year of service. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions

The Plan allows participant contributions up to 80% of pretax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer Contributions

The Company provides elective matching contributions for participant elective deferrals. Currently, the Company electively matches participant deferrals up to 50% of the first 4% of eligible compensation. The Plan offers twenty-three participant investment options. Additional employer discretionary contributions are determined annually by the Company's Compensation Committee within the Board of Directors. To be eligible for discretionary contributions, employees must have one year of service. No employer discretionary contributions were elected for 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, plan expenses, and net earnings or losses from the Plan. Plan net earnings and losses are allocated based on participant earnings or account balances, as defined. Employer discretionary contributions are allocated based on eligible compensation. Each participant is entitled to the benefit that can be provided from his or her vested account balance.

The Plan has allowed for the provisions of the CARES Act in regards to distributions, loans and required minimum distributions.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer matching contributions, forfeitures, and earnings thereon is based on years of credited service. Participants are 100% vested after four years of credited service. Participants whose employment commencement dates are prior to February 1, 2019 are 100% vested at all times.

Payment of Benefits

Upon termination of service, a participant with a non-forfeitable accrued benefit exceeding \$5,000 can elect to receive either a lump-sum amount equal to the participant's vested account balance or installments over a period of time not to exceed the participant's assumed life expectancy (or the participant's and their beneficiary's assumed life expectancies). If no election is made, the plan administrator may elect to distribute the balance in a lump sum to the participant. Prior to separation from service, a participant reaching age 59½ can elect to receive all or a portion of their vested account balance or defer payment until retirement.

Upon termination of service, participants with non-forfeitable accrued benefits between \$1,000 and \$5,000 can elect to receive a distribution in a lump sum or roll over the vested balance into another retirement plan. If no election is made, distributions will automatically roll over into a newly established individual retirement account.

Upon termination of service with non-forfeitable accrued benefits below \$1,000, participants receive a lump-sum distribution.

Forfeited Accounts

Forfeited non-vested amounts are used either to reduce employer contributions or plan expenses in the year following the Plan year the forfeiture occurs. Total forfeitures used to reduce plan expenses were \$14,000 and \$0 for the years ended December 31, 2024 or 2023, respectively. Forfeitures available to reduce future employer contributions or plan expenses totaled \$60,403 as of December 31, 2024.

Notes Receivable from Participants

Under terms of the Plan, participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the participant's balance, subject to regulations, and are due in a time period not to exceed 5 years, with interest at rates comparable to local prevailing rates. Principal and interest is paid ratably through payroll deductions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value using quoted market prices, if available. See Note 4 for further discussion of investment valuation inputs.

Purchases and sales of investments are recorded on a trade-date basis. Interest is recorded when earned. Dividends and contributions are recorded when received.

Gains and losses (realized and unrealized) are included in the statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased, sold, and held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income from notes receivable is recorded when earned. Delinquent notes receivable are reclassified as loans in default and are recorded as distributions at the time they are deemed uncollectible.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of participant loans and distributions, as well as investment transactions, are charged directly to the participant's account and are included in investment and administrative expenses.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

The Plan had investments totaling \$1,530,876 and \$2,299,356 that were concentrated in three and four funds, as of December 31, 2024 and 2023, respectively.

Mutual funds are valued at fair value using the daily closing prices as reported by the fund. Mutual funds held by the Plan are open ended mutual funds that are registered with the Securities and Exchange Commission.

Guaranteed Investment Contract

Guaranteed investment contracts are valued at contract value.

4. FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value based on a hierarchy that prioritizes valuation inputs as referenced below:

5. GUARANTEED INVESTMENT CONTRACT

The Plan invests in a benefit-responsive guaranteed investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Plan management believes that the occurrence of an event that would cause the Plan to transact at less than contract value is not probable. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Empower. Empower Trust Company, LLC is the trustee as defined by the Plan. Fees paid by the Plan to Empower for all accounting and investment management services qualify as party-in-interest transactions and totaled \$22,559 and \$23,109 for the years ended December 31, 2024 and 2023, respectively.

7. INCOME TAX STATUS

The Volume Submitter 401(k) Profit Sharing Plan adopted by the Company obtained its latest determination letter on November 14, 2022, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. ADMINISTRATION OF PLAN ASSETS

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

9. PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate participation in the Plan subject to provisions of ERISA. In the event of termination, participants become 100% vested in their accounts.
