INDEPENDENT AUDITOR'S REPORT

To the Investment Committee
Beltservice Corporation 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Beltservice Corporation 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Beltservice Corporation 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Beltservice Corporation 401(k) Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Beltservice Corporation 401(k) Profit Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Beltservice Corporation 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan was amended effective March 20, 2024 for purposes of eligibility to include members of Uniband USA, LLC.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. Beltservice Corporation, the Plan Sponsor, has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0.

General

The Plan is a defined contribution plan that was adopted effective August 1, 1972. Upon hire, the Plan immediately covers eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Contributions to the Plan are made by Beltservice Corporation (the "Company") on behalf of the participants based on specified compensation withholdings. Participants may elect to make contributions to the Plan up to 60% of total compensation not to exceed the applicable legal limit. The participants may designate a portion of their contribution as a Roth (post-tax) Contribution. Participants may also transfer funds to the Plan from other qualified retirement plans. Participants make all investment selections for their accounts. For eligible participants, the Company contributes a safe harbor match equal to 100% of each participant's elective deferral, up to 4% of compensation regardless of the amount contributed by the employee.

Additional Company matching contributions are determined by and at the sole discretion of the Company's Board of Directors each year. For the year ended December 31, 2024, no additional employer matching contributions were made to the Plan. Company discretionary profit-sharing contributions are allocated to each participant based upon the ratio of each participant's compensation to the total of all such participants' compensation. In order to share in Company profit sharing contributions for a year, a participant must work at least 1,000 hours during the Plan year and continue to be employed on the last day of that year.

Eligibility

An employee shall become a participant in the Plan on the first enrollment date on which the employee is in covered employment. Enrollment date means the first day of each calendar month of each Plan year. Employees are auto-enrolled on a pre-tax basis at 4% of eligible compensation as of the enrollment date, and their contributions will be automatically increased 1% each year up to 10% maximum.

Eligibility (continued)

Employees are eligible for Company profit sharing contributions once they have completed twelve consecutive months of service and 1,000 hours of service during the Plan year and must be employed as of the last day of the Plan year. Employees are automatically enrolled for Company profit sharing contributions upon meeting eligibility requirements.

Participant accounts

Each participant's account is credited with the participant's contributions and the Company's matching and discretionary contributions, allocation of Plan earnings, forfeitures of terminated participants' non-vested accounts which serve to partially reduce the Company's contributions, and investment gains and losses, and charged with administrative expenses as defined in the Plan document. The benefit to which each participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested at all times in their contributions, safe harbor matching employer contributions, and any earnings thereon.

Payment of benefits

Upon termination of service due to death, disability, retirement or other reasons as defined in the Plan document, a participant may elect to receive a distribution in the form of a lump sum payment or rollover into another qualified retirement plan. The Company may authorize certain withdrawals from a participant's salary reduction account(s) in the event of "proven financial hardship." Hardship withdrawals are subject to specific statutory and regulatory requirements.

Notes receivable from participants

Participants may borrow from their fund accounts an amount not to exceed the greater of 50% of their vested account balance or \$50,000. The amount and duration of the loan is subject to limitations defined in the Plan. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll withholdings.

Forfeitures

Forfeitures of terminated participants' non-vested account balances are used to reduce future Company contributions and pay administrative expenses. Forfeited nonvested accounts totaled \$454 and \$11,393 at December 31, 2024 and 2023, respectively. Forfeitures used totaled \$16,096 and \$46,512 during the Plan years ended December 31, 2024 and 2023, respectively.

Investment options

Participants of the Plan elect investment accounts in which their contributions are invested. Several investment account options are currently available, comprising various degrees of risk and return. All investment accounts are invested through Fidelity Management Trust Company ("Fidelity") the Plan's Trustee.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The reported value of the common collective trust fund is at the Net Asset Value ("NAV"). The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Investment valuation and income recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

The common collective trust fund investment (the "Fidelity Managed Income Portfolio II" or "MIP") is comprised of public investment securities valued at NAV, and a participant's ownership of the MIP is represented by units. Units are issued and redeemed daily at the MIP's constant NAV of \$1 per unit. The MIP allows for daily liquidity with no additional notice required for redemption. Although it is the policy of the MIP to use its best efforts to maintain a stable NAV of \$1 per unit, there is no guarantee that the MIP will be able to maintain that value. See Note 5 for discussion of investments measured at NAV.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Certain costs of administering the Plan were paid by the Plan, while other expenses were borne by the Company and are not reflected in the accompanying financial statements. Investment related expenses are included in net appreciation in fair value of investments on the statements of changes in net assets available for benefits.

Use of estimates in financial statement presentation

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator and management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent events

The Plan has evaluated all subsequent events through August 13, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from Fidelity as of December 31, 2024 and 2023, and for the years ended, that all of the amounts related to investment balances, notes receivable from participants, net appreciation in fair value of investments, dividends, and interest on notes receivable from participants provided by Fidelity and included in the accompanying financial statements and supplemental schedule are complete and accurate.

Information as to the investments in the accounts of Fidelity, investment income activity, and all notes receivable from participants and interest earned thereon appearing in the accompanying financial statements and supplemental schedule is presented in reliance solely upon the certifications.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust – Valued at the NAV of the units held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

6. PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. INCOME TAX STATUS

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code ("IRC") Section 401(a). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

9. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are mutual funds and units of a collective trust managed by Fidelity. Fidelity is the Trustee and Recordkeeper of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services totaled \$24,044 and \$17,482 for the years ended December 31, 2024 and 2023, respectively.
