Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audits of the accompanying financial statements of Delta Dental of Oklahoma 401(K) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF PLAN

The following description of the Delta Dental of Oklahoma 401(K) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan covering employees of Delta Dental Plan of Oklahoma, Inc., Delta Dental of Oklahoma Foundation and Delta Dental of Oklahoma Dental Practice Support, Inc. (The Company). Employees are eligible to make salary deferrals to the Plan on the first day of the month coinciding with or following the date the individual attains age 18 and completes two months of service. Employees are eligible to receive safe harbor and discretionary profit-sharing contributions on the next entrance date coinciding with or following the date the individual attains age 18 and completes one year of service. If no election is made by the employee, automatic salary deferrals are initially set up at 1% of eligible compensation. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator of the Company is responsible for the oversight of the Plan.

B. Contributions

Participants may make voluntary contributions to the Plan up to Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts distributed from other qualified plans.

The Company makes safe harbor contributions equal to 3% of the participants’ compensation. The Company may also, at its sole discretion, make discretionary profit-sharing contributions to the Plan. There were discretionary profit-sharing contributions of \$884,690 made to the Plan for the year ended December 31, 2024.

C. Participant accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Earnings and losses are allocated by fund based on the ratio of a participant’s account invested in a particular fund to all participants’ investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

D. Vesting

Participants are vested immediately in their own contributions and the Company’s safe harbor contributions, plus actual earnings thereon. Vesting in the Company’s profit-sharing contributions, plus actual earnings thereon, is based on each participant’s years of continuous service on a six-year graded vesting schedule. A participant is 100% vested after six years of credited service or when the participant attains the normal retirement age of 62. A participant is also fully vested in their entire account upon the earliest occurrence of death, total and permanent disability and early retirement date, or plan termination.

E. Forfeitures

Amounts forfeited by reason of termination or severance of employment prior to full vesting are used to fund Company contributions or to pay plan expenses. During 2024, \$16,280 of forfeitures were utilized to fund Company contributions or pay plan expenses. There were unallocated forfeitures of \$15,305 and \$16,267 at December 31, 2024 and 2023, respectively.

F. Investment options

Upon enrollment in the Plan, a participant may direct contributions into a variety of investment options. All funds vary in rates of return and investment risk and are described in more detail in the Plan's literature. Participants may elect, on a daily basis, to have all or part of their account balances and future contributions transferred from one fund to another or in any combination.

G. Notes receivable from participants

Participants are allowed to borrow up to the lesser of half of their vested account balance or \$50,000, subject to a minimum loan of \$1,000. The loan is secured by the balance in the participant's account and bears interest based upon market rates. The maximum term for repayment is five years. The Plan has a provision allowing repayment over 10 years if the loan is used to purchase a home as a principal residence of the participant. Principal and interest are paid ratably through payroll deductions.

H. Payment of benefits

On termination of service, if the participant's account balance is less than \$7,000, the Plan will distribute that portion in a lump sum, subject to the automatic rollover provisions, as defined, as soon as administratively practicable. If the participant's vested account balance is greater than \$7,000, the participant may elect to receive distribution either in a lump sum or in installments over a specified period of time. The Plan also allows in-service distributions when certain requirements defined in the Plan document are met by participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

B. Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment valuation and income recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are recorded at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Notes receivable from participants have been classified as an investment asset for Form 5500, Annual Return/Report of Employee Benefit Plan, reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

E. Payment of benefits

Benefit payments to participants are recorded when paid.

F. Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of the Plan or associated with the investment of Plan assets may be paid by the Plan or by the Company. Fees related to participant requested services are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses.

G. Implemented Provisions

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. During 2024, the Plan implemented provision 304 Updating dollar limit for mandatory distributions.

H. Subsequent events

The Plan’s management has evaluated subsequent events through the date the financial statements were available to be issued.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 (“SECURE 2.0”) was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of the provisions within SECURE 2.0 vary through 2026. Management has elected to adopt certain provisions of SECURE 2.0 with an effective date of January 1, 2025.

3. INFORMATION CERTIFIED OR PROVIDED BY THE CUSTODIAN

The following is a summary of the Plan’s asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and ERISA-required supplemental schedule, which was prepared by or derived from information provided by Standard Insurance Company, the Plan’s custodian, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Plan’s custodian that the information provided to the Plan Administrator by the Plan’s custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and ERISA-required supplemental schedule related to the following assets:

4. FAIR VALUE MEASUREMENTS

Accounting standards establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts

Value is based on net asset value (NAV), as reported by the custodian of the pooled separate accounts. NAV is used as a practical expedient and is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, which is deducted prior to setting the daily unit value. Each of the pooled separate accounts invests either in multiple securities or in single mutual funds, which are generally identified in the name of the pooled separate account and is derived based on the closing prices of the underlying securities.

In accordance with FASB Accounting Standards Codification Subtopic 820-10, the pooled separate accounts held by the Plan are not classified in the fair value hierarchy table that prioritizes the inputs to valuation techniques used to measure fair value because they are measured at NAV per share.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits for the year ending December 31, 2024.

6. FIXED INTEREST ACCOUNT

The Plan has invested in the Standard Stable Value A Fund. The fund is credited with interest earned based on the stated interest rates over the life of the contract. Withdrawals can be made at any time for the purpose of participant withdrawals or benefit payments at contract value. The Standard Stable Value A Fund is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract is included in the financial statements at contract value, as it is fully benefit-responsive.

6. FIXED INTEREST ACCOUNT (Cont'd)

Contract value represents contributions made under the contract, plus earnings, less any participant withdrawals or benefit payments. There are no reserves against contract value for credit risk of the Standard Stable Value A Fund or otherwise. The average yield based on actual earnings and based on the interest rate credited to participants was 2.43% for the year ended December 31, 2024.

The Plan's ability to receive amounts due in accordance with a fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including a complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs or a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contracts. The Plan Administrator does not believe that any events that would limit the ability of the Plan to transact at contract value with the issuer's contract that would also limit the contract or the ability of the Plan to transact at contract value with participants are probable to occur.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of a material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor's regulations as any fiduciary to the Plan or party rendering services to the Plan, the Company and certain others. As such, transactions conducted with the Company and Standard Insurance Company, the custodian, qualify as party-in-interest transactions.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

9. INCOME TAX STATUS

The Plan has adopted a non-standardized pre-approved plan sponsored by Standard Retirement Services, Inc. Standard Retirement Services, Inc. has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

9. INCOME TAX STATUS (Cont'd)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
