To the Plan Administrator of
GPI Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of the GPI Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance; and therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audits.

Other Matter

Supplemental Schedules Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024 and Schedule of Delinquent Participant Contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. DESCRIPTION OF PLAN

The following description of the GPI Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Graphic Packaging International, LLC (the Company). Full-time salaried and non-union hourly employees are eligible to participate in the Plan effective on the first day of employment or re-employment if previously an eligible employee. The Plan excludes non-union hourly employees, who are eligible to participate in the GPI Hourly Savings Plan (for represented employees). If the employee is a covered employee, such employee is eligible to participate in the Plan after completing at least 1,000 hours and one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 22, 2024, the Bell Incorporated Employee Savings Plan was merged into the Plan. The merger is reflected in the statement of changes in net assets available for benefits.

Contributions

Each year, participants may contribute up to 75% of their 401(k) eligible compensation in pretax, Roth after-tax, or a combination of both contributions to the Plan. Any participant who is age 50 by the end of the Plan year may contribute additional "catch-up" contributions. Participants may make Roth after-tax contributions and Roth after-tax "catch-up" contributions to the Plan in lieu of all or a portion of the pretax contributions the participant could otherwise contribute to the Plan.

However, Roth after-tax contributions and Roth after-tax "catch-up" contributions are included in the participant's gross income at the time of deferral and are subject to income tax. Participants may also contribute in the form of a direct rollover, amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants hired on or after January 1, 2009, are automatically enrolled into the Plan and an employee 401(k) deferral contribution of 3% of the participant's eligible compensation is automatically deducted from their compensation and deposited into the Plan on the participant's behalf unless the participant elects otherwise. Participants hired on or after January 1, 2018, are automatically enrolled into the Plan at a deferral percentage of 5% of the participant's eligible compensation unless the participant elects otherwise.

The Company Safe Harbor matching contribution is 100% of the participant's contribution up to 4% of eligible compensation and 50% of the next 3% of eligible compensation.

A Supplemental Employer Contribution will be made by the Company each year in the amount of 3% of eligible compensation on behalf of those participants who are not eligible for the Company's pension plans. Contributions are subject to certain limits. Effective January 1, 2023, the Plan was amended to provide for immediate eligibility for participants to receive the Supplemental Employer Contributions and to provide that participants who complete an hour of service on or after January 1, 2023, will be fully vested in the Supplemental Employer Contributions after completing one year of service. Prior to January 1, 2023, newly hired participants were required to complete

one year of vesting service before they became eligible to receive the Supplemental Employer Contribution. The Supplemental Employer Contribution is contributed annually after the close of the Plan year. To be eligible to receive the Supplemental Employer Contribution, the employee must be on payroll at year end. Exceptions to this are in the case of an active employee's death, termination due to disability or involuntary termination without cause. In these instances, the contribution will be calculated and made at the time of the event. For employees who terminate during the year but are at least age 55, and their age plus service is greater or equal to 65, a contribution will be made to their account after the close of the year. For the year ended December 31, 2024, the total Supplemental Employer Contribution was \$22,560,923. The Supplemental Employer Contribution is reflected within employer contributions receivable within the statements of net assets available for benefits as of December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contribution, and Plan earnings or losses. Participant accounts are charged with withdrawals and investment fees which are netted against the revenue allocated to them and certain loan and distribution fees. Allocations are based on participant earnings, participant contributions or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, safe harbor matching and rollover contributions plus actual earnings thereon. Vesting in the participant's Supplemental Employer Contribution portion of the participant's account is based on the vesting schedule noted above.

Effective April 30, 2024, each participant in the Plan who was actively employed at the Augusta Mill Factory as of the closing of the sale of the facility or who was on an approved leave of absence as of the closing of the sale of the facility was fully vested in his/her account.

Notes Receivable from Participants

Participants may borrow from their accounts in amounts equal to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The Plan prohibits loans from being made out of the participant's Supplemental Employer Contribution portion of the participant's account. The loans are secured by the balance in the participant's account and bear varying rates of interest, which are commensurate with local prevailing rates as determined by the Plan administrator. The loans can have up to a maximum term of 57 months, unless the loan is to be used in conjunction with a purchase of a principal residence, and in that case, the loan can have a maximum term of 25 years. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

A participant, or their beneficiary, is entitled to a distribution of 100% of his or her account balance upon retirement, death, or disability. Upon termination of service for any other reason or if the participant has attained the age of 59¹/₂, the participant may elect to receive the value of the vested portion of their account either as a lump-sum amount or in the form of installment payments. A participant may take a distribution in the event of financial hardship if all requirements are met as specified by the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan. Effective January 2020, the Plan adopted a fixed fee expense structure in which participants are charged a flat fee which is directly applied to the participant's account. The balance in the payment account as of December 31, 2024 and 2023, is \$221,632 and \$119,020, respectively. In addition, the Plan also maintains a revenue credit program account (RCP) with Fidelity. The balance in this account is utilized to pay Plan expenses. As of December 31, 2024 and 2023, the balance in this account totaled \$66,307 and \$83,728, respectively. For the year ended December 31, 2024, \$21,960 earned within the RCP was utilized to pay Plan expenses.

Forfeited Accounts

For the Plan year ended December 31, 2024, forfeitures of \$330,095 were used to reduce employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$72,223 and \$6,884, respectively. These accounts are available to reduce future employer contributions to the Plan or to pay the Plan's administrative expenses.

Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company, by a letter dated November 4, 2015, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. The Plan has been amended subsequent to receipt of the determination letter. However, the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and that the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America (GAAP) requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principles and policies which significantly affect the determination of net assets available for Plan benefits and results of operations are summarized below.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with GAAP.

Investment Valuation and Income Recognition

Investments in the GPI Savings Plan Master Trust (the Master Trust), in which the Plan is funded, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in its statement of changes in net assets available for benefits an allocation of the Master Trust's net gain which consists of net appreciation and interest and dividend income.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties

The Master Trust invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. It is at least reasonably possible that a significant change may occur in the near term for the estimates of investment valuation.

Payment of Benefits

Benefits are recorded when paid.

3. INTEREST IN GPI SAVINGS PLANS' MASTER TRUST

The Plan's investments are held in the Master Trust which was established for the investment of assets of the Plan and certain assets of another company sponsored retirement plan. The plans participating in the Master Trust collectively own, through the Master Trust, the assets based upon investment percentages. Participant transaction activity is designated to specific plans. Accordingly, each plan's investment percentage in the Master Trust changes regularly. Income/loss earned by the Master Trust is allocated to the various plans based upon the investment percentage on the day the income is earned. At December 31, 2024 and 2023, the Plan's interest in the net assets of the Master Trust was approximately 70% and 69%, respectively. Net investment income/loss relating to the Master Trust is allocated to the individual plans based on: (1) whether it is related to a specific plan (100% allocation to that plan), or (2) the Plan's proportionate share of the income/loss which is attributable to the Master Trust.

4. FAIR VALUE MEASUREMENT

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, defines fair value, establishes a framework for measuring fair value and requires additional disclosures about the use of fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.
- Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are observable as of the reporting date. These inputs include quoted prices for similar assets in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Graphic Packaging Stock Fund: The Graphic Packaging Stock Fund consists primarily of shares of the Company's common stock. The underlying common stock is valued at the last reported sales price at the end of the year or, if there were no sales that day, the last reported bid price. Effective January 1, 2004, no additional shares of Company stock may be purchased through the Plan.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Master Trust are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Master Trust are deemed to be actively traded.

Common Collective Trust Funds: Valued at the NAV of units held by the Master Trust at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner. As of December 31, 2024 and 2023, there are no unfunded commitments or redemption restrictions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by the trustee of the Plan, and as such, qualify as party-in-interest investments. The Plan holds shares of Graphic Packaging, Inc. common stock and recognized net appreciation of \$751,006 from its investment in the Company's common stock. Additionally, the Plan holds party-in-interest investments in the form of notes receivable from participants. Fees paid by the Plan to the record keeper, Fidelity Workplace Services, LLC, for the administration of the Plan amounted to \$417,718 as of December 31, 2024. In addition, fees were paid by the Plan for audit fees and also investment advisory fees.

7. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

In accordance with GAAP, the financial statements do not reflect deemed distributions of loans in default without post default payments, while Schedule H of Form 5500 reflects these as distributions. 8. PROHIBITED TRANSACTIONS

During 2024, the Company determined that certain amounts of participant deferrals were not remitted to the Plan in accordance with the DOL's rules regarding the timeliness of depositing such employee contributions, representing a nonexempt loan of funds to the Company from the Plan. During 2025, the Company took remedial actions to correct the matter and remit lost earnings on delinquent contributions. The lost earnings were not material to the financial statements.
