Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Children's Council of San Francisco 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statements of Changes in Net Assets Available for Benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Children's Council of San Francisco 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Children's Council of San Francisco 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Children's Council of San Francisco 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Children's Council of San Francisco 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

1. Description of Plan

The following brief description of Children's Council of San Francisco 401(k) Profit Sharing Plan ("the Plan") is provided for general information purposes only. Participants should refer to the Plan's agreement for a more complete description of the Plan's provisions.

General

The Plan, as restated and amended, is a defined contribution savings plan intended to qualify under Section 401(a) and related provisions of the Internal Revenue Code. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination, or financial hardship. The Plan covers all employees of Children's Council of San Francisco ("Children's Council") who meet certain eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), and subsequent laws.

Plan Administration

Children's Council is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. Children's Council has delegated certain responsibilities for the operation and administration of the Plan. Trustee and recordkeeping services were provided by Voya Retirement Insurance and Annuity Company ("Voya"). Certain administrative expenses of the Plan, including recordkeeping and auditing costs, were paid directly by Children's Council for the years ended December 31, 2024 and 2023. Investment fees, which may vary according to the individual funds selected, and loan fees are paid out of the assets of the Plan. Participants should refer to the prospectus of the individual investment funds for further details on individual investment fees.

Eligibility

Employees become eligible to make deferral contributions to the Plan on the first day of the month after completing one hour of service as defined in the Plan. In addition, employees become eligible for matching contributions to the Plan on the payroll period after completing one hour of service as defined in the Plan. Employees covered under the Plan include all employees except nonresident aliens.

Contributions

Each year participants may contribute a fixed dollar amount or any whole percentage up to the maximum determined by the Internal Revenue Service from their eligible compensation as defined in the Plan. In addition, participants qualifying for age-based provisions may make additional catch-up deferrals. Participants are also allowed to roll over contributions from other qualified employer-sponsored retirement plans. All contributions are paid to the trustee for investment in the appropriate investment fund or portfolio in accordance with the participant's directives and the terms of the Plan.

1. Description of Plan, continued

Participants may make either or both of the following types of contributions to the Plan:

- Before tax contributions - deducted from salary before federal income tax is imposed
- Designated Roth contributions - deducted from salary after federal income tax is imposed

Annually, Children's Council will determine the discretionary matching contribution. During the year, Children's Council matches up to 8.5% of compensation that a participant contributes to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution or rollovers and the allocation of Children's Council's contribution and the Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earning thereon. Vesting in the Plan's contribution portion of their accounts is based on years of continuous service. A year of credited service is defined by the Plan as 1,000 hours worked in a calendar year. The following is a tier schedule, representing vesting percentages based on years of service.

- 50% vesting after 1 year of service
- 75% vesting after 2 years of service
- 100% vesting after 3 years of service

Notes Receivable from Participants

Participants may borrow up to 50% from their vested account balance to a maximum loan of \$50,000. The minimum loan is \$1,000. The maximum loan term is five years unless used for the purchase of a principal residence. The loans are secured by the balance in the participant's account representing an amount equal to 100% of the loan balance and bears interest rates that commensurate with local prevailing rates. Principal and interest are paid ratably through bi-weekly payroll deductions.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered by the trustee. Participants may change their investment options at any time.

Forfeitures

Forfeitures of matching contributions are applied to reduce employer matching contributions. There were no balances in forfeited non-vested accounts at December 31, 2024 and 2023, respectively. Amounts of forfeitures used to reduce employer matching contributions were \$22,934 and \$8,766 at December 31, 2024 and 2023, respectively.

Plan Loans

The Plan allows for loans to participants. Participants may borrow from the Plan using a portion of their plan account as collateral for the loan. Plan loans are not treated as a distribution from the Plan and are not considered plan assets. Therefore, plan loans are not reported on the statements of net assets available for benefits. A participant may apply for a plan loan to be made from his or her vested account balance in the Plan not to exceed the lesser of 50% of the participant's vested account balance or \$50,000 and must be for at least \$1,000. All loans are to be paid back over a period not to exceed five years, excluding loans to acquire the participant's principal residence, which may permit a longer repayment term.

Participants will be charged a commercially reasonable rate of interest established by the Plan Administrator. Principal and interest are paid by the participant through payroll deductions.

The plan administrator has concluded that these loans are not plan assets, and that such arrangements are party-in-interest transactions for which a statutory exemption exists. The balances of outstanding loans as of December 31, 2024 was \$118,088.

Payment of Benefit

Distribution and withdrawals are payable upon retirement, termination, financial hardship, disability, or death. If a participant's account balance is equal to or less than \$1,000, the balance is distributed immediately in a lump-sum cash payment. If the account balance is over \$1,000, the participant can consent to either; a lump-sum cash payment, a direct rollover into another qualified plan, installment payments over a period not longer than life expectancy, or postpone payment to a later date and remain in the Plan as described in the plan documents.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements is as follows:

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's (losses) and gains on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants on the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and are recorded at their unpaid balance. Interest income on notes receivable from participants is recorded when it is earned, and the related fees are recorded as administrative expenses and expensed when incurred.

Payment of Benefits

Benefits are recorded when paid.

Fair Value Measurements

Generally accepted accounting principles provide guidance on how fair value should be determined when financial statement elements are required to be measured at fair value. Valuation techniques are ranked in three levels depending on the degree of objectivity of the inputs used with each level:

Level 1 inputs - quoted prices in active markets for identical assets

Level 2 inputs - quoted prices in active or inactive markets for the same or similar assets

Level 3 inputs - estimates using the best information available when there is little or no market

The Plan is required to measure investments at fair value. The specific techniques used to measure fair value for the financial statement element is described in the notes below that relate to the element.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures as of the date and for the period presented. Actual results could differ from those estimates.

Administrative Expenses

Children's Council may pay some plan administration expenses with its own assets rather than use plan assets. To the extent Children's Council does not pay plan expenses with its own assets, the Plan generally will pay the expenses of plan administration and will assess the expenses paid against the accounts of all participants in the Plan. Children's Council may, from time to time, change the manner in which expenses are allocated. During the years ended December 31, 2024 and 2023, total administrative charges were \$53,232 and \$41,772, respectively.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the Statements of Net Assets Available for Benefits.

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across various asset classes and the utilization of investment managers.

Reclassifications

Certain amounts have been reclassified for the year ended December 31, 2023 to conform to the presentation for the year ended December 31, 2024.

Subsequent Events

Management has evaluated subsequent events through August 4, 2025, the date which the financial statements were available for issue. No events or transactions have occurred during this period that appear to require recognition or disclosure in the financial statements.

3. Notes Receivable from Participants

Notes receivable from participants are repaid bi-weekly at varying interest rates. Notes receivable from participants outstanding at December 31, 2024 and 2023, totaled \$118,088 and \$45,032, respectively.

During the years ended December 31, 2024 and 2023, the Plan's investments (including investments bought, sold, and held during the years) appreciated in value by \$1,772,673 and \$1,706,669, respectively.

6. Related Party and Party-in-Interest Transactions

ERISA defines parties-in-interest more broadly than generally accepted accounting principles' related parties, encompassing all service providers to the Plan. Management identified no related parties that were not also parties-in-interest, and no material related party transactions occurred during the Plan year regarding compensation arrangements, expense allowances, or similar items.

Parties-in-interest transactions include those with Plan fiduciaries or employees, service providers, employers with covered employees, employee organizations with covered members, and persons owning 50% or more of such employers or employee associations, along with their relatives. Trustee transactions, including revenue sharing and fee offset agreements, as well as the Plan's payment of certain plan fees and expenses, qualify as parties-in-interest transactions. Administrative fees paid by the Plan to the trustee were \$53,232.

The Plan's investment options include funds managed by Voya or its affiliates. As custodian and recordkeeper, Voya's transactions qualify as exempt parties-in-interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, Children's Council has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. Tax Status

The Plan has adopted a prototype standardized profit-sharing plan sponsored by Mutual of America. The Internal Revenue Service ("IRS") informed Mutual of America by a letter dated November 6, 2001, that its volume submitter plan was designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The organization believes that the Plan is designed and is currently being operated in accordance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
