INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cayuga Medical Center Retirement Savings Plan (DC1), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of October 1, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the periods then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cayuga Medical Center Retirement Savings Plan (DC1)'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the periods ended October 1, 2024 and December 31, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

- The information in the financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cayuga Medical Center Retirement Savings Plan (DC1) and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Cayuga Medical Center Retirement Savings Plan (DC1)'s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTES TO FINANCIAL STATEMENTS
PERIODS ENDED OCTOBER 1, 2024 AND DECEMBER 31, 2023**

A. DESCRIPTION OF PLAN:

The following description of the Cayuga Medical Center Retirement Savings Plan (DC1) ("the Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Cayuga Medical Center at Ithaca, Inc. ("the Medical Center") hired before December 19, 2021. Employees hired before January 1, 2022 are eligible to contribute immediately and are immediately eligible for Medical Center match contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As of June 13, 2014, the Medical Center is 100% owned by Cayuga Health System, Inc., and is part of a controlled group, as defined by the IRS.

Merger

On September 30, 2024, the Board of Directors of Cayuga Health System, Inc., the plan sponsor, approved the merger of this plan into the Cayuga Medical Center 403(b) Plan (DC2), effective as of October 1, 2024. As a result, all investments were transferred from the Plan into the DC2 Plan by October 22, 2024.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan ("salary reduction contributions"). Effective February 15, 2024, participants are also permitted to make Roth contributions. Additionally, if a participant has or is projected to attain age 50 before the end of the Plan year, that participant may make "catch-up" contributions as determined by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans, as defined in the Plan document. The Medical Center has elected to make an employer matching contribution on a bi-weekly basis equal to 50% of the first 4% of each participant's pre-tax salary deferral contributions up to a maximum of 2% of the participant's salary. Contributions are subject to limitations determined by the Internal Revenue Service.

Participant Accounts

Each participant's account is credited with the elective deferral contribution, the employer matching contribution, as well as an allocation of Plan earnings and losses. Administrative fees are charged as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Medical Center's contribution portion of their accounts is based on years of continuous service, as follows:

<u>Years of Service</u>	<u>Percent Vested</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 with the maximum amount being the lesser of 50% of the vested account balance or \$50,000 reduced by the highest outstanding loan balance at any time in the preceding year. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the Prime Rate, as stated in the Wall Street Journal, plus 1%. Principal and interest are paid ratably over a period not to exceed five years (unless the loan is for purchase of a primary residence).

Payment of Benefits

Upon termination of service for any reason, a participant may elect to receive cash distributions in the form of a lump-sum, equal to the value in the participant's vested interest in his or her account, or an annuity or a series of installments chosen by the participant. The Plan may make involuntary cash-out distributions of account balances of terminated vested participants of \$1,000 or less. Amounts that are above \$1,000 but are not more than \$5,000 are subject to the applicable automatic rollover requirements of the Internal Revenue Code. The Plan also allows for withdrawals to participants who have attained age 65 or incurred a hardship, as determined by the Plan document.

Forfeitures

Forfeited non-vested accounts are retained by the Plan and may be used to offset Plan expenses or reduce employer contributions made to the Plan. At October 1, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$24,109, respectively. Forfeitures of \$3,443 and \$79,072 were used to reduce employer contributions or cover plan expenses in 2024 and 2023, respectively. The balance of \$75,927 was transferred to the DC2 Plan.

Expense Budget Account

The costs associated with administering the Plan are partially covered by an expense budget account. This account is fed by revenue from investment managers and Plan expenses are then paid out of this account. The balance in the expense budget account at October 1, 2024 and December 31, 2023, totaled \$0 and \$33,586, respectively. Amounts of \$120,484 and \$100,573 were used from the expense budget account to pay Plan expenses in 2024 and 2023, respectively. The balance of \$11,210 was transferred to the DC2 Plan.

Unallocated Accounts

In addition to forfeited and expense budgeted accounts, other unallocated assets include amounts held in an advanced employer account, used to deposit excess employer

contributions. These funds can be used to reduce future employer contributions made to the Plan. The balances in the advanced employer account at October 1, 2024 and December 31, 2023 totaled \$0 and \$1,428, respectively. \$1,139 and \$0 of the unallocated funds were used to reduce employer contributions in 2024 and 2023, respectively. The balance of \$437 was transferred to the DC2 Plan.

B. SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Estimates and Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Medical Center's investment committee and Plan management determine the Plan's investment and valuation policies, utilizing information provided by its advisors and custodian. See Note D for discussion of fair value measurements.

Investment transactions are recorded on a trade-date basis. Gains and losses on investments are calculated on a moving average based on historical cost. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest and dividend income are recorded on the accrual basis.

All Plan assets were transferred to the DC2 Plan before close of business on October 22, 2024.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Most of the Plan operating expenses are absorbed by the Plan. Certain administrative expenses, including annual Plan audit fees and fidelity bond premiums, are paid directly by the Medical Center, and are excluded from these financial statements.

C. INVESTMENTS (UNAUDITED):

Unaudited Information Certified by the Plan Trustee

The investment activities and balances included on the October 1, 2024 and December 31, 2023 Statements of Net Assets Available for Benefits, the Statements of Changes in Net Assets Available for Benefits for the periods then ended and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the trustees, State Street Bank and Trust Company and Transamerica Financial Life Insurance Company Inc., in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$0 and \$103,813,875 and notes receivable from participants of \$0 and \$755,812 as of October 1, 2024 and December 31, 2023, respectively, and related investment income of \$16,446,010 and \$17,867,156 respectively, and interest on notes receivable from participants of \$11,964 and \$25,567, respectively, for the periods then ended.

D. FAIR VALUE MEASUREMENTS:

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair values may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and consist primarily of information derived by management where level 1 and level 2 inputs are not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 1, 2024 and December 31, 2023.

Mutual Funds: Investments are valued at daily calculated NAV and are traded at their quoted prices through the National Securities Clearing Corporation.

Charles Schwab Personal Choice Retirement Account: This account is a self-directed investment account. Mutual Funds are Level 1, and generally individual stocks are Level 1, and bonds are Level 1 or 2.

E. FULLY BENEFIT-RESPONSIVE CONTRACTS:

The Plan has entered into fully benefit-responsive guaranteed investment contracts with Metropolitan Life Insurance Company (MetLife) and TransAmerica Life Insurance Company (Insurance General Contract). Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The guaranteed investment contracts are presented on the face of the statement

of net assets available for benefits at fair value with an adjustment to contract value in arriving at net assets available for benefits. Contract value, as reported to the Plan by State Street Bank, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

F. PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are managed by the recordkeeper, Transamerica Retirement Solutions or affiliated companies. Total commissions and indirect compensation paid by the Plan to the broker, Healthcare Community Security Group, amounted to \$120,484 and \$75,143 for the periods ended October 1, 2024 and December 31, 2023, respectively. Total commissions and indirect compensation paid by the Plan to the broker, HANYS Benefit Services, amounted to \$0 and \$25,430 for the periods ended October 1, 2024 and December 31, 2023 respectively. Fees paid by the Plan to the recordkeeper, totaled \$132,881 and \$140,475 for the periods ended October 1, 2024 and December 31, 2023, respectively.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

G. PLAN TERMINATION:

Should the Plan have elected to terminate instead of merge, the Medical Center had the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would have become 100% vested in their accounts.

H. TAX STATUS:

The Plan obtained its latest advisory letter dated March 31, 2017, in which the Internal Revenue Service stated that the form of the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the advisory letter. However, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore believes that the Plan is qualified. As of June 13, 2014, the Medical Center is a member of a controlled group as defined by the IRC, which is considered a single employer for compliance requirements and testing purposes.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

I. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. The investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect

participants' account balances and the amounts reported in the statements of net assets available for benefits.

J. SUBSEQUENT EVENTS:

The Plan Administrator has evaluated subsequent events through August 13, 2025, the date when the financial statements were available to be issued, and there were no events requiring disclosure.
