Notes to Financial Statements

1. Description of the Plan

The following description of the Khan Academy, Inc. 401(k) Safe Harbor Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

General

The Plan was adopted effective January 1, 2012, and restated on April 26, 2022, by Khan Academy, Inc. (the Company), who is the sponsor of the Plan. The Plan is a contributory defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee, Custodian and Administration of the Plan

The trustee, custodian and recordkeeper of the Plan is Fidelity Management Trust Company (Fidelity or Trustee). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The 401(k) Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

The Plan covers all eligible employees of the Company upon hire who are age 21 or older. Eligible employees can become a participant immediately upon meeting the completion of the eligibility requirements.

Contributions

Each year, participants may elect to make contributions on a pre-tax or after-tax (Roth) basis up to 90% of eligible compensation, as defined in the Plan document, up to a maximum allowable under the Internal Revenue Code (IRC). Additionally, participants who attain age 50 before the close of the Plan year may also elect to make additional catch-up contributions to the Plan, not to exceed the amount allowable under current income tax regulations. Participants may also rollover amounts representing distributions from other qualified plans which are reflected as rollover contributions in the statement of changes in net assets available for benefits. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto enrollment provision for new or rehired employees at a contribution rate of 4%. New employees or rehired employees can elect to opt out from the enrollment.

The Company has elected to make safe harbor matching contributions of 100% of deferrals up to 4% of eligible compensation (the Safe Harbor Matching Contribution), subject to IRC limitations. The Safe Harbor Matching Contribution for each participant is made to the same investment funds to which the participant's deferred contributions are made. All investments are participant directed.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of

administrative expenses that are paid by the Plan, as applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary deferred contributions and the Safe Harbor Matching Contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, and up to a maximum equal to the lesser of 50% of their account balance or \$50,000, reduced by the highest outstanding loan balance during the previous 12 months, if any. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan administrator based on the prevailing interest rates, as defined. Loan repayments are generally made ratably through payroll deductions over a period not to exceed five years, unless the loan is used for the purchase of a principal residence, in which case the repayment period may not exceed ten years. Participants may only have one loan outstanding at a time. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC.

Payments of Benefits

Participants are eligible to receive a lump sum distribution of their account balance upon termination of employment, retirement, disability, or death. If, upon termination of employment, the value of the portion of a participant's account is \$1,000 or less, the participant will receive an automatic lump sum cash payout while those with account balances ranging from \$1,000 to \$5,000 will be rolled over to an individual retirement account designated by the Plan as soon as administratively feasible. For participants with account balances in excess of \$5,000, no distribution will occur until a withdrawal request is completed.

Prior to separation from service, participants may withdraw all or any portion of their account balance attributable to rollover contributions. Participants over age 59½ are also entitled to receive a distribution of all or any portion of their account balance. Under certain circumstances, a participant may qualify for a hardship distribution and receive a lump-sum payment of a portion of his or her account balance.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment related expenses are included in net appreciation in fair value of investments. Administrative expenses paid by the Plan totaled \$111,482 for the year ended December 31, 2024.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ materially from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Any accrued but unpaid interest is de minimis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Brokerage Link Investment Account - Valued at the quoted closing market price of the securities held in the accounts.

Money Market Fund - Valued at the daily closing price as reported by the fund.

The valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Certain Plan investments are in funds and accounts that are managed by a company affiliated with Fidelity Management Trust Company, the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Participant loan and distribution processing fees are paid to Fidelity Management Trust Company by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 1, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would remain 100% vested in their accounts.

8. Tax Status

The Plan uses a pre-approved plan document sponsored by Fidelity which received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.
