**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Vertex, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2022, plan management amended and restated the Plan in its entirety by adopting a non-standardized, pre-approved profit-sharing plan with cash or deferred arrangements (the “Amended Plan”), with the following significant modifications:

- Service hour requirement of one hour of services was eliminated;
- Employer matching contributions were increased to 100% of the first 6% of participant contribution amounts;
- New participants are immediately vested in employer contributions to their accounts;
- Existing participants became fully vested in any unvested account balances; and
- The Vertex, Inc. (the “Company”) board of directors discretionary profit-sharing contribution was eliminated.

On May 25, 2022, the Company’s Investment Committee approved the transition of the Plan’s trustee and record-keeper from Vanguard Fiduciary Trust Company (“VFTC”) to Fidelity Management Trust Company (“Fidelity”), which became effective on April 3, 2023. As a result of the change in trustee and recordkeeper, the Company adopted a new non-standardized pre-approved plan document on April 3, 2023 (see Note 7). Fidelity Investments offers similar self-directed investment options, and no significant changes were made to the Plan’s provisions.

General: The Plan is a defined contribution plan covering substantially all employees of the Company who are age eighteen or older. Employees become eligible to participate in the Plan on the date they are hired.

Contributions: The Company’s matching contribution is 100% of the first 6% of eligible compensation during the period in which an eligible participant contributes to the plan. Additional amounts may be contributed at the option of the Company’s board of directors. Participants are allowed to contribute up to 100% of pre-tax and/or Roth annual compensation and up to 10% of after-tax annual compensation each year. The Plan includes a traditional automatic contribution arrangement and unless a participant makes an affirmative election, the employer will withhold the 6% of compensation for each payroll period. The initial automatic deferral amount will increase by 1% of compensation up to a maximum of 15% of compensation apply as of each May. In addition, participants who are age fifty (50) or older are allowed to make catch-up contributions in accordance with the Economic Growth and Tax Relief Reconciliation Act. Participants may also contribute amounts representing disbursements from other qualified defined benefit or contribution plans. Contributions are subject to certain limitations.

Funding Policy: The Company funds the employee elective deferrals and the employer matching contribution within a week of the paycheck date.

Participant Accounts: Each participant has an individual investment account which is invested in shares of registered investment companies. These accounts were managed by VFTC and other fund managers through April 3, 2023, and Fidelity and other fund managers, thereafter. Each investment account is credited with the participant’s contribution, employer match, and investment income from assets directly attributable to the participant. Each investment account is also charged with investment losses and an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit provided from the participant’s vested individual investment account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Participants are immediately vested in employer contributions to their accounts.

Investment Options: Participants are able to direct the investment of both employee and employer contributions in any of the investment options offered through the Plan. Participants may change their investment options over the telephone or internet at any time. Employees who are auto-enrolled are notified of their enrollment and of the Plan's qualified default investment alternative.

Participant Notes Receivable: Participants may borrow from their accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 less the highest outstanding loan balance in the last twelve (12) months, or 50% of their vested account balance. Loan terms range up to five (5) years, or in the case of the purchase of a primary residence the terms range up to ten (10) years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator when the loan is made. Interest rates range from 4.25% to 9.5% for outstanding loans as of December 31, 2024 and 2023. Principal and interest are paid ratably through biweekly payroll deductions.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant, or beneficiary in the case of death, may elect to receive either a lump-sum amount equal to 100% of their vested account balance, or installments over a period of not more than the participant's assumed life expectancy. Upon termination of service due to termination of employment, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. The participant also has the option of rolling over the amount equal to the value of the vested interest in his or her account to another qualified plan. Additionally, the Plan provides for automatic cashout of small balances and provides for in-service withdrawals for financial hardship purposes or upon attainment of age 59  $\frac{1}{2}$ .

Forfeited Account: At December 31, 2024 and 2023, the forfeited nonvested account totaled \$6,153 and \$47,662, respectively. This account is used to reduce employer contributions or pay administrative expenses. During 2024, \$161,135 of forfeitures were used to reduce employer contributions.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company or plan management and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amount of net assets and disclosures of contingent assets and liabilities at the date of the financial statements and reported increases in Plan assets during the reporting period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchase and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023 due to the notes receivable from participants being secured by the participants' remaining account balance.

Payment of Benefits: Benefits are recorded when paid.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

FASB Accounting Standards Codification ("FASB ASC") 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective Investment Trust:* The Plan's interest in the collective investment trust is valued based on information reported by the Plan trustee using the audited financial statements of the collective trust at year-end. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The collective trust provides for daily redemptions by the Plan at reported net asset unit value per share, with no advance notice requirement.

The following tables set forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, 2024 and 2023, with the exception of the collective investment trust measured at fair value using the net asset practical expedient. The fair value for the collective investment trust is provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

**NOTE 4 - EMPLOYER CONTRIBUTION RECEIVABLE**

Employer contributions receivable resulted from the timing of the funding of employer true-up matching contributions to the Plan. The Company funded the employer true-up matching contributions for 2024 in 2025. The employer contributions receivable at December 31, 2024 totaled \$2,006,350. The Company funded the employer true-up matching contributions for 2023 in 2024. The employer contributions receivable at December 31, 2023 totaled \$336,008.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contributions and earnings thereon.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (“DOL”) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan invests in a common collective trust and shares of mutual funds issued by Fidelity Investments, an affiliate of Fidelity. Fidelity acts as trustees for only those investments as directed by the Plan. Transactions in such investments and payment of fees to Fidelity qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Notes receivable from participants also reflect party-in-interest transactions.

#### **NOTE 7 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the volume submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). The Company believes that the Plan is currently being operated in accordance with the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America requires Plan Management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment funds. Investments in general are exposed to various economic risks, such as interest rate, credit, overall volatility risk, and economic risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

#### **NOTE 9 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, trustee of the Plan.

#### **NOTE 10 – SUBSEQUENT EVENTS**

Plan Management monitored significant events occurring after the balance sheet date and through July 30, 2025, the date the financial statements were available to be issued.

The Setting Every Community Up Retirement Enhancement 2.0 Act (“SECURE 2.0”), was passed by congress on December 29, 2022. SECURE 2.0 included provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. Effective January 1, 2025, individuals attaining ages 60–63 during the calendar year will be able to make catch-up contributions to eligible retirement plans. Effective January 1, 2026, provision 603 of SECURE 2.0, will require that catch-up contributions for eligible participants with certain wages from the employer sponsoring the plan exceed a threshold in the preceding calendar year must be treated as Roth contributions, which are made with after-tax dollars.

Plan Management is continuing to evaluate the impact of the SECURE 2.0 act on the Plan’s operations and financial statements but does not expect any other significant impact at this time.
