Independent Auditor's Report

To the Plan Administrator of the Harvey Industries, LLC 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Harvey Industries, LLC 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Emphasis of Matter — Plan Merger

As further discussed in Note I, the Plan was merged into the Cornerstone Building Brands 401(k) Profit Sharing Plan effective January 1, 2025. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO THE FINANCIAL STATEMENTS

A. PLAN DESCRIPTION:

The following description of the Harvey Industries, LLC 401(k) Plan (the "Plan") is presented for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution pension plan covering substantially all employees of Harvey Industries, LLC (the "Company") and consists of voluntary participant contributions, discretionary non-elective contributions and employer matching contributions. Employees of the Company who are not classified as temporary, seasonal or as interns, who have completed one month of service and have attained age 18 are eligible to make deferral contributions and receive company matching contributions. Temporary employees, seasonal workers, and interns who have attained age 18 and completed a 12-month period of employment with the Company where they are credited with at least 1,000 hours of service are also eligible to participate in the plan. All employees who have attained age 18 and have completed one year (at least 1,000 hours) of service and are employed on the last day of the plan year are eligible to receive an allocation of any discretionary profit sharing contributions made by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Upon meeting eligibility requirements, participants may elect to contribute up to 100% of their eligible compensation, as defined by the Plan, on a pre-tax or after-tax ("Roth") basis subject to Internal Revenue Service ("IRS") limitations. Each newly hired employee shall be automatically enrolled in the Plan at a pre-tax contribution rate of 3% of compensation after meeting eligibility requirements. The participant may elect to cease or change the amount of these contributions at any time. The Plan provides for automatic increases of 1% each year up to a maximum of 10% for employees who do not opt out of auto increase and are currently deferring below 10%. Participants who are at least age 50 may also make additional catch-up contributions subject to IRC limitations. Participants may also contribute funds from another qualified retirement plan ("rollover contributions"), subject to certain requirements.

The Company makes safe harbor matching contributions to participants equal to 100% of the first 3% of elective deferrals and 50% of the next 2% of elective deferrals, for a maximum matching contribution of 4% of a participant's eligible compensation. The Company may also make discretionary non-elective contributions to the Plan. Additional discretionary non-elective contributions are allocated based on the ratio of each eligible employee's compensation to total eligible employees' compensation. There were no discretionary non-elective contributions for the year ended December 31, 2024.

NOTES TO THE FINANCIAL STATEMENTS

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in that portion of their account which relates to their contributions, safe harbor contributions, discretionary matching contribution and the income earned thereon. Participants become 100% vested in discretionary non-elective contributions upon death, total and permanent disability, or attainment of normal retirement age. Otherwise, a participant's interest in discretionary non-elective contributions, and earnings thereon vests as follows:

<u>Completed Years of Service</u>	<u>Percent Vested</u>
Less than 2 years	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%
6 years or more	100%

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of a participant's account represents a forfeiture, as defined by the Plan. If a forfeiting participant is re-employed and fulfills certain requirements, as set forth in the Plan, the participant's account will be restored. Forfeitures of discretionary non-elective contributions may be allocated to participants based on the same formula used to determine the allocation of profit sharing contributions to participants. They may also be used to pay administrative expenses or to reduce employer contributions. During 2024, \$1,857 in forfeitures were used to reduce employer contributions and \$20,373 used to pay plan expenses. Total unapplied forfeitures were \$1,386 and \$19,582 as of December 31, 2024 and 2023, respectively.

Unallocated Account

The Plan holds assets in an unallocated account which receives contributions as a result of a revenue sharing agreement with Great-West Life & Annuity Insurance Company, and Great-West Trust Company, LLC. During 2024, contributions to the account totaled \$79,811, which is included in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits. Funds in the account may be used to pay plan expenses. During 2024, \$90,248 was used to pay plan expenses. Unallocated assets were \$48,513 and \$55,616 on December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The interest rate is 1% over the Prime Rate published in the Wall Street Journal on the first business day of the month before the loan is originated. The interest rate is fixed for the life of the loan. The plan administrator may change the basis for determining the interest rate on future loans from time to time. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed. No more than two loans may be outstanding at any time. Principal and interest is generally paid ratably through payroll deductions each pay period.

Distribution of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Distributions under the Plan may be made in lump sums, partial withdrawals or periodic installment payments.

A participant may also request a withdrawal upon attainment of age 59 1/2 or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. Participants may withdraw from their rollover account at any time.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Contributions

Contributions from plan participants are recorded in the year in which the participant contributions are withheld from compensation. Company contributions are calculated and recorded based on plan compensation paid during the year.

Benefits

Benefit payments to participants are recorded when paid.

Expenses

Substantially all of the Plan's expenses are paid by the Company except for participant initiated transaction fees and expenses paid with plan forfeitures and from the unallocated account, as provided by the Plan document. Expenses that are paid by the Company are excluded from these financial statements.

C. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology that are unobservable and significant to fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTES TO THE FINANCIAL STATEMENTS

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used on December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts – Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Variable annuity contract – This category consists of accounts managed by Empower which invest principally in equity securities, fixed-income instruments and short-term investments. The fair values of each account in this category are determined daily using the net asset value per share of the investments.

There are no unfunded commitments for the common collective trusts held by the Plan. The FIAM Small Capitalization Core account and the Vanguard Retirement Savings Trust requires a 30 days' notice to redeem, and the T. Rowe Price Retirement Trust target date funds require a 15 days' notice to redeem.

Accounting standards require disclosure of investment strategies for investments valued using net asset value as a practical expedient to estimate fair value if the investment does not file a Form 5500 with the Department of Labor ("DOL") as direct filing entity ("DFE"). Redemptions of investments in the variable annuity contract are allowed daily for participants. There are no unfunded commitments.

D. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS:

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the custodians are considered party in interest transactions.

E. TAX STATUS:

The Company adopted a pre-approved plan document of Empower Retirement LLC. The IRS has determined and informed Empower Retirement LLC by a letter dated November 14, 2022, that the pre-approved plan document is designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan.

G. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

H. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

I. PLAN MERGER:

Effective January 1, 2025, the Harvey Industries, LLC 401(k) Plan merged with and into the Cornerstone Building Brands 401(k) Profit Sharing Plan and ceased to exist as a separate plan on that date. As of December 31, 2024, the Plan held assets of \$90,729,361. On January 1, 2025, these assets became assets of the Cornerstone Building Brands 401(k) Profit Sharing Plan, and the Plan's assets of January 1, 2025 were \$0.

J. SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through July 9, 2025, the date these financial statements were available for issuance.
