Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Vetter Equipment Company, Inc. 401(k) Profit Sharing Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

OCTOBER 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Vetter Equipment Company, Inc. ("Company") 401(k) Profit Sharing Trust ("Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Company established the Plan to provide employees with a systematic means of savings and investing for the future. Eligible employees of the Company, as defined by the Plan document, can enroll on the first day of the first month and of the seventh month of the Plan Year coinciding with or immediately following the date the employee satisfies the eligibility requirements.

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Assets of the Plan are allocated to participant accounts based on specific contributions made by each participant and respective matches made by the Company. Investment income (loss) is credited to each account based on appreciation (depreciation) of specific assets held in each participant account and any earnings thereon.

The plan was originally effective on November 11, 1988. The amended and restated provisions of the Plan became effective on August 22, 2023.

Contributions

Upon meeting the eligibility requirements, participants may contribute a minimum of 1 percent of their compensation, as defined by the Plan, by means of payroll deductions on a pre-tax or Roth basis. Contributions are subject to certain discrimination tests prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company makes a matching contribution equal to 50 percent of the amount deferred up to 7 percent. The Company may make discretionary non-elective contributions to the Plan. During the years ended October 31, 2024 and 2023, the company did not make any non-elective contributions. Contributions are subject to certain statutory limitations.

NOTE 1 – DESCRIPTION OF THE PLAN - CONTINUED

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the company's matching contributions, Plan gains or losses, and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's accounts.

Investment Options

Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and a guaranteed interest account as investment options for participants.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of service. Employees vest 20 percent per year after completing two years of service until becoming 100 percent vested after six years of credited service in accordance with the Plan document, or immediately if employment is terminated due to death, disability, or retirement.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or in installments, not to exceed the life expectancy of the participant or their spouse, or any combination of the two. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants with a vested benefit not exceeding \$5,000 may only elect to receive payment in a lump-sum amount.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to 50 percent of their vested account balance not to exceed \$100,000. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years. Participants notes receivable are valued at their outstanding principal balance plus accrued but unpaid interest. As of October 31, 2024 and 2023, the Plan had loans receivable from participants with principal balances totaling \$105,307 and \$119,375, respectively.

NOTE 1 – DESCRIPTION OF THE PLAN - CONTINUED

Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

Forfeited Accounts

At October 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,688 and \$18,313, respectively. These accounts will be used, at the discretion of the Plan administrator, to reduce future plan expenses and the Company's matching contributions. For the years ended October 31, 2024 and 2023, \$30,629 and \$14,903, respectively, were reallocated from forfeiture accounts to be used for plan expenses and matching contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the plan have been prepared on the accrual basis of accounting.

Investment held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, disclosure of contingent assets and liabilities. Accordingly, the actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Investment Valuation and Income Recognition - continued

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expense charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of October 31, 2024 and 2023, no allowance for credit losses have been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions

Contributions from employees are recorded as they are withheld from the participant's wages.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as accounts payable, with a corresponding reduction to contributions. There were no excess contributions for the years ended October 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants are included in administrative expenses and charge directly to the participant's account.

NOTE 3 – INVESTMENTS (UNAUDITED)

The Plan's investments were held in trust and administered by the trustee, Nationwide Financial Services, Inc. for the years ended October 31, 2024 and 2023. All investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held and net appreciation/depreciation in fair value of investments and interest and dividends, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value for investment options offered by Nationwide Financial Services, Inc. There have been no changes in the methodologies used as of October 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the net asset value (NAV) of shares held by the plan at year end and are classified in Level 2 of the fair value hierarchy.

NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

These funds are considered open-end mutual funds, meaning that the fund is ready to redeem its shares at any time and offers its shares for sale to the public, either through retail outlets or through institutional investors continuously. For institutional funds, NAV's are received daily from fund managers, and the managers stand ready to transact at these quoted amounts.

The insurance company custodian transacts in these funds on a daily basis as part of the separate account trading activity.

The calculation of the NAV for funds composed of other funds (e.g., retirement target date funds) is essentially the same as the calculation of the NAV for any other fund: the total market value of assets across all underlying funds less any liabilities is divided by the outstanding shares. Again, this resulting NAV is published and/or the fund managers are ready to transact at the quoted prices.

NOTE 5 – INVESTMENT CONTRACTS WITH INSURANCE COMPANY

During the years ended October 31, 2024 and 2023, the Plan held a guaranteed interest account, which is a fully benefit-responsive investment contract with Nationwide. Nationwide maintains the contributions in a general account. The guaranteed interest account is valued at contract value which represents contributions made under the contract, plus earnings less participant withdrawals and administrative expenses. Participants are able to ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest account issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan.

NOTE 5 – INVESTMENT CONTRACTS WITH INSURANCE COMPANY - CONTINUED

As described in Note 2, because the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. The guaranteed interest account is presented on the face of the Statements of Net Assets Available for Benefits at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contracts as October 31, 2024 and 2023, was \$1,298,631 and \$1,506,639, respectively. The contract value of the investment contracts at October 31, 2024 and 2023 was \$1,425,500 and \$1,739,768, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity was provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that no events are probable of occurring that would limit the Plan's ability to transact at contract value with participants.

Nationwide is contractually obligated to pay principal and a specified interest that is guaranteed by the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0.5%. Such interest rates are reviewed on a quarterly basis for resetting.

NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Nationwide Financial Services, Inc., the trustee of the Plan and therefor, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

During the year ended October 31, 2024, the plan sponsor did not remit certain participant contributions to the plan in a timely manner, as defined by ERISA. These instances were corrected during 2025. These contributions are considered nonexempt party-in-interest transactions, which may result in an imposition of a 15 percent excise tax on the amount of the transactions. The plan sponsor intends to compensate participants for any lost interest resulting from the delay in contributions. Management estimates that lost income associated with the delay in contributions amounts to \$604. These nonexempt transactions do not affect the tax status determination of the plan, and the company intends to pay all fines imposed

NOTE 6 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS - CONTINUED

During the year ended October 31, 2023, the plan sponsor did not remit certain participant contributions to the plan in a timely manner, as defined by ERISA. These instances were corrected during 2024. These contributions are considered nonexempt party-in-interest transactions, which may result in an imposition of a 15 percent excise tax on the amount of the transactions. The plan sponsor intends to compensate participants for any lost interest resulting from the delay in contributions. Management estimates that lost income associated with the delay in contributions amounts to \$665. These nonexempt transactions do not affect the tax status determination of the plan, and the company intends to pay all fines imposed.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 8 – INCOME TAX STATUS

The Company has adopted a prototype non-standardized plan pre-approved by the IRS. The IRS issued an opinion letter dated June 30, 2020, that the prototype non-standardized plan is acceptable with the applicable section of the IRC. Although the Plan has been amended since receiving the opinion letter, the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of American require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 – RISKS AND UNCERTANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 – SECURE ACT 2.0

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as “SECURE 2.0.” These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting 2023 and forward. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect. Most of the significant provisions will become effective in 2024 and thereafter. Accordingly, there is no material impact to the Plan’s 2023 financial statements.

NOTE 11 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There were no reconciliations of net assets available for benefits or reconciliations of the change in net assets available for benefits per the financial statements to Form 5500 at October 31, 2024 and 2023.

NOTE 12 – RECEIVABLE FROM RECORDKEEPER

During the plan year ending October 31, 2023 a participant requested a distribution of \$9,500. Nationwide inadvertently distributed the participants entire account balance, \$111,946. They paid the participant \$9,500 and placed the remaining \$102,446 into a suspense account. Nationwide discovered the error in December 2023 and repaid the participant their remaining balance in January 2024. The payment to the participants account was \$102,446. Nationwide has calculated the lost income to be approximately \$6,475 and will be making that payment into the participants account.

NOTE 13 – DELINQUENT CONTRIBUTIONS

As required by ERISA Section 2510.3-102, the plan sponsor is required to segregate employee contributions to the plan from its general assets as soon as practicable but in no event more than 15 days following the end of the month in which amounts are withheld from wages.

During the year ended October 31, 2024, there were five contributions that were paid in excess of four business days, the days proven to be practicable for payment by the company, after the paydate. Total contributions and loan repayments for these pay periods were \$170,462. Contributions for these pay periods are considered a prohibited transaction. The company will make an interest payment of \$604 to compensate the plan for lost investment earnings relating to this prohibited transaction.

During the year ended October 31, 2023, there were five contributions that were paid in excess of four business days, the days proven to be practicable for payment by the company, after the paydate. Total contributions and loan repayments for these pay periods were \$194,270. Contributions for these pay periods are considered a prohibited transaction. The company will make an interest payment of \$665 to compensate the plan for lost investment earnings relating to this prohibited transaction.

NOTE 14 – SUBSEQUENT EVENTS

During the audit, it was identified that Nationwide had inadvertently allocated forfeitures as employee contributions rather than as employer matching contributions. In addition, the distribution of these forfeitures among participants was incorrect. Nationwide is currently in the process of correcting the classification and reallocating the amounts appropriately among affected participants.

No other subsequent events were noted. Subsequent events have been evaluated through August 15, 2025, the date the financial statements were available to be issued.
