INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the
Intertape Polymer Corp. Marysville Union Pension Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Intertape Polymer Corp. Marysville Union Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and statements of accumulated plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and statements of changes in accumulated plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

December 31, 2024 and 2023**

1 – Description of the Plan

The following description of the Intertape Polymer Corp. Marysville Union Pension Plan (the “Plan”), is provided for general information purposes only. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan’s provisions.

General

The Plan is a non-contributory defined benefit pension plan providing pension benefits to employees of the former Central Products Company (“Central”). Central was acquired by Intertape Polymer Group, Inc. (“IPG”) in 1999, at which time, Intertape Polymer Corp., a subsidiary of IPG, assumed sponsorship of the Plan (the “Company”, “Plan Administrator”, “Plan Sponsor”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

Employees whose initial date of employment was on or before May 1, 1999 with a minimum of five years of service are eligible for normal retirement benefits on the first day of the month following their sixty-fifth birthday. The Plan is frozen to new participants hired after May 1, 1999.

Funding Policy

The Company shall make contributions to the Plan in such amounts computed by the Plan’s actuary, which shall be consistent with the Plan’s objectives and in full compliance with the minimum funding requirements imposed under ERISA. There were no employer contributions required or made for Plan years 2024 and 2023.

Payment of Benefits

Normal monthly retirement benefits for employees retiring on or after April 29, 2006 (except as revised below) are calculated as a benefit rate of \$25.00 multiplied by the number of years of benefit service. Prior to April 29, 2006, the benefit rate ranged from \$9.00 to \$23.00. Annual benefit payments commence at the normal retirement date and continue for life. The Plan provides reduced benefits for early retirement and disability. The Plan provisions allow employees with at least ten years of service to elect early retirement following the employee’s fifty-fifth birthday. Individual retirement benefits are limited to the maximum set forth by ERISA and the Internal Revenue Code (“IRC”).

On December 31, 2015, Plan amendments were adopted resulting in an increase in the pension benefit rate from \$25.00 per month per year of service to \$25.00 per month per year of service earned prior to January 1, 2016 and \$27.00 per month per year of service earned on or after January 1, 2016. Effective May 3, 2018, the pension benefit rate increased to \$28.00 per month per year of service earned on or after January 1, 2019.

In lieu of receiving a monthly benefit as provided above, an employee may alternatively elect a reduced monthly survivorship benefit payment during the lifetime of the retired employee which provides continuance of payments, under several options, during the lifetime of the employee’s surviving spouse, as defined by the Plan Document.

In the event of a mandatory distribution greater than \$1,000 but less than or equal to \$5,000, if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover, or to be paid in a lump sum distribution, then the Plan Administrator will pay the distribution in a direct rollover to an individual retirement plan designated by the Plan Administrator. Mandatory distributions less than \$1,000 are paid directly to the participant, unless the participant elects a direct rollover.

Death and Disability Benefits

The spouse of a participant will receive a pre-retirement survivor annuity, as defined in the Plan, upon the death of the participant prior to the date the participant's benefit payments begin. The spousal pre-retirement survivor annuity is equal to fifty percent of the participant's monthly benefit. The spouse may commence survivor annuity payments as of the earliest date the participant would have received benefits. The minor child(ren) of an unmarried participant with at least ten years of service at the time of his death may be eligible to receive a surviving child benefit. The amount of the benefit is equal to 42.5% of the participant's monthly benefit, split equally among all eligible children. If a participant has already begun receiving benefits at the time of the participant's death, death benefits payable by the Plan, if any, will depend upon the form of payment in which the participant was receiving benefits.

A participant who has completed at least ten years of service and retires for reason of total and permanent disability prior to attaining age 65 is entitled to monthly pension benefits equal to two times the normal retirement benefit such participant would have received based on the participant's years of credited service as of the date the participant became totally and permanently disabled. Upon the earlier of attaining age 65 or becoming eligible for disability benefits under the Federal Social Security Act, the participant's monthly pension benefits shall be reduced to the normal retirement benefit such participant would have received based on the participant's years of credited service as of the date the participant became totally and permanently disabled. Benefits shall be payable on the later of the first day of the month following (a) the date that proof of total and permanent disability is received by the Company, (b) the completion of a period of total and permanent disability of six months, or (c) the month for which the last Company-provided sickness or accident benefit payment is made.

Vesting Schedule

A participant becomes fully vested upon completing five years of service.

Termination of Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination of the Plan, benefits vested will not be affected. Plan assets will be allocated to benefit categories in a specific order.

Beginning with the benefit category that has first claim on Plan assets, payments will be made for:

- those currently receiving benefits and who have been receiving benefits for at least three years prior to Plan termination;
- those currently receiving benefits and began receiving benefits, and active employees who were eligible to retire, within three years prior to Plan termination;
- benefits guaranteed by the Pension Benefit Guaranty Corporation ("PBGC");
- all other benefits vested under the Plan;
- all other benefits accrued but not yet vested under the Plan.

Benefits under this Plan are insured by the PBGC if the Plan terminates. The PBGC covers most vested retirement benefits and certain disability and survivor benefits. However, the PBGC does not insure all types of benefits and the amount of benefit protection is subject to certain limitations. The PBGC guarantees benefits vested on the date the Plan terminates. However, if the level of benefits have been increased within five years prior to Plan termination, the entire amount of the Plan's vested benefits or the benefit increases may not be guaranteed. In addition, there is a ceiling on the amount of monthly benefits that the PBGC guarantees. The PBGC adjusts this ceiling periodically.

2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“US GAAP”).

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits, and the changes therein during the reported period. Actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan’s expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments presented in the statements of changes in net assets available for benefits.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosures regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes Plan gains and losses on investments bought and sold as well as held during the year.

Actuarial Present Value of Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan’s provisions to the services employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of employees who are deceased, and (c) present employees or their beneficiaries. Benefits payable under all circumstances – retirement, death, disability and termination of employment – are included, to the extent they are deemed attributable to employee service rendered through the valuation date.

Annuity Buy Out Transaction

Effective June 12, 2024, the Plan Sponsor entered into an agreement with an insurance company to purchase a group annuity buy out contract and transfer approximately \$10 million of the Plan's projected benefit obligations to the insurance company. The transaction was funded with Plan assets. This annuity buy out transaction transferred responsibility for pension benefits for approximately 156 retirees and their beneficiaries with a monthly benefit of \$81,899 to the insurance company.

Subsequent Events

The Plan has evaluated subsequent events through August 14, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

3 – Benefit Obligations

The actuarial present value of accumulated plan benefits for the years ended December 31, 2024 and 2023 was determined by an independent actuary. Present value is determined by discounting future cash outflows using interest rates of high-quality corporate bonds that have terms to maturity approximating the terms of the related plan benefits and by applying actuarial assumptions to reflect the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The following presents significant actuarial assumptions used in the valuations as of December 31, 2024 and 2023:

These actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits. The computations of the actuarial present value of plan benefits were made as of January 1, 2025 and 2024. Had the valuations been performed as of December 31, there would be no material differences.

4 – Fair Value Measurements

The *Fair Value Measurements and Disclosures* topic of the Financial Accounting Standards Board Accounting Standards Codification (the “Codification”) establishes a framework for measuring fair value.

That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this guidance are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methods used for assets measured at fair value at December 31, 2024 and 2023. There have been no significant changes in the methods used at December 31, 2024 and 2023:

Mutual funds: Valued at the quoted market price available on an active market.

Pooled separate accounts: Units of participation in pooled separate accounts are valued based on the net asset value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy.

5 – Related Party and Party-In-Interest Transactions

A portion of the costs of administering the Plan are paid by the Company. These costs are insignificant to the Plan's net asset available for benefits, but are considered to be related-party transactions.

As of December 31, 2024 and 2023, Plan investments were managed by Principal Trust Company ("Principal"). As of December 31, 2024 and 2023, Principal holds the Plan's investment assets and executes investment transactions.

Any transactions with Principal qualify as party-in-interest transactions.

6 – Information Certified by Qualified Institutions

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has determined that Principal is a qualified institution and information prepared and certified by them meets the requirement of ERISA Section 103(a)(3)(C). Accordingly, Principal has certified that the following data included in the financial statements and supplemental schedules is complete and accurate:

- Investments, at fair value as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss), as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024.
- Schedule H, Line 4(j) - Schedule of Reportable Transactions for the year ended December 31, 2024.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

7 – Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Company by a letter dated July 29, 2016, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and believes the Plan, as amended, is qualified and the related trust is tax exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

The Plan's contributions are made and the actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption processes, it is at least reasonably possible that changes in these estimates and assumptions in the near-term could materially affect the amounts reported and disclosed in the financial statements.

Methods prescribed by law

Liability measure

Funding target is the present value of the benefits accrued on the valuation date. Target normal cost is based on benefits expected to accrue during the current plan year and includes an estimate of plan expenses for the year.

Benefit accrual

All benefits paid at decrement are considered in total and then split to determine how much is included in funding target. The following pieces are included in the funding target.

The portion based on the plan's definition of accrued benefit.

The benefit portion in excess of the accrued benefit based on the ratio of the participant's years of service on the valuation date to the years of service the participant will have at the time of decrement.

The benefits included in target normal cost are calculated similarly, by splitting the benefits. The target normal cost is based on the difference between the amount included in Funding Target and an amount calculated assuming the participant accrues service through the end of the plan year.

Methods selected by plan sponsor

Asset method

The asset valuation method is prescribed by law for plans that elect to use a value other than market value.

For each of the preceding two years, an expected value of assets at the end of the year is compared to the end of year market value. The resulting gain or loss is recognized evenly over three plan years.

The expected value includes contributions, distributions, any deducted administrative expenses, and expected earnings (based on the lesser of the assumed interest rate or the maximum allowable rate). The deferred gains and losses are added to the current market value and then restricted to no more than 110% and no less than 90% of that market value.

When actual returns exceed the assumed return, the actuarial value of assets will lag below market value. The lag and the smoothing effect are limited since the value must be within 10% of market value.

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The Blue collar base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe "Approach 1" is reasonable for this plan.

Mortality improvement

MP-2021 is the most recent improvement scale published by the SOA in October 2021.

In selecting this assumption, we considered the other parameters available in the MIM-2021-v4 application tool issued by the SOA in October 2023 and consider the selections in MP-2021 reasonable. Based on the sponsor's input, plan experience does not show a need for long-term excess death or Covid death load adjustments.
