## Independent Auditor's Report

### The Plan Administrator Winsight, LLC 401(k) Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Winsight, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, the related statements of changes in net assets available for benefits for the ten months ended October 31, 2024 and for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of October 31, 2024 and December 31, 2023, for the ten months from January 1, 2024 to October 31, 2024, and for the year ended December 31, 2023 stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).



- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter—Plan Merger**

As discussed in Note 8 to the financial statements, the Plan was merged into the Informa USA, Inc. 401(k) Plan effective January 24, 2024. As a result, all plan assets were transferred to the control of Informa USA Inc. 401(k) Plan on October 7, 2024. Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTE 1      DESCRIPTION OF THE PLAN**

The following description of the Winsight, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General**

The sponsor of the Plan is Winsight, LLC (the “Company” or the “Plan Sponsor”). The Plan is a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility and Participation**

Employees are eligible to participate in the Plan on the first day of the month on or after they become eligible employees. Certain employees, including nonresident aliens who have no earned income from sources within the United States, union employees, employees not eligible for the Company-provided health and welfare benefits, and independent contractors are not eligible for participation in the Plan. Employees may begin making salary deferral contributions and are eligible to participate in discretionary employer matching contributions on the first day of the month following their date of hire.

**Contributions**

Participants may make salary deferral contributions of eligible annual compensation as defined in the Plan document, up to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS). Participants were automatically enrolled at 6% through April 28, 2020. Effective April 29, 2020, the initial automatic deferral rate is increased to 8% with an annual escalation of 1% up to a maximum of 15%, unless the participant makes a contrary election. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also permits participants to make additional voluntary contributions of qualified rollovers from other retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Employer contributions are at the Company’s discretion. The Company elected to make discretionary employer matching contributions of a certain percentage of employee deferral contributions. If the Company makes one, they choose the percentage. Matching contributions are calculated based on the participant’s pay and elective deferrals for the payroll period. Matching contributions are made for all persons who were active participants at any time during that payroll period. Any percentage chosen will apply for the entire plan year.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and the Company’s contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**NOTE 1      DESCRIPTION OF THE PLAN (CONTINUED)**

**Notes Receivable from Participants**

Participants may borrow from their accounts. Notes receivable may not exceed 50% of the vested portion of the participant's account (or \$50,000 whichever is less) and must be a minimum of \$1,000. The note receivable must be repaid within five years unless the loan proceeds are used to purchase the participant's primary residence, in which case the note may be repaid over a 10-year period. All notes receivable will provide for the repayment of interest at rates commensurate with local prevailing rates, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant whose vested account balance exceeds \$1,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his/her account. Participants with account balances less than \$1,000 must take a lump-sum distribution as soon as practicable following termination.

Participants who are at least 59 ½ years of age may take an in-service distribution of their vested account balance.

**Vesting**

Participants are immediately vested in their elective deferral, qualified matching contributions, and any rollover contributions made to the Plan, plus actual earnings thereon. Effective January 1, 2019, participants are immediately 100% vested in Company contributions. Additionally, participants may become fully vested upon normal retirement age, death, or total disability prior to retirement.

**Forfeitures**

The Plan allocates participant forfeitures first to reduce Plan expenses and then for Company contributions.

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Net Appreciation (Depreciation) in Fair Value of Investments**

Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of October 31, 2024 and December 31, 2023. If a participant ceases to make repayments and the Plan Administrator deems the note receivable from the participant to be in default, the note receivable from the participant's balance is reduced and a benefit payment is recorded.

**Benefits Paid to Participants**

Benefits paid to participants are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying Statements of Changes in Net Assets available for Benefits.

**NOTE 3 INCOME TAX STATUS**

The Plan has adopted a volume submitter plan sponsored by Principal Financial Group. The IRS has determined and informed the sponsor of the prototype plan by a letter dated August 8, 2014, that the volume submitter plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The volume submitter plan opinion letter has been relied upon by this Plan. On March 11, 2022, the Plan was restated and adopted a non-standardized pre-approved profit-sharing plan sponsored by Principal Financial Group.

Although the Plan has been amended since the date of the opinion letter, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 4 INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan's asset information as of October 31, 2024 and December 31, 2023, and for the ten months ended October 31, 2024 and for the year ended December 31, 2023, included throughout the Plan's financial statements and supplemental schedule, were obtained by management and agreed to or derived from information certified by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal), the custodian of the Plan. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the Plan's assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following:

- Investments and notes receivable, as reflected in the Statements of Net Assets Available for Benefits as of October 31, 2024 and December 31, 2023;
- Investment activity, as reflected in the Statements of Changes in Net Assets Available for Benefits for the ten months ended October 31, 2024 and for the year ended December 31, 2023;

**NOTE 4 INFORMATION CERTIFIED BY THE CUSTODIAN (CONTINUED)**

- Investment information disclosed in Notes 5 and 6 to the Plan's financial statements; and
- Investments, as reflected in Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of October 31, 2024.

**NOTE 5 FAIR VALUE MEASUREMENT**

The Plan has adopted Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. This framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2023.

**NOTE 5 FAIR VALUE MEASUREMENT (CONTINUED)**

**Shares of registered investment companies:** Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end shares of registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The shares of registered investment companies held by the Plan are deemed to be actively traded.

**Common/collective trust:** The Plan's investments in common collective trust funds are classified as Level 2 assets in the fair value hierarchy. Common collective trust funds have the characteristics of a structure similar to a mutual fund and are valued based on the readily determinable quoted market price that each fund publishes at the end of each day. While the underlying assets are actively traded on an exchange, the common collective trust funds are not and, therefore, are classified as Level 2 assets in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 INVESTMENTS AT CONTRACT VALUE**

The Plan invests in an evergreen fully benefit-responsive guaranteed return account with the trustee. The trustee maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed return account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting.

**NOTE 6 INVESTMENTS AT CONTRACT VALUE (CONTINUED)**

The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the trustee, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

The Plan's investments in fully-benefit investment contract as of December 31, 2023 amounted to \$3,656,802.

**NOTE 7 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are guaranteed investment contracts managed by Principal. Principal is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Principal totaled approximately \$12,000 and \$73,000 for the ten months ended October 31, 2024 and for the year ended December 31, 2023, respectively. The Company pays directly any other fees related to the Plan's operations.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

**NOTE 8      PLAN MERGER**

On May 18, 2023, the Company was acquired by Informa USA, Inc. (“Informa”) and the Plan was merged with the Informa plan effective January 24, 2024. As a result, all plan assets were transferred to the Informa USA, Inc. 401(k) Plan on October 7, 2024.

**NOTE 9      RISK AND UNCERTAINTIES**

The Plan invests in various investment securities that are exposed to risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 10     SUBSEQUENT EVENTS**

The Plan Administrator has evaluated events or transactions that occurred subsequent to October 31, 2024 through August 15, 2025, the date the accompanying financial statements were available to be issued, for potential recognition or disclosure in the financial statements and determined that no subsequent events required disclosure or adjustment to the accompanying financial statements.
