Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Public Policy Institute of California Defined Contribution Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of Public Policy Institute of California Defined Contribution Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document and any amendments for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan established on October 1, 1994 under Section 403(b) of the Internal Revenue Code (the "Code") to provide retirement benefits to eligible employees of Public Policy Institute of California (the "Company"). The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Code and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

B. Plan Administration and Expenses

The Company appointed an administrative committee to manage operation and administration of the Plan. Plan investments are provided under group annuity contracts issued by the custodians, TIAA and CREF. TIAA serves as third-party administrator of the Plan. Investment fund sub-advisor, operating and management fees, custodial fees, record keeping and contract management fees and brokerage commissions are factored into Plan investment funds as a reduction in investment return. Other costs incurred for administering the Plan are paid by the Company.

C. Eligibility

The Plan excludes visiting researchers and temporary employees from participation in the Plan. There is no service or age requirement for an eligible employee to begin elective deferrals. Participants are eligible to receive employer matching contributions on the date of hire.

D. Contributions

The Company makes nonelective contributions equal to 9% of each participant's compensation plus 5% of each participant's compensation in excess of 100% of the Social Security Taxable Wage Base for the year.

Participants may elect to have the Company contribute their eligible pre-tax compensation up to the amount allowable under the Plan document and Code regulations. Participants who elect to have the Company contribute a portion of their pre-tax compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants who are age 50 or older may make additional "catch-up" contributions as provided under the Plan and Code provisions. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans plus Roth after-tax contributions. Such contributions are deposited in the appropriate investment funds in accordance with the participant's investment directions.

E. Participant Accounts

Each participant's account is credited with participant's contributions, rollover contributions, Company nonelective contributions, and the participant's share of Plan earnings or losses and expenses. Participants direct the investment of their accounts.

F. Vesting and Forfeitures

Participants are immediately 100% vested in their contributions, rollover contributions and related earnings. Participant accounts become 100% vested in Company contributions after one year of employment with the Company. Forfeitures of terminated participants' non-vested accounts may be used to reduce future Company contributions. For the 2024 Plan year, no forfeitures were used to reduce Company contributions. The balance of unapplied forfeitures was not significant as of December 31, 2024.

G. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account balance, bears a fixed rate of interest which is generally the Federal Reserve Board Bank prime loan rate plus 1% at the time of the loan origination, and must be repaid to the Plan within five years unless the loan is used for the purchase of a principal residence, in which case the maximum repayment period may be extended. Principal and interest are paid ratably through payroll deductions. As of December 31, 2024, there were no participant loans outstanding.

H. Payment of Benefits

Normal retirement under the Plan is age 65. Upon termination of service, death, disability, or attainment of age 59½, a participant may receive benefits or choose to maintain his or her account in the Plan. Participants may elect to receive benefits in a lump sum, partial payments, installments or an annuity. In-service distributions, such as hardship distributions, may be available depending on the individual investment products an account is invested in.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments held by an employee benefit plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under a contract, plus earnings, less participant withdrawals and administrative expenses.

C. Investment Valuation and Income Recognition (Continued)

Purchases and sales of investments are recorded on the trade-date basis. Dividend and interest income are recorded on the accrual basis. Net appreciation includes gains and losses on investments bought and sold as well as held during the year. Net appreciation of investments includes gains and losses on investments bought and sold as well as held during the year.

D. Risks and Uncertainties

Plan investments are exposed to investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - RELATED PARTY TRANSACTIONS

Investments offered under the Plan are issued by TIAA and CREF. Purchases and sales of these securities and payment of investment and administrative fees by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of participants affected by a partial or complete termination of the Plan are non-forfeitable and will be determined as of the termination date.

NOTE 5 - INCOME TAX STATUS

The Company adopted a volume submitter plan that has received an opinion letter from the Internal Revenue Service stating that the form of the Plan qualifies under applicable provisions of the Code. The Company believes the Plan is designed and operated in accordance with and qualifies under applicable requirements of the Code and is exempt from federal income tax.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by TIAA and CREF, the custodians.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Level 1 inputs are based on quoted prices for identical securities in an active market. Level 2 inputs are based on quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Fair value of the Plan investments in non-benefit responsive fixed income annuity contracts issued by TIAA is based on unobservable inputs. TIAA estimates fair value of the contracts based on a formula which depends on the applicable interest rates applied to contributions under the contracts. The following tables summarize Plan investments at December 31 based on inputs used to value them:

The fund seeks to generate favorable long-term returns primarily through rental income and appreciation of real estate and real estate related investments owned by the fund.

NOTE 9 - INVESTMENT CONTRACTS

TIAA investment contracts provided under the Plan include a non-benefit responsive investment vehicle and a benefit-responsive investment vehicle. Participants may enter into individual annuity contracts issued by TIAA that are non-benefit responsive or benefit-responsive. Interest is credited on contributions at a guaranteed rate of 3% plus additional interest that is determined annually but is not guaranteed. The contracts do not allow for plan level redemptions, and redemption restrictions apply to participant investments. Lump sum cash withdrawals are generally not allowed and surrender charges apply in circumstances when lump sum withdrawals are permitted. Participants generally are required to redeem investments in installments over a 10-year period or five annual installments for withdrawals after termination of employment through election of a five-year fixed-period annuity. Repayment of principal and guaranteed interest under investment contracts is backed by the general account of TIAA. The Plan's ability to receive amounts due under investment contracts is dependent on TIAA's ability to meet its financial obligations. There are no reserves against contracts for credit loss.

TIAA has concluded that fair value approximates contract value for non-benefit responsive contracts and are reported at fair value while benefit-responsive contracts are reported at contract value. Contract value equals the accumulated cash contributions, interest credited, net transfers less withdrawals.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 12, 2025, the date on which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosures in these financial statements.
