NOTE 1    PLAN DESCRIPTION

The following description of Community Living Care, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

*General*

The Plan is a defined contribution plan covering all eligible employees of Community Living Care, Inc. (the “Organization”) who are twenty-one (21) years of age and have completed at least one thousand (1,000) hours of service during a twelve (12) consecutive month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent amendments.

*Contributions*

Each year, participants may elect to make voluntary contributions between one percent (1%) and one hundred percent (100%) of compensation, as defined in the Plan, not to exceed the maximum amount allowable under the Internal Revenue Code. Participants who have attained age fifty (50) by the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans.

The Organization may make a matching contribution in an amount and allocation formula as determined by the board, which is equal to one hundred percent (100%) of the participant’s salary deferrals that do not exceed five percent (5%) of compensation for the year ended December 31, 2024.

In addition, the Organization may, in its discretion, make profit sharing contributions. The profit sharing contributions are allocated or divided among participants based on each participant’s compensation to the total compensation of all participants eligible to share in the contribution for the plan year. There were no profit sharing contributions for the year ended December 31, 2024.

*Vesting*

Participants are always fully vested in their voluntary contributions, rollover contributions, and any earnings thereon. Vesting in the Organization’s contributions and earnings thereon is based on years of continuous service, as follows:

Less than 1 year	0%
1 year but less than 2 years	20%
2 years but less than 3 years	40%
3 years but less than 4 years	60%
4 years but less than 5 years	80%
5 years or more	100%

Participants will become fully vested in the Organization’s contributions upon reaching retirement age, or in the event of death or total and permanent disability.

### *Participant Accounts*

Each participant's account is credited with (a) the participant's contribution and related Organization matching contribution, (b) an allocation of the Organization's profit sharing contribution, (c) investment earnings, and (d) charged administrative expenses, to the extent not paid by the Organization. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### *Investment Options*

The Plan is entirely participant-directed and, as such, upon enrollment in the Plan, a participant may direct employee and Organization contributions in any investment option offered in the Plan. Participants may change their investment options at any time. The Plan currently offers a money market fund and various registered investment companies as investment options.

### *Benefits*

In the case of normal retirement, disability, or termination of employment, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In the case of death, a beneficiary may elect to receive a lump sum distribution, or in certain cases, an annuity, equal to the value of the participant's account. Upon reaching age fifty-nine and a half (59 ½), participants may elect to receive in-service withdrawals. The Plan also maintains a provision for hardship withdrawals.

### *Notes Receivable from Participants*

Participants are prohibited from borrowing from their fund accounts.

### *Forfeitures*

Forfeited amounts are used to reduce contributions paid by the Organization or pay administrative expenses. During the year ended December 31, 2024, forfeitures totaling \$7,763 were used to reduce employer contributions.

## NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### *Basis of Accounting*

The accompanying financial statements are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of fair value measurements.

Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### *Payments to Participants*

Benefit payments to participants are recorded when paid.

#### *Administrative Expenses*

Substantially all of the administrative expenses of the Plan are paid for by the Organization.

### NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

- Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities;
- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued based on the closing price of the security as quoted by the principal exchange on which the security is traded, which represents fair value.

Registered investment companies: Shares of registered investment companies are valued at quoted market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4 CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA required supplemental schedule.

**NOTE 5    PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to a participant's account will become fully vested and nonforfeitable.

**NOTE 6    INCOME TAX STATUS**

The Plan adopted a standardized plan sponsored by Fort William, LLC. The standardized plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the standardized plan's qualified status. The standardized plan opinion letter has been relied upon by this Plan. The standardized plan has been amended since receiving the determination letter. However, the plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code. As a result, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. With few exceptions, the Plan is no longer subject to income tax examination by the U.S. federal, state, or local tax authorities for years prior to 2021.

**NOTE 7    RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8    RELATED PARTY TRANSACTIONS**

Plan investments consist of mutual funds managed by American Funds, an affiliate of the Capital Group Companies, Inc. Capital Bank and Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest.

**NOTE 9    SUBSEQUENT EVENTS**

Subsequent events were considered through July 31, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
