Opinion

We have audited the accompanying financial statements of Motor Car Dealers Association of Greater Kansas City Health and Welfare Fund (the Fund) to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of April 30, 2025 and 2024, and the related statements of changes in benefit obligations and of net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE A – DESCRIPTION OF FUND

The following description of the Fund provides only general information. Participants should refer to the Fund agreement for a complete description of the Fund's provisions.

General - The Fund was founded December 1, 1962, and provides health, dental, vision, death, short-term disability, and life benefits to active collectively bargained employees of Automobile Dealers (Dealers) participating in the Standard Automotive Agreement, as well as other dealers who maintain active membership in the Fund. Election by dealers to provide Fund benefits to other than collectively bargained employees requires that participation in the Fund be provided to substantially all active employees of that electing dealer. In no event are retired employees eligible to participate in benefits provided by the Fund. The Fund is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits - The Fund provides health benefits (medical, hospital, surgical, major medical, vision, and dental), short-term disability income, life and accidental death benefits to full-time employees of participating dealers on the employees' first day of the month following the first 30 full days of employment. Employees who leave the employment of participating dealers are eligible for meeting the provisions provided by COBRA in order to extend the eligibility period for Fund benefits. Otherwise, employee eligibility terminates at the end of the month in which the last contribution is made by them on their behalf.

Medical-related benefits are provided by a fully insured insurance contract with Blue Cross Blue Shield of Kansas City. Life, short-term disability and accidental death & dismemberment benefits were provided by Lincoln National Life Insurance Company through December 2024 and USAble Company thereafter. Dental benefits are provided through Metropolitan Life Insurance Company. Vision benefits were provided through The Standard Insurance Company. COBRA administration is provided through P & A Administrative Services.

Contributions - Dealers participating in the Standard Automotive Agreement contribute on covered collectively bargained employees in accordance with provisions of the agreement. Employees of participating dealers not covered by the collective bargaining agreement, who participate in the Fund, participate in accordance with employment provisions provided to them by their respective employer.

At the beginning of each month, contributing employers provide a census of employees who are eligible for participation. The census is the basis of monthly billings to contributing employers who provide coverage for their employees in the corresponding month. Contributions are due on the 15th of the month and delinquent if not paid by the end of the month in which billed.

NOTE A – DESCRIPTION OF FUND (CONTINUED)

Employees may contribute specified amounts, determined periodically by the Fund's insurance companies, to extend coverage to eligible dependents.

The Fund does not provide for or allow retirees to participate in Fund benefits; therefore, no contribution provision is provided for retirees.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits - Health claims and premiums are reported when paid. Any refunds due to overpayments, subrogation, or adjustments are recorded in the period received and are shown netted with benefit payments.

Administrative Expenses - Expenses incurred in the administration of the Fund are paid by the Fund. These expenses include such expense items as legal, accounting, third-party COBRA administrative fees, and reimbursements to the Automobile Dealers Association of Greater Kansas City (the Association) for operating expenditures incurred by the Association on behalf of the Fund.

Post-Retirement Benefits - The Fund does not provide post-retirement benefits.

Subsequent events - Subsequent events were evaluated through August 15, 2025, which is the date the financial statements were issued, and no additional disclosures were required.

NOTE C – CASH AND CASH EQUIVALENTS

Financial instruments that potentially subject the Fund to concentrations of credit risk consist principally of cash and cash equivalent accounts in financial institutions. Cash and cash equivalents exceeding federally insured limits totaled \$2,566,980 at April 30, 2025 and \$2,434,067 at April 30, 2024.

NOTE D – ADMINISTRATION

Administrative services are provided through an agreement with the Association. Administrative expenses are reviewed annually for determination of the estimated amount of operating expenditures that the Association incurs on behalf of the Fund. The trustees agreed that the reimbursement from the Fund to the Association should approximate the estimate of reimbursable costs, but should not exceed the estimated amount. For the years ended April 30, 2025 and 2024 the Fund paid the Association \$25,000 and \$0 in administrative expenses, respectively.

NOTE E – TAX STATUS

The Trust established under the Fund to hold the Fund's net assets is qualified pursuant to Section 501(c) 9 of the Internal Revenue Code, and accordingly, the Trust's net investment income is exempt from income taxes. The Sponsor has obtained a favorable tax determination letter from the Internal Revenue Service and the Sponsor believes that the Trust, as amended, continues to qualify and to operate as designed.

Accounting principles generally accepted in the United States of America require the Fund Administrator to evaluate tax positions taken by the Fund and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Fund is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Fund Administrator believes the Fund is no longer subject to income tax examinations for years prior to 2020.

NOTE F – FUND TERMINATION

Although they have not expressed any intention to do so, the Fund trustees have the right under the Fund to modify the benefits provided to active employees and to terminate the Fund subject to provisions set forth in ERISA. In the event of such termination, the net assets of the Fund should be allocated to pay the benefit obligations of the Fund in accordance with ERISA.

NOTE G – BROKER FEES AND ADMINISTRATIVE SERVICE FEES PAID

Lockton Companies, Inc. (Lockton) provides representational and administrative services to the various insurance underwriters, providing insured benefit coverage, on behalf of the Fund. Lockton is not paid directly by the Fund for these services. However, they are paid through a contractual relationship with the insurer. During the insured year which ended December 31, 2024, Lockton was paid \$81,085 in commissions and \$259,683 in administrative services fees from the insurance companies.
