### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ABC Coating 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the ten-month period ended October 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of October 31, 2024 and December 31, 2023, and for the ten-month period ended October 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. As discussed in Note F to the financial statements, the governing body of the Plan approved to merge the Plan with the ADP TotalSource Retirement Savings Plan, effective October 31, 2024. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

**A. DESCRIPTION OF THE PLAN**

The following description of the ABC Coating 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan established by ABC Coating Co. (the Company) for the benefit of its employees. The Plan was adopted June 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management of the Company is responsible for the oversight of the Plan. Reliance Trust Company serves as the trustee of the Plan. As described in Note F, effective October 1, 2024, The Company merged the Plan with ADP TotalSource Retirement Savings Plan (the Multiple Employer Plan), with all assets transferred or distributed to the Multiple Employer Plan on October 31, 2024. Therefore, the following Plan provisions represent those in place prior to the transfer of all assets.

*Eligibility*

Upon completion of one month of service, Employees are automatically enrolled into the plan at the next plan entry date. A voluntary elective contribution of 1% will be deducted from pay before-taxes and deposited into the Plan's default fund. Employees have the ability to decline automatic enrollment at any time.

*Contributions*

Each year, participants may contribute up to 90 percent of their compensation, as defined by the Plan, up to IRS maximum limits. Salary deferral contributions can be made on a pre-tax basis or directed towards a Roth (after-tax) account. Participants who are projected to be age 50 or older by the end of a calendar year may also make catch-up contributions. Employee rollover contributions are also permitted.

The Plan also provides Safe Harbor matching contributions equal to 100% of participant's elective deferrals that do not exceed 4% of the participant's eligible compensation. Additional amounts may be contributed by the Company under the Plan's nonelective provisions at the discretion of the Company's board of directors. There were no Company nonelective contributions made to the plan in 2024.

Contributions are subject to certain limitations.

*Participant Accounts*

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the funds offered by the Plan and may change the allocation daily. Each participant's account is credited with the participant's contribution, the Company's contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are vested immediately in their contributions and Safe Harbor matching contributions plus actual earnings thereon. Vesting in Company contributions is based upon years of continuous service as follows:

Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

*Notes Receivable from Participants*

Active, eligible participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the vested balance in the participant's account and bear interest based on local prevailing rates available as determined by the plan administrator. Once the loan is granted the interest rate on the loan will not change. Principal and interest is paid ratably through weekly payroll deductions, over a term not to exceed five years (except for loans used for the purchase of a principal residence).

*Payment of Benefits*

Upon retirement, termination, disability, or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take an in-service distribution upon reaching the age of 59 ½. Upon termination, automatic distributions are required for balances of less than \$5,000. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 72.

The Plan allows hardship withdrawals from the participants' 100% vested accounts, subject to account balance limits and applicable laws.

*Forfeitures*

Forfeitures may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During the ten-month period ended October 31, 2024, no previously forfeited amounts were used to reduce Company contributions or pay expenses.

*Administrative Expenses*

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Investment-related expenses are included in net appreciation in fair value of investments.

*Plan Termination*

The Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. See in Note F related to the Plan merger.

**B. SUMMARY OF ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles accepted in the United States of America.

*Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the valuation policies utilizing information provided by the Trustee. See Notes D and E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

*Notes Receivable from Participants*

Loans are valued at their unpaid principal balances, plus any accrued but unpaid interest. Interest income is recognized over the life of the loan based on the stated interest rate. If any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the schedule payment, the loan shall be in default and will be treated as a taxable distribution.

*Payment of Benefits*

Benefits are recorded when paid. There were no benefits requested before year-end that were not paid.

*Administrative Expenses*

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

*Subsequent Events*

Subsequent events have been evaluated through the date of the independent auditor's report, which is the date the financial statements were available to be issued.

**C. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedules of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of October 31, 2024 and December 31, 2023;
- Net appreciation in fair value of investments and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the ten-month period ended October 31, 2024;
- Investment information related to mutual funds and collective trust included in the footnotes as of October 31, 2024 and December 31, 2023 and on the supplemental schedule of assets (held at end of year) as of October 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

**D. FAIR VALUE MEASUREMENTS**

Accounting Standards Codification Topic 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs are not available.

At October 31, 2024, the Plan held no investments.

*Level 1:* Fair values are based on quoted market prices in active markets for identical issues that the Plan has the ability to access at the measurement date. The Plan's investments measured using Level 1 inputs at December 31, 2023 consisted of mutual funds.

*Level 2:* Fair values are based on inputs other than quoted market prices included within Level 1 that are observable for valuing the asset, either directly or indirectly. Observable inputs include quoted prices for similar assets in active or non-active markets. As of December 31, 2023, the Plan did not hold any assets or liabilities measured using Level 2 inputs.

*Level 3:* Fair values are based on unobservable inputs used for valuing the asset. Unobservable inputs are those that reflect the Plan's own assumptions about assumptions that market participants would use in pricing the asset, based on the best information available in the circumstances. As of December 31, 2023, the Plan did not hold any assets or liabilities measured using Level 3 inputs.

**E. INVESTMENTS MEASURED USING THE NET ASSET VALUE PER SHARE PRACTICAL EXPEDIENT**

Investments held by the Plan include a collective trust fund. The collective trust fund is stated at fair value as determined by the issuer of the collective trust fund based on the fair market value of the underlying investments, which is valued at net asset value (NAV) as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

**F. PLAN MERGER**

On October 1, 2024, The Company entered into a merger agreement with ADP TotalSource Retirement Savings Plan (the Multiple Employer Plan), with all assets transferred or distributed to the Multiple Employer Plan by October 31, 2024. The amount transferred out of the Plan totaled \$1,033,525. As of October 31, 2024, all Plan assets had been transferred or distributed.

## **G. TAX STATUS**

The Plan operates under a non-standardized adoption agreement in connection with a prototype profit sharing plan with a cash or deferred arrangement sponsored by ADP, LLC. The Internal Revenue Service advised on October 6, 2020, that the prototype plan constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax exempt as of the date of the letter. The Plan has been amended since the date of the letter; however, the plan administrator believes that the Plan and the related trust is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Generally accepted accounting principles requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **H. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## **I. PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan incurs expenses related to general administration, record keeping and trust administration. These expenses and certain accounting and auditing fees related to the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for these services. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

Certain Plan investments are held in funds of the Plan trustee. Therefore, these transactions qualify as party-in-interest transactions. The Plan paid \$4,909 of recordkeeping fees to the trustee during the ten-months ended October 31, 2024. Certain fees paid by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment.
