Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Preston Chevrolet-Cadillac Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Preston Chevrolet-Cadillac Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note A – Description of Plan

The following description of Preston Chevrolet-Cadillac Inc. 401(k) Plan (the “Plan”) as amended and restated on July 1, 2021 is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

Preston Chevrolet-Cadillac Inc., Preston Ford, Inc., and Preston Lane, LLC (collectively, the “Company”) established the Preston Chevrolet-Cadillac Inc. 401(k) Plan (the “Plan”) effective May 1, 1994.

The Plan is a defined contribution plan covering all full-time employees of Preston Chevrolet-Cadillac Inc. (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

An eligible employee is any person employed by the Company excluding employees who are leased or non-resident aliens with no U.S. income. Employees of the Company are eligible to participate in the Plan on the first day of each month of the plan year, coincident with or next following the date the employee reaches age 21 for deferrals, matching contributions, and employer profit sharing contributions and after completing one year of service in which at least 1,000 hours are worked. Participants must complete at least 1,000 hours of service during the Plan year to be eligible to receive any employer matching contribution.

Contributions

Participants may make voluntary contributions from 1% to 100% of their annual compensation, as described in the Plan agreement. The participant may elect to have their compensation reduced by making contributions to the plan on a pre-tax basis or on an after-tax basis. The total annual participant voluntary contribution is limited to \$23,000 and \$22,500 in 2024 and 2023, respectively. Participants who will be at least age 50 by the end of the year may make additional contributions of \$7,500 and \$7,500 for 2024 and 2023, respectively. Participants may also contribute amounts representing roll-over distributions from other qualified plans. There were no profit sharing contributions in 2024 and 2023. The employer can make discretionary matching contributions to the Plan. The employer made safe harbor and matching contributions of \$499,352 and \$510,957 in 2024 and 2023, respectively.

Participant’s voluntary contributions and employer’s matching contributions are designated under a qualified deferred arrangement as allowed by Section 401(k) and 401(m) of the Internal Revenue Code.

Note A – Description of Plan (continued)

Participants' Accounts

Each participant's account is credited with their voluntary contribution and employer's matching and profit sharing contributions and an allocation of the Plan's net earnings as defined by the Plan.

Plan Assets

The Plan's assets are invested in various mutual funds as administered by the Plan's custodian, Ascensus Trust Company. The participants are responsible for making investment decisions and may direct contributions to any or all mutual funds available.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are 100% vested in the employer's profit sharing and matching contribution and actual earnings after six years of service.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals, with a minimum of \$1,000. In-service distributions are allowed at age 59½.

For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or may continue to participate in the plan investments and benefits will be provided upon retirement or death. If the balance of the vested accounts is \$5,000 or less, payment will be made in a lump-sum without the participant's consent. Hardship distributions are allowed in accordance with the provisions of the Plan.

Forfeitures

Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures will be used to offset the Company's contributions or administrative expenses for the Plan year. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0-. During 2024 and 2023, approximately \$261 and \$6,708 was used to reduce employer contributions or administrative expenses, respectively.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participants total vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's vested account and bear interest at a rate commensurate with prevailing interest rates.

Notes Receivable from Participants (continued)

Principal and interest are paid ratably through payroll deductions. Interest income for 2024 and 2023 totaled \$29,769 and \$18,145, respectively and has been recorded as other income in the accompanying Statements of Changes in Net Assets Available for Benefits.

Plan Costs

Most administrative, investment and audit expenses incurred in connection with Plan are paid by the Plan. The Company, at any time, may elect to pay for all administrative, investment and audit expenses.

Note B – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting. Investment contracts are required to be reported at fair value. However, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transaction under the terms of the Plan. The statements of net assets available for benefits present the fair value of the investment contracts. There was no adjustment of the fully benefit-responsive investment contracts from fair value to contract value, since contract value is the same as fair value.

Investment Valuation and Income Recognition

The investment funds are valued by Ascensus Trust Company at quoted market prices of the underlying securities comprising each fund. The Plan's investment in an investment fund is expressed in "units". A "unit value" is calculated by dividing the value of the entire investment fund by the total number of units in the fund. The value of the Plan's investment in an investment fund is determined by multiplying the number of units held by the Plan by the fund's unit value.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses on investment transactions are recorded as the difference between proceeds received and the investment's fair value at the beginning of the year or acquisition cost if acquired during the year. Unrealized appreciation and depreciation is recorded as the difference between the investment's fair value at the end of the year and the fair value at the beginning of the year, of cost if acquired during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events

Management evaluated all activity of the Plan through July 29, 2025, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

Note C – Information Certified by Trustee

The plan administrator has elected the method of compliance permitted pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations and Disclosures under the Employment Retirement Income Security Act of 1974. Accordingly, Ascensus Trust Company, the plan custodian, has certified that all of the investments and investment-related activity presented in the statements of net assets available for benefits, statements of changes in net assets available for benefits, and the supplemental schedule of assets held for investment purposes are complete and accurate. Such information has not been audited by independent auditors except for comparing such information with the related information included in the financial statements and supplemental schedule as of December 31, 2024 and 2023 and for the years then ended.

Note D – Investments and Fair Value Measurements

FASB ASC 820 requires the Plan to classify its assets and liabilities based on valuation methods using three levels. Level 1 inputs are based on quoted prices in active markets for identical investments. Level 2 inputs are based on quoted prices in active markets for similar investments and quoted prices in inactive markets. Level 3 inputs are based on significant unobservable inputs that reflect the Plan's determination of assumptions that market participants might reasonably use in valuing the investments. The valuation inputs are not necessarily an indication of risk or liquidity associated with the underlying investments.

Note E – Plan Termination

Although it is not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of the Plan termination, participants will become 100% vested in their accounts.

Note F – Income Tax Status

The Plan, a prototype plan, obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Note G – Party-In-Interest Transactions

Certain plan investments are managed by Vanguard. Vanguard is the custodian and recordkeeper as defined by the Plan and, therefore, such transactions qualify as party-in-interest transactions.

Note I – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
