**Note 1 - Plan Description**

The following description of Dixie Chemical Company, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all eligible employees of Dixie Chemical Company, Inc. (the "Company") who have completed three months of service. The Plan does not cover collectively bargained employees, leased employees, and interns. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective June 1, 2024, the American Carbonyl LLC 401(k) Plan was merged into the Plan, and the assets were transferred on November 21, 2024.

Effective January 1, 2024, Dixie Functional Additives, LLC (Functional) and Dixie Specialties, LLC (Specialties) were added to the Plan as adopting employers. Functional and Specialties were newly formed entities in 2024 as a result of a corporate restructuring by the Company. There were no significant changes to the Company's participant base as a result of the restructuring event.

***Contributions***

The Plan provides for employee salary deferral contributions on a pretax or after-tax basis up to a maximum of 50 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer discretionary matching contributions and profit-sharing contributions. The Company has elected to match 100 percent of the participant's contribution not to exceed 6 percent of the employee's deferred compensation. Bonuses, commissions, and other special or extraordinary pay is excluded from the determination of matching contributions. In July 2025, the matching contributions was changed to not exceed 3 percent of the employee's deferred compensation. There were no discretionary profit-sharing contributions made during 2024.

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. In the instance of certain qualified disasters, the limit is increased to \$100,000 or 100 percent of their account balance. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates determined periodically by the plan administrator. All loans must be repaid within a period of 5 years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed 15 years, or unless the loan is used in the instance of a qualified natural disaster. Such loans are secured by a pledge of the participant's account balance in the trust fund and bear interest at the prevailing interest rate charged by banks for similar loans.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

***Vesting***

Participants' contributions, the employer match contribution, and the employer discretionary contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

**Note 1 - Plan Description (Continued)**

***Benefit Payments***

On termination of service due to death, disability, in the instance of certain qualified disasters, for qualified birth of adoption events, retirement, or attainment of 59½ years of age, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities if subject to required minimum distribution rules. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, or as a rollover to another plan that does not exceed the life expectancy of the employee or designated beneficiary.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement. The Company must approve any such hardship withdrawals.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized gains include the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

The Plan's expenses are paid by the Plan or the Company, as provided by the plan agreement.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 7, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Charles Schwab Trust Bank (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

***Money Market Fund***

Money market funds are valued at quoted prices reported in active markets.

***Common/collective Trust Fund***

The common collective trust funds are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

Effective June 1, 2024, the American Carbonyl LLC 401(k) Plan, a plan sponsored by a sister entity of the Company, was merged with the Plan. Accordingly, assets of \$85,737 were transferred into the Plan on November 21, 2024.

**Note 6 - Tax Status**

The Plan has adopted a preapproved plan. The preapproved plan and former prototype plan have received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
