As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of October 31, 2024 and December 31, 2023, and for the period from January 1, 2024 through October 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to benefits provided under the plan and certified by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of TruStile 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As further discussed in Note 1, the Plan was merged into the Marvin Companies Profit Sharing and 401(k) Plan effective November 1, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about TruStile 401(k) Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.
- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, no such opinion is expressed.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about TruStile 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Description of Plan

TruStile Doors, LLC (the Company) is the Plan sponsor for the TruStile 401(k) Plan (the Plan). The Plan was established for the benefit of the eligible employees of the Company. The following description of the Plan provides only general information. Participants should refer to the Plan document effective January 20, 2015, and its Amendments and Restatements, for a more complete description of the Plan's provisions.

General – The Plan was a defined-contribution employee benefit plan intended to constitute a qualified trust under Section 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as Plan administrator. Certain employees of the Company served as the Plan's trustees.

Plan merger – On October 31, 2024, all plan assets were transferred to the Marvin Companies Profit Sharing and 401(k) Plan. The Plan merged into the Marvin Companies Profit Sharing and 401(k) Plan (Marvin Plan) effective November 1, 2024. Effective with the Plan's merger, all participants with an account balance remaining in the Plan were transferred to the Marvin Plan. The Plan's merger also ceased employee and employer contributions into the Plan and ceased new participant notes receivable from the Plan.

Eligibility – Under the terms of the Plan, employees were eligible to participate in the Plan on the first day of the month coincident with or following the next eligibility date after employees reach the age of 21 and completed three months of service measured from their date of hire.

Contributions

Participant contributions – Each year, participants could contribute between 1% and 100% of pretax annual compensation, as defined in the Plan. Participants could have elected to make Roth contributions utilizing after-tax contributions. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. In June of 2024, the Company amended the automatic enrollment provision such that enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

Employer match – The Company matched employee contributions, up to 6% of eligible compensation deferred to the Plan on a tiered basis.

Participant accounts – Each participant's account was credited with the participant's contributions and employer matching contributions, as well as rollovers and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that would be provided from the participant's vested account. Participants directed the investment of their account into various investment options offered by the Plan.

TruStile 401(k) Plan Notes to Financial Statements

Vesting – Participants were vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts was based on years of continuous service. A year of service was counted when an employee registered 1,000 or more hours in a calendar year. Participants vested in the Company’s contributions based on the following schedule:

Notes receivable from participants – Participants were able to borrow from their fund account a minimum of \$1,000 up to a maximum amount of the lesser of 50% of the participant’s vested account balance or \$50,000. The loans were secured by the participant’s vested account balance but not in excess of 50% of such vested account balance. Each loan was to be repaid in equal installments of principal and interest over a period to be determined by the Plan administrator. Such period was not to exceed five years unless the purpose of the loan was for the purchase of the principal residence of the participant in which case the repayment period was not to exceed ten years. As of October 31, 2024, there were no outstanding loans.

Loans receivable from participants were measured at amortized cost, which represents unpaid principal balance, plus accrued but unpaid interest. Delinquent loans receivable from participants were reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. No allowance for credit losses was recorded as of October 31, 2024 or December 31, 2023.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant became fully vested and entitled to a lump-sum distribution. For termination of service due to other reasons, a participant received the value of the vested interest in his or her account as a lump-sum distribution.

At any time, but not more frequently than once a year, a participant with an immediate and critical need was able to request a hardship withdrawal in an amount no greater than was necessary to satisfy such financial hardship. Such request had to be approved by the Company’s benefit administrator.

Investment options – Upon enrollment in the Plan, a participant was able to direct his or her contributions in any of the investment accounts which were sponsored by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan. Participants could change their investment choices at any time and their contribution percentages every pay period.

Forfeitures – Forfeitures were the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures were retained in the Plan and were first used to pay Plan administrative expenses, with any remaining amount used to reduce future Company contributions. As of October 31, 2024 and December 31, 2023, forfeited nonvested accounts totaled \$0 and \$95,038, respectively and \$104,842 was used to reduce employer contributions as of October 31, 2024.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments were reported at fair value and contract value. The Plan's custodians, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, certified the contract value of the Guaranteed Insurance Contract and fair market value of all other investments. If available, quoted market prices were used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Payment of benefits – Benefits were recorded when paid.

Expenses – General plan administrative expenses could be paid out of the forfeiture account, plan expense account, or paid by the Company. Monthly deposits were made to the Plan expense account based on revenue credits from participant accounts. The Plan's expense account paid \$21,802 in investment advisor fees and \$44,842 in investment management fees for the ten-month period ended October 31, 2024. Investment management, distribution, and loan transaction fees were paid by the Plan participants. Expenses incurred during the ten-month period ended October 31, 2024, totaled \$154,850.

Excess contributions payable – Excess contributions payable represent amounts refunded to participants after year-end to comply with regulatory contribution limitations. As of October 31, 2024 and December 31, 2023, excess contributions payable totaled \$0 and \$77,653, respectively.

Subsequent events – Subsequent events are events or transactions that occur after the statements of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statements of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statements of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

TruStile 401(k) Plan Notes to Financial Statements

The Plan has evaluated subsequent events through August 15, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and December 31, 2023.

Note 4 – Guaranteed Investment Contract with Insurance Company

In 2010, the Plan entered into a fully benefit-responsive investment contract (FBRIC) with Empower Annuity Insurance Company of America (formerly Great-West Life & Annuity Insurance Company). Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. Due to the Plan merger described in Note 1, the contract was terminated and the investments were reinvested in the new plan.

The contract meets the FBRIC criteria and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 – Tax Status

The Plan document is a volume submitter defined contribution Plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

Note 7 – Information Certified by the Custodians

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan, have certified to the completeness and accuracy of the following:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of October 31, 2024 and December 31, 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants, reflected on the accompanying statement of changes in net assets available for benefits for the period from January 1, 2024 through October 31, 2024.

Note 8 – Party-in-Interest Transactions

Certain Plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, and, therefore, transactions with these entities qualify as exempt party-in-interest transactions.

Note 9 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested. While the Plan has not officially been terminated, all plan assets were transferred out of the Plan on October 31, 2024 (see Note 1).
