We have performed audits of the financial statements of Alvarez & Marsal Holdings, LLC 401(k) and Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of October 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended October 31, 2024, and the related notes to the financial statements.

Notes to Financial Statements

1. Description of Plan

The following description of the Alvarez & Marsal Holdings, LLC 401(k) and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was adopted by Alvarez & Marsal Holdings, LLC (Alvarez & Marsal) effective April 1, 1984 and was most recently amended and restated effective January 1, 2021. The Plan allows affiliated entities (the Adopting Employers) to adopt the Plan. The Plan is available for qualifying employees of Alvarez & Marsal and Adopting Employers (collectively, the Company).

The Plan was established under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified deferred income arrangement as described in Section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The trustee of the Plan is T. Rowe Price Trust Company (T. Rowe Price or Trustee). The recordkeeper of the Plan is T. Rowe Price Retirement Plan Services, Inc. The administrator of the Plan is the Alvarez & Marsal Holdings, LLC 401(k) and Retirement Plan Investment Committee. T. Rowe Price holds all assets of the Plan in accordance with the provisions of the trust agreement and service provider contract with the Company.

The Board of Managers is responsible for oversight of the Plan. The Alvarez & Marsal Holdings, LLC 401(k) and Retirement Plan Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Managers.

Eligibility

Eligible employees are immediately eligible to participate in the Plan on the first day of each calendar month once hired, if they are an eligible class of employee, as defined in the Plan Document. Employees who have attained 20½ years of age and 1,000 hours of service are eligible for employer nonelective contributions on the first day of the Plan year coinciding with or next following satisfaction of eligibility requirements. Further, employees must be employed on the last day of the Plan year in order to receive the employer nonelective contribution.

Contributions

Participants may contribute, on a pre-tax or Roth after-tax basis, up to 90% of their eligible compensation, as defined by the Plan Document. Participants may make separate elections in excess of payroll period limits for certain bonuses whereby participants may contribute up to 100% of bonus pay. Participant contributions are subject to certain IRC limitations. The Plan also allows catch-up contributions for participants aged 50 or over subject to certain IRC limitations. Salary deferral agreements shall be made, terminated, or changed according to procedures and limitations set up by the Plan administrator and the Plan Document.

Notes to Financial Statements

The Company may elect to make employer nonelective contributions to the Plan. The employer nonelective contribution, if any, is allocated to participants' accounts using a cross-tested employee group allocation formula. The Company made a nonelective contribution in the amount of \$57,581,912 for the year ended October 31, 2024.

Rollover contributions transferred from other qualified retirement plans may also be made subject to certain criteria.

Participants' Accounts

Participants' accounts are credited with the participant's pre-tax, Roth after-tax and catch-up contributions, employer nonelective contributions, and rollover contributions, as well as an allocation of Plan earnings or losses. Participants' accounts are charged with certain administrative fees that are paid by the Plan. Earnings or losses from investment funds are allocated to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option.

Participants may direct the investment of their account balances into various mutual funds and common collective trust funds. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are immediately vested in their participant, rollover, and employer nonelective contributions, plus actual earnings thereon.

Forfeitures

Forfeitures are retained in the Plan and may be used to pay Plan administrative expenses and to reduce future employer nonelective contributions. There were \$2,601 and \$1,029 in forfeitures as of October 31, 2024 and 2023, respectively. During the year ended October 31, 2024, \$43 of forfeitures were used to reduce employer contributions and pay administrative expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and are secured by the balance in the participant's account. All loans must be repaid within a period of five years unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within 15 years. Principal and interest are paid ratably through semi-monthly payroll deductions. A participant's note shall be in default upon the earlier of the date that the participant's benefit election is processed or any scheduled payment remains unpaid beyond the end of the calendar quarter following the calendar quarter in which a payment is missed. Under the terms of the Plan Document, the notes bear interest equal to the prime rate plus 1% and are fixed for the duration of the note. As of October 31, 2024, the rates of interest on outstanding loans ranged from 4.25% to 9.50%.

Payment of Benefits

Upon termination of service due to separation of service, death, disability, or attainment of normal retirement age (65), a participant may elect to receive their benefit payment in the form of a lump-sum amount or installment payments equal to the value of the participant's vested interest in his or her account. A participant may remain in the Plan or may roll over the amount to another qualified retirement plan or individual retirement account. Hardship withdrawals and certain other in-service withdrawals at age 59½ are also permitted by the Plan if certain criteria are met. Participants with an account balance of \$5,000 or less are rolled over directly to an individual retirement account maintained by a provider selected by the Company unless the participant makes an affirmative election for distribution.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as further discussed in Note 4, *Fair Value Measurements and Disclosures*. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date exit price. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustee.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income and capital gains are recorded on the ex-dividend date. The net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses (in the form of an expense ratio) charged to the Plan for investments in the mutual funds and common collective trust funds are deducted from income earned on a daily basis and reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest was de minimis at October 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid directly by the Company and are excluded from these financial statements. The Plan engages an independent investment advisor, auditor, trustee, and attorney on a fee-for-service basis. Fees related to the administration of notes receivable from participants and certain benefit payments are charged directly to the participant's account and are included in administrative expenses. Under the service provider agreement with T. Rowe Price, certain revenue-sharing rebates received from certain mutual funds held by the Plan reduce recordkeeping fees. Fees in excess of rebates are charged to the Plan. Investment-related expenses (in the form of an expense ratio) are included in net appreciation in fair value of investments.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price, a qualified institution, has certified that the following information included in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) is complete and accurate:

- Investments and notes receivable from participants as reported in the statements of net assets available for benefits as of October 31, 2024 and 2023.
- Interest and dividend income, net appreciation in fair value of investments, and interest earned on notes receivable from participants as reported in the statement of changes in net assets available for benefits for the year ended October 31, 2024.
- Certain investment amounts included in the notes to financial statements.
- All investment amounts included in the supplemental Schedule of Assets (Held at End of Year) as of October 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements and Disclosures

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). Level 1 inputs are quoted market prices in active markets for identical investments that the Plan has the ability to access at the measurement date. Level 2 inputs are inputs other than quoted market prices included within Level 1 that are observable for the Plan's investments, either directly or indirectly. Level 3 inputs are unobservable inputs for the Plan's investments.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. Valuation methodologies at October 31, 2024 and 2023 are consistent between years presented.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds (CCTs)

Target Date Funds - The T. Rowe Price Target Date Retirement Funds are determined at the close of each business day at unit value (NAV as a practical expedient) and based on the fair value of the underlying investments. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Units are issued and redeemed only on a valuation date and at the NAV per unit computed on that date. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require a 30-day notification in order to ensure that securities liquidations will be carried out in an orderly business manner. These funds are direct filing entities.

Mid Cap Value Fund - The CCT is valued at the NAV of units held. The NAV, as provided by the trustee of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell for an amount different than the reported NAV. The fund is a direct filing entity.

Stable Value Fund - The T. Rowe Price Stable Value Common Trust Fund is a stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of the units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the fund, the issuer reserves the right to require a 12 to 30 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. The stable value fund is a direct filing entity.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Party-in-Interest and Related Party Transactions

The Plan invests in a mutual fund and units of common collective trust funds managed by T. Rowe Price. Certain investment fees are paid to T. Rowe Price and are reflected within the net investment gain for the year. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts. The Plan also pays fees to T. Rowe Price, legal counsel, the investment advisor, and auditor. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

During the year ended October 31, 2022, \$4,871 of administrative fees were inadvertently paid to the Plan sponsor, which resulted in a non-exempt transaction with a party-in-interest. The Plan administrator is in the process of reimbursing the Plan for the non-exempt transaction amount and will calculate and remit any related lost earnings as soon as administratively feasible. See the Schedule of Non-Exempt Transactions for the year ended October 31, 2024.

6. Income Tax Status

The Company adopted a T. Rowe Price Pre-Approved Volume Submitter Plan Document (Volume Submitter Plan) effective January 1, 2021. The sponsor of the Volume Submitter Plan received an advisory letter from the Internal Revenue Service (IRS) dated August 19, 2020, indicating that the Volume Submitter Plan is designed in accordance with the applicable sections of the IRC.

The Company and the Plan administrator believe that the Plan, as amended, is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt as of the financial statement date, and no provision for income taxes has been included in the accompanying financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

7. Concentrations, Risks, and Uncertainties

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions and may be adversely affected by shifts in the market perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' account balances.

As of October 31, 2024 and 2023, there was one investment held in both periods, which individually accounted for more than 10% of net assets available for benefits. See the supplemental Schedule H, Line 4i, Schedule of Assets (Held at End of Year) for a complete listing of investments held at October 31, 2024.

8. Subsequent Events

The Plan has evaluated subsequent events through August 14, 2025, the date the financial statements were available to be issued. There were no events or transactions discovered during the evaluation that requires recognition or disclosure in the financial statements.
