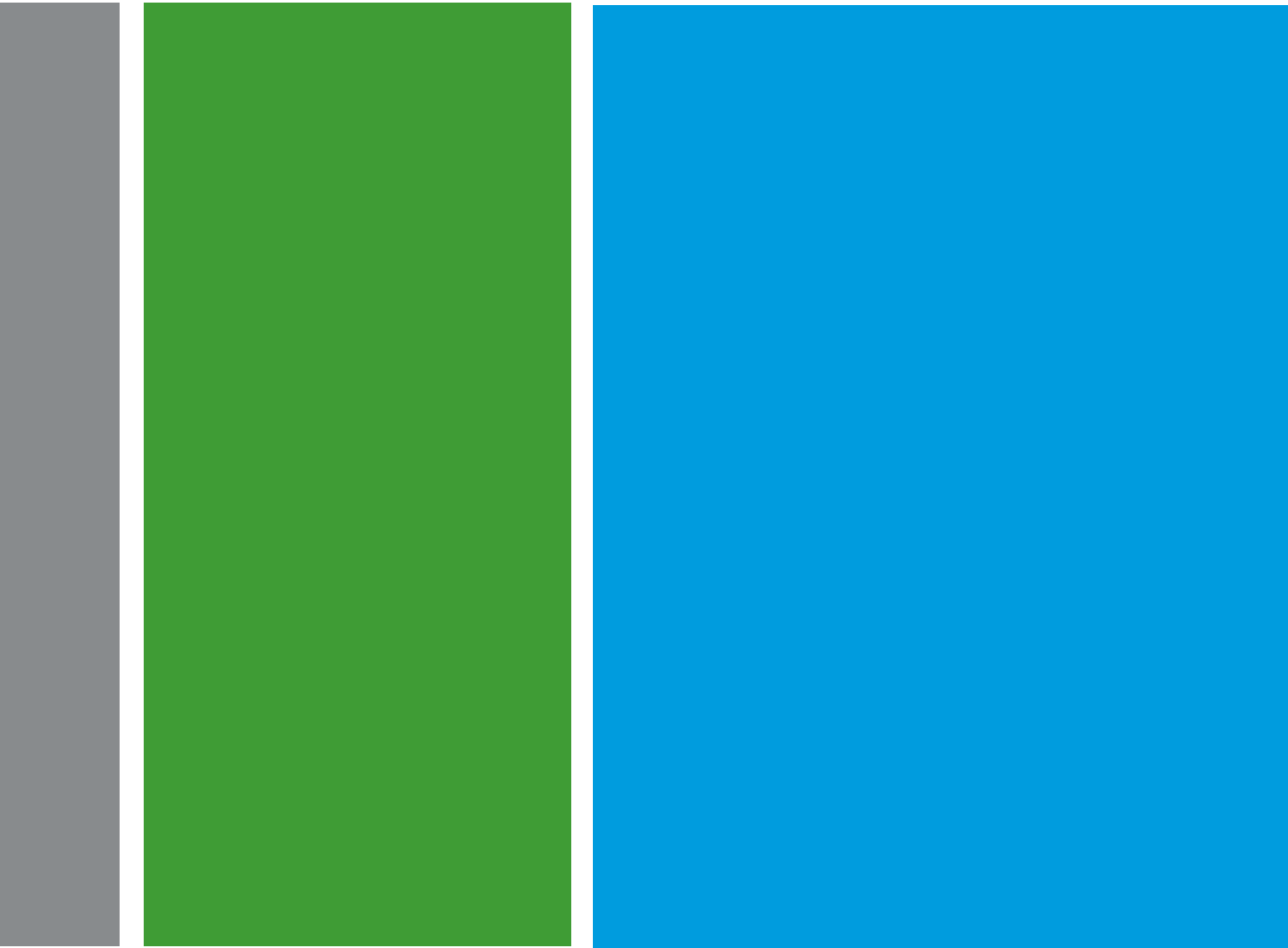

INDEPENDENT AUDITORS' REPORT

To: The Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Combe Products Employees Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Combe Products Employees Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS December 31, 2024 and 2023

Note 1 – Description of Plan

The following description of Combe Products Employees Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a detailed description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Combe Products, Inc. (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees who are regularly scheduled to work 20 hours or more per week are generally eligible to participate in the Plan on the first pay period of the month following their date of hire. Employees who are regularly scheduled to work less than 20 hours per week shall be eligible to participate in the Plan on the first pay period of the month following the completion of one year of service, provided they worked at least 1,000 hours of service during the one year of service. If an employee elects not to participate, they must complete and submit an opt-out form to discontinue plan contributions.

Contributions: Pre-tax contributions are limited to \$15,000, as established by Act No. 1 of January 31, 2011, Section 1081.01 (d) (7) (A) (i) of the Puerto Rico Internal Revenue Code (the Code), as amended. In addition, a participant who has attained age 50 by the end of a calendar year, may elect to make catch-up contributions up to the \$1,500 limit established by Section 1081.01 (d) (7) (C) (i) of the Code.

The Employer automatically contributes from 3% to 11% of each participant's eligible pay (Non-elective Profit Sharing Contributions) based on the participant's age at January 1st of each year. Effective January 1, 2026, the Non-elective Profit Sharing Contributions will be 5% of participant's eligible pay, regardless of age. The Employer also makes a matching contribution equal to 100% of the first 5% of eligible pay that a participant contributes. For the year ended December 31, 2024, total annual contributions made by the Employer and participants were limited to the lesser of \$69,000 or 100% of the total compensation paid by the Employer to participant during the Plan year, as provided in the Code, Section 1081.01 (a) (11) (B) (i).

Within the Plan rules, participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributions are invested in accordance with each participant's investment election.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. Allocation of the participant's and Employer's contribution are based on the participant's investment election. Allocations of Plan earnings are based on account balances, as defined. The benefit to which a participant is entitled under the Plan is the balance of the participant's account.

Vesting: Participants are vested immediately in their contributions and Employer's matching contributions plus actual earnings thereon.

Effective January 1, 2022, those employees with over one (1) year of service have employer non-elective profit-sharing contributions vesting of 100%; those employees with less than one (1) year of service have no vesting.

In addition, effective January 1, 2022, the Plan set-up a frozen employer profit sharing contribution source which is immediately 100% vested and is available for in-service withdrawals upon reaching the age of 59 ½ and is both lienable and available for participant loans in the Plan. All profit sharing contributions funded as of December 31, 2021 were transferred into this frozen employer contribution source. Any profit sharing contribution funded as of January 1, 2022 and forward is not lienable and not available for participant loans in the Plan.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their account balance, excluding the balance of any profit sharing funded from January 1, 2022 and forward. The Plan allows a participant to have only one loan outstanding at any time. The \$50,000 loan limit is reduced by the participant's highest outstanding loan balance in the past twelve months. Loans are secured by the balance of the participant's account. Loans in existence prior to February 2020 bear interest at a rate equal to the prime rate plus 1%, which was reset on June 30 each year and remained constant throughout the life of the loan. Effective February 1, 2020, the Plan modified the Participant Loan Program, whereby the interest rate on loans will be based upon the prime rate plus 1% and will be set monthly as soon as administratively feasible. Once the loan is approved and the interest rate established, the interest rate will remain unchanged during the term of the loan, except as otherwise required by law. Loans are repaid ratably over a period not to exceed 5 years through payroll deductions and allocated to the various investment funds based on the participant's investment elections at the time of repayments. The administration of participant loans is done by the record-keeper.

Payment of benefits: Upon the retirement of a participant for age or disability or upon termination of employment, the participant shall be entitled to the payment of the balance in its participant account in one lump-sum distribution. The participant may also request to have the balances in his/her accounts to be paid in several partial or periodic distributions. These distributions can be made up to a maximum of twice per year.

Also, a participant may request, at the time and manner prescribed by the Employee Benefits Committee, to have all or part of a lump sum distribution from the Plan paid directly to a Puerto Rico Eligible Retirement Plan in a direct rollover, as provided by the Code, Section 1081.01(b)(2)(A).

If a participant dies after the installment distribution of his interest has begun, the remaining portion of such interest will continue to be distributed at least as rapidly as under the method of distribution being used prior to the participant's death. If a participant dies before distribution has begun, the balance in the participant's account shall be paid in a single sum on or before the 60th day after the Plan year in which the death occurs to the designated beneficiary (or beneficiaries).

Forfeitures: Forfeitures may be used to reduce the Employer's contributions.

Hardship withdrawals: Under the provisions of the Plan, participants are permitted to withdraw an amount not to exceed their total vested balance only if financial hardship, as defined by the Plan Document, is demonstrated, and is approved by the Plan Administrator.

Administrative expenses: Certain administration expenses of the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits.

Note 2 – Summary of Significant Accounting Policies

The Plan's significant accounting policies are as follows:

Basis of accounting: The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments valuation and income recognition: Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. As of December 31, 2024 and 2023, the interest rate on outstanding notes receivable ranges from 4.25% to 9.50%.

Contributions: Employees' contributions are recorded in the Plan year in which the Employer makes the payroll deductions from the participant's earnings.

Payment of benefits: Payment of benefits are recorded upon distribution.

Risks and uncertainties: The Plan's investments are exposed to several risks, such as interest rate fluctuations, market volatility and credit risk. Due to the level of risk associated with certain investment securities, it is possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the Plan's account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

Note 3 – Information Certified by Reliance Trust Company

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Reliance Trust Company (the Custodian) and furnished to the Plan Administrator.

The Plan Administrator has obtained certifications from the Custodian that information provided to the Plan Administrator by the Custodian related to the following assets is complete and accurate. Accordingly, as permitted by ERISA section 103(a)(3)(C) pursuant to CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

As of December 31, 2024 and 2023, the Plan's investments consisted solely of mutual funds registered with the Securities and Exchange Commission and are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are considered Level 1 investments within the fair value hierarchy.

Note 5 – Tax Status

The Plan obtained a tax determination letter from the Puerto Rico Treasury Department dated December 20, 2013, indicating that it had been designed in accordance with applicable sections of the Commonwealth of Puerto Rico's income tax law and is, therefore, exempt from Puerto Rico income taxes.

The Plan covers participants in Puerto Rico only and is generally exempt from federal income tax requirements applicable to tax-qualified retirement plans. However, Plan assets are invested in a trust formed in the state of New York. As a result, the portion of participant distributions attributable to trust earnings may be subject to federal income tax. Management has engaged legal counsel to address this issue with the IRS and is working to resolve the matter.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination of taxing authorities. The Plan Administrator evaluated the tax positions taken by the Plan and concluded that the Plan as of December 31, 2024 and 2023, has maintained its Puerto Rico tax exempt status and had taken no uncertain tax positions that would require adjustments or disclosures to the financial statements. Therefore, no provision or liability for income taxes for the Plan has been included in the financial statements. The Plan is subject to routine audits by the Puerto Rico Treasury Department. As of December 31, 2024, the years 2020 and thereafter remained subject to examination; however, there are currently no audits for any tax periods in progress.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan provisions to discontinue its contributions at any time and/or to terminate the Plan subject to the provisions of ERISA.

Note 7 – Party-in-Interest Transactions

Combe Products, Inc., Reliance Trust Company, Spectrum Investment Advisors, and ADP Retirement Services are each a party-in-interest as defined by ERISA. There were no prohibited party-in-interest investments or transactions.
