**Note 1 – Description of the Plan**

The following brief description of the ML Automotive Group, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of ML Automotive Group, LLC and its affiliates collectively referred to herein as (the “Employer”). Affiliated companies covered by the Plan include the following:

- NM1, LLC (d/b/a Palmetto57 Nissan),
- VW1, LLC (d/b/a Palmetto57 Volkswagen),
- JLR Treasure Coast, LLC (d/b/a Jaguar Treasure Coast and Land Rover Treasure Coast)

The Plan covers all employees who have completed six months of service and are age eighteen or older. The Plan was established on December 1, 2012 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Administrator and Trustee

The Plan administrator, and trustee are as follows:

Plan Administrator – ML Automotive Group, LLC

Third Party Administrator – Automatic Data Processing, Inc. (ADP)

Trustee – Reliance Trust Company

Eligibility Requirements

Employees who are eighteen years of age or older, have completed six months of service and have reached the entry date are eligible to participate in the Plan. Employees will receive credit for one month of service for each month in which they complete at least one hour of service. An hour of service is any hour for which the employee is paid or is entitled to payment. The entry date will be the first day of the month immediately following or coincident with the date the employee completes eligibility requirements.

Requirements for Contributions

Participants may elect to defer a portion of their annual compensation, as defined by the Plan and consistent with the IRS guidelines. Participants may elect to make contributions to pre-tax and Roth 401(k) deferral accounts. Additionally, participants may rollover or transfer to the Plan any portion or all of the funds received from another nonaffiliated qualified retirement plan (rollover contribution). At any time, an employee can elect not to make contributions. Participants that reach age 50 before the end of the calendar year may make additional catch-up contributions.

Participants direct their elective contributions into various investment options offered by the Plan. The Employer’s contributions are allocated in the same manner as that of the participant’s elective contributions. Participants may change their investment options and deferral percentages or amounts at any time.

**Note 1 – Description of the Plan (continued)**

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a default investment selected by the Plan Sponsor until changed by the participant.

In addition, the Employer makes a matching contribution of 25% of each participant's salary deferrals up to the first 4% of eligible compensation. The Employer made matching contributions of \$118,130, net of forfeitures of \$12,349, for the 2024 plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of (a) the Employer's matching contributions, and (b) the Plan's earnings. Allocations of earnings are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant accounts are reduced by the number of withdrawals made by the participant during the plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon retirement, disability, death, termination of employment, reaching 65 years of age (Plan's normal retirement age) or age 59 (Plan's early retirement age), distributions are made to participants in the form of a lump sum distribution or in installments if the participant is subject to required minimum distributions.

Also, an automatic mandatory lump sum distribution will be made to those participants who have a vested benefit that does not exceed \$5,000 upon termination of their employment. The non-vested balance, if any, reverts to the Plan. As further described in the Plan document, early withdrawals are generally limited to cases involving financial hardship. In the event of a hardship, participants may withdraw the funds from all their accounts.

Vesting Percentage

Participants are immediately vested in their elective deferrals and transfer contributions plus actual earnings thereon.

Participants are generally vested in the Employer’s matching and discretionary contribution portion of their accounts plus actual earnings thereon based on years of vesting service as follows:

Participants are 100% vested in the Employer’s matching contribution if they are employed on or after their normal retirement age of 65, or if a participant incurs a severance of employment as a result of death or disability.

Forfeitures

The non-vested portion of fund assets allocated to a participant’s account is forfeited upon termination of service. The forfeitures may first be used to reduce future Employer contributions. During the year ended December 31, 2024, Employer contributions were reduced by \$12,349 due to forfeitures of non-vested fund assets.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into any of several investment options including various registered investment companies. Participants may change their investment options at their discretion.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent (50%) of the fair value of the portion of the non-forfeitable or vested accrued benefit of their account, whichever is less. The loans are secured by the balance in the participant’s account and bear interest at rates equal to the prime rate plus two percent (2%). Principal and interest is paid ratably through monthly payroll deductions for a period not to exceed five years unless the purpose is a home loan, which is for a period not to exceed 30 years.

Plan Amendments

There were no amendments to the Plan during the year ended December 31, 2024.

**Note 2 – Significant Accounting Policies**

Basis of Presentation

The accompanying financial statements are presented using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates and assumptions.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold as well as held during the plan year.

Distributions Payable

Distributions Payable represent amounts owed to participants who have requested or are otherwise entitled to receive benefits under the Plan terms as of year-end.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Employer has evaluated subsequent events and transactions for potential recognition or disclosure through July 29, 2025, which is the date the financial statements were available to be issued. See Note 11.

**Note 4 – Fair Value Measurements**

FASB Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered Investment Companies:* Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end.

*Common/Collective trust fund:* Invesco Stable Asset Trust Fund (“Stable Asset Trust Fund”) is a common/collective trust fund that invests principally in synthetic guaranteed investment contracts, and short-term investment funds which are intended to preserve principal and to provide interest income reasonably under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The Plan’s investment in the Stable Asset Trust Fund is valued based on the Plan’s share of the underlying net assets. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment. Issuances and redemptions of participant units are made daily.

**Note 4 – Fair Value Measurements (continued)**

The Stable Asset Trust Fund is valued at the net asset value (NAV). NAV represents shares held by the Plan at year end adjusted for any cash held for liquidity purposes and any fees imposed by the fund. The NAV per unit is determined by dividing the net assets by the number of units outstanding on the day of valuation. There is no unfunded commitment. The Plan may redeem units at any time upon 10 business days' notice at the lesser of the market value or the book value of the redeemed units. Were the Plan to initiate a full or partial redemption of the Stable Asset Trust Fund, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its matching contribution at any time and to modify, suspend or terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants would become 100% vested in their Employer contributions.

**Note 6 – Tax Status**

In a letter dated October 6, 2020, the Internal Revenue Service determined that the prototype non-standardized profit-sharing plan which this Plan has been based on has been designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is designed and is currently operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is not subject to income tax examinations for years prior to 2022.

**Note 7 – Distributions Payable**

As of December 31, 2024, the Plan approved a benefit payment to a participant totaling \$25,580 that had not yet been disbursed. This amount is included in distributions payable in the accompanying statements of net assets available for benefits and represents the amount owed to a participant who had requested or was otherwise entitled to receive benefits under the Plan terms. This distribution was paid subsequent to year-end.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

**Note 9 - Party-in-Interest**

Parties in interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. Automatic Data Processing, Inc. (“ADP”) is the Plan’s third-party administrator. The Plan holds registered investment accounts with Reliance Trust Company that utilizes an affiliate broker dealer of ADP. Reliance Trust Company is the Plan’s Trustee and, therefore, these transactions and the payment of record keeping fees, custodian fees, and investment management fees qualify as party-in-interest transactions. Notes receivable from participants held by the Plan also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Employer.
