We have performed audits of the accompanying financial statements of Sensidyne, LP 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Notes to Financial Statements

December 31, 2024 and 2023

1. Plan Description

The following description of the Sensidyne, LP 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of Sensidyne, LP and OHD, LLLP (collectively, the "Company") who have completed three months of service and are age 18 or older. The Plan excludes leased employees and employees covered by a collective bargaining agreement. Participants may enter the Plan on the 1st day of the month following the date that the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974. The original effective date of the Plan was May 1, 2008.
- b) *Contributions* – Each year participants may contribute to the Plan up to the maximum amount allowed by law, subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans (rollover contributions). Contributions may be made by participants before tax or post-tax (Roth). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation.

The Company contributes a safe harbor matching contribution of 4% of eligible compensation that a participant contributes to the Plan. The Company made matching contributions of \$326,826 in 2024. The Company may also make discretionary profit sharing contributions. No profit sharing contributions were made for the year ended December 31, 2024.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or website.

- c) *Participants Accounts* – Each participant's account is credited and/or reduced with the participant's contributions and withdrawals, safe harbor matching or profit-sharing contributions, and allocations of Plan earnings and losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or

charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- d) *Vesting* – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is vested 33% after one year of service, 67% after two years of service and 100% after three years of service.
- e) *Notes receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at 1% above prime rate. Participants are allowed to have only one loan outstanding at any time. The interest rates on loans outstanding as of December 31, 2024, ranged between 4.25% and 9.5% and mature through 2030. Principal and interest is paid ratably through payroll deductions.
- f) *Payment of Benefits* – Immediate distributions may be made at participants' election upon termination of employment in a lump sum payment. The normal retirement age is the date a participants attains age 65. In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution. The Plan allows hardship withdrawals.
- g) *Forfeited accounts* – Forfeitures of nonvested balances may be used to pay Plan expenses or reduce employer matching contributions. At December 31, 2024 and 2023, the Plan had nonvested forfeited accounts of \$10,072 and \$8,356, respectively. No amounts were used to pay plan expenses or reduce employer matching contributions during 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the

reporting period. Actual results could differ from those estimates.

Investments, Investment Valuation, and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The three levels of inputs that may be used to measure fair value are:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other-than-quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and,

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Interest Bearing Cash – The carrying value approximates fair value and is classified within Level 1 of the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make scheduled repayments and the Plan administrator deems the participant to be in default, the participants note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

6. Risks and Uncertainties

The Plan invests in various investment options in investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

7. Party-in-Interest Transactions

The Plan paid Csenge Advisory Group, LLC, a party-in-interest, \$47,126 for investment management services in 2024, and paid \$12,859 in contract administration fees to PCS Retirement LLC, a party-in-interest.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. Tax Status

The Plan is a pre-approved defined contribution plan ("Pre-approved Plan") sponsored by PCS Retirement LLC ("PCS Retirement"). PCS Retirement obtained its latest opinion letter dated June 30, 2020, in which the IRS stated that the Pre-approved Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and accordingly is exempt from taxation. Therefore, no provision for income taxes has been included in the Plan's financial statements.
