We have performed audits of the financial statements of The Christman Company Profit Sharing Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Plan Description

The following description of The Christman Company Profit Sharing Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that provides benefits to eligible participants according to the provisions of the plan document. The Plan covers the employees of The Christman Company; Christman Constructors, Inc.; Christman Mid-Atlantic Constructors, LLC; Christman Millwork, LLC; Christman Facility Solutions LLC; and Christman Building Innovation Group. Collectively, these entities are referred to herein as the "Company." The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Employees not covered under a collective bargaining agreement and employees who are not interns are eligible to participate in the Plan if they are 21 years of age and have completed one month of service. Eligible employees can receive employer safe harbor contributions if they are 21 years of age. Eligible employees can receive profit-sharing contributions if they are 21 years of age and have completed one month of service.

#### **Contributions**

The Plan provides for elective deferral contributions by participants, subject to the limitations contained in the Internal Revenue Code, and an employer safe harbor contribution of 3 percent of the participant's compensation. The Plan also allows for an employer discretionary profit-sharing contribution. During 2024, there were safe harbor and profit-sharing contributions made to the Plan by the Company of approximately \$2,556,000 and \$4,916,000, respectively. Contributions to the Plan are invested as directed by the participants in any one or more investment alternatives. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and the participant's share of the Company's contributions. Allocation of plan earnings and expenses to a participant's account is based on the participant's proportionate share of funds in each of the investment accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Participant Notes Receivable**

Participants may borrow from their accounts up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### **Forfeitures**

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions.

#### ***Vesting***

Participants are immediately vested in elective deferral employee contributions and earnings thereon, as well as employer safe harbor contributions. A participant is vested in employer discretionary contributions based on the following schedule:

Participants become fully vested in employer discretionary contributions upon the participant's 65th birthday, which is the normal retirement age per the plan document.

#### ***Benefit Payments***

Upon termination of service, a participant may receive his or her account balance in a lump sum or installment payments over his or her life expectancy. In the event of an employee's death, the entire account balance will be paid to the participant's named beneficiary. In-service withdrawals may be taken by participants starting at age 55 from vested employer contributions. At the age of 59½, in-service withdrawals may be taken from all sources.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances, and net assets of the Plan will be allocated, as prescribed by ERISA and its regulations.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company or its affiliates. Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value.

The common collective trust funds and the pooled separate account are valued at net asset value (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices. See Note 4 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 2 - Summary of Significant Accounting Policies (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Certain expenses to administer the Plan in 2024 were paid by the Company on behalf of the Plan.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including July 30, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.
