NOTE 1: DESCRIPTION OF PLAN

The following description of The Guidance Center Tax Sheltered Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

A. General

The Plan is a 403(b) tax-sheltered annuity retirement plan covering substantially all employees of The Guidance Center (the "Agency").

Employees of the Agency are eligible to participate in elective salary reduction deferral (employee) contributions immediately upon hire by the Agency.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective September 7, 2017, the Plan was amended and restated to comply with final regulations under section 403(b) of the Internal Revenue Code of 1986, as amended, and to make certain other changes. The amendments did not have a significant effect on benefits or net assets.

B. Plan Termination

On May 16, 2024 participants of the Plan were given notice that the Plan would be terminated effective July 1, 2024, at which time they would have the opportunity to rollover their account balances into the newly created Guidance Center 401(k) Plan.

C. Contributions

Employee contributions are elected as a deferral of eligible compensation. A participant's includible compensation means any salary, wages or other remuneration that is includible in his gross income for federal tax purposes less any bonuses received, plus any salary reduction contributions that are not includible in his federal gross income, including salary reduction contributions to the Plan.

Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers various mutual fund options for participants. Annual contributions are subject to certain limitations under the Internal Revenue Code.

D. Participant Accounts

Each participant's account is credited with their allocations of the employee's contribution and Plan earnings, and charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

E. Vesting

Participants are vested immediately in all employee contributions plus actual earnings thereon.

F. Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest rates that are commensurate with rates charged by other lenders on similar loans. Current interest rates are 9.50%. Loan repayments are made ratably through payroll deductions over a period not to exceed 5 years, unless the loans were used to purchase a primary residence, in which case the loan terms may exceed 5 years. Effective July 1, 2024, an outstanding loan shall not be due and payable when the Plan terminates to the extent a participant with an outstanding loan balance elects a direct rollover of an eligible rollover distribution that includes a loan note to another qualified plan, in accordance with nondiscriminatory procedures set up by the loan administrator.

G. Payment of Benefits

Plan benefits begin at the normal retirement age of 65, however, in service distributions can commence upon age 59 ½. Participants who have attained their retirement age shall have a 100% non-forfeitable right in the value of their account. Upon termination of employment due to death, disability, retirement, or other separation participants or their beneficiary may elect to receive an amount equal to the value of the participant's interest in his or her account in a lump sum payment or in annual installments over a period of not more than the participants assumed life expectancy. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

H. Related Party Transactions

Plan investments consist of shares of mutual funds and annuities managed by Principal Life Insurance Company. Principal Life Insurance Company is the trustee of the Plan and, therefore all transactions qualify as party-in-interest transactions exempt from prohibited transaction rules.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements have been prepared on the liquidation basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP). Effective July 1, 2024, the Agency adopted an amendment to terminate the Plan. As a result, the Plan's financial statements as of October 16, 2024 and December 31, 2023 and for the period and year then ended, have been prepared on the liquidation basis, in accordance with U.S. GAAP. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets is reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. The estimated net realizable cash value for investments as of October 16, 2024 and December 31, 2023 would be equivalent to fair value.

B. Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the loan to be in default, the loan balance is reduced, and the delinquent participant loan receivable is recorded as a benefit payment based on the terms of the Plan Document.

E. Payment of Benefits

Benefits are recorded when paid.

NOTE 3: PLAN ADMINISTRATION

The Plan is administered by the Agency. The Plan is responsible for payment of all administrative expenses. For the period ended October 16, 2024 and year ended December 31, 2023, such expenses totaled \$6,929 and \$1,207 respectively. All other administrative costs (i.e. payroll costs related to administration of the Plan) are paid by the Agency and not a deduction from Plan net assets.

NOTE 4: TAX STATUS

In a letter dated March 31, 2017 the Internal Revenue Service (IRS) stated that the Plan's prototype plan document, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's Tax Counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE 4: TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained up examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5: INVESTMENTS AND FAIR VALUE MEASUREMENTS

During 2024 and 2023, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$624,002 and \$913,993, respectively. Interest income on the guaranteed investment contract and loans receivable were \$4,869 and \$875 during 2024, respectively, and \$23,787 and \$1,291 during 2023, respectively. Dividends received in 2024 and 2023 were \$38,385 and \$74,492, respectively.

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 5: FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 16, 2024 or 2023.

*Registered Investment Companies:* Mutual funds with Principal Life Insurance Company are valued at the net asset value (NAV) of shares held by the plan at year end, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan had no assets at fair value as of October 16, 2024. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2023:

NOTE 6: INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan had a group annuity investment contract with Principal Life Insurance Company. Principal Life Insurance Company deposits participant contributions to this contract in a general account. The account is credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses. The contract was included in the financial statements at contract value as reported to the Plan by Principal Life Insurance Company. Contract value represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value approximates fair value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at October 16, 2024 and December 31, 2023 was \$0 and \$1,253,819. All contributions and transfers to the contract earned interest at the guaranteed rate in effect at the time of the contribution or transfer. All monies in the investment contract will earn interest at the guaranteed rate until the guaranteed rate is changed. Principal Life Insurance Company may declare a new guaranteed rate for the investment contract that becomes effective on January 1<sup>st</sup>. The guaranteed interest rate as of December 31, 2023 was 1.70%.

NOTE 6: INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 8: CERTIFIED FINANCIAL INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants at October 16, 2024 and December 31, 2023 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period and year ended October 16, 2024 and December 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal (the trustee/custodian) of the Plan.

At the request of the plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements.

NOTE 9: SUBSEQUENT EVENTS

Subsequent Events have been evaluated through August 15, 2025, the date the financial statements were available to be issued.
