## INDEPENDENT AUDITORS' REPORT

To the ATS Construction 401(k) Retirement Plan  
and Participants

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ATS Construction 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ATS Construction 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Description of Plan**

The following brief description of the ATS Construction (the “Company”) 401(k) Retirement Plan (the “Plan”), is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

**General**

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). The Plan is administered by a trust, the trustee of which is Empower Trust Company, LLC.

**Eligibility**

The Plan covers substantially all employees of L-M Asphalt Partners, Ltd., dba ATS Construction, L-M Holdings, Inc, Central Bridge Company, LLC, ATS Asphalt Terminal, LLC, Stone Creek Farm Ltd., L-G Haulers and Walker Construction & Materials, LLC (collectively referred to herein as the “Companies”). The employees are eligible immediately following the date the employee performs an hour of service and employees may enter the Plan immediately after becoming eligible.

**Contributions**

Each year, participants are permitted to contribute a portion of their total annual eligible compensation, as defined in the plan agreement, as a before-tax salary deferral contribution not to exceed the maximum allowable under Internal Revenue Service Regulations. The Companies may, at their discretion, make a matching contribution each Plan year on behalf of eligible participants. The total contribution to a participant’s account for the Plan year cannot exceed the maximum limit determined by Internal Revenue Service regulations.

**Davis-Bacon Act**

The Company provides an employer contribution for each eligible participant who performs Davis-Bacon Act Service. Davis-Bacon Act Service is any service performed by an employee under a public contract subject to the Davis-Bacon Act, or to any other federal, state or municipal prevailing wage law. There is no minimum age or length of service requirement, and employees are immediately eligible to participate as of their date of employment.

**Investment Options**

Participants may, upon enrollment in the Plan, elect to invest their contributions and any Company contributions in any or all of the various funds currently offered by the Company. The Plan also allows individual investment direction among any allowable investments through self-directed brokerage accounts.

Periodic transfer among funds of certain accumulated account balances and directions of future employee’s deferral and Company matching contributions is permitted.

**Participant Accounts**

Participant contributions are credited to the individual accounts. Each participant’s account is also credited with Company contributions and allocations of the Plan’s earnings or losses. Allocations are based on participant earnings or account balances, as defined.

**1. Description of Plan, continued**

**Benefits and Vesting**

The benefit to which a participant is entitled is the benefit which can be provided from the participant's accounts, which includes participant and Company contributions and related earnings thereon. Earnings are allocated based on the individual participant's account balance in relation to total participant account balances. Participants become 25% vested in sponsor contributions and related earnings thereon after two years of service of 1,000 hours or more, and vest 25% each additional year of service up to 100% after five years. The participants are immediately vested in their contributions, Davis-Bacon employer contributions and related earnings. The nonvested portion of a participant's employer matching account is forfeited upon the distribution of the vested portion of the participant's account.

**Payment of Benefits**

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may also be entitled to in service distributions for hardship, qualified reservists, or age 59½, subject to Plan provisions.

**Forfeited Accounts**

There were no forfeited nonvested accounts as of December 31, 2024 and 2023. Forfeited balances of terminated participants' nonvested accounts are used to either reduce employer matching contributions or pay plan administrative and trust expenses.

**Plan Expense Account and Unallocated Assets**

A plan expense account (the "ERISA account") is maintained to hold revenue sharing funds the Plan receives from Empower Retirement, LLC pursuant to an agreement between Empower Retirement, LLC and the Plan. These revenue sharing funds are available to pay qualified Plan administrative expenses. At December 31, 2024 and 2023, the ERISA account balance was \$90,923 and \$86,486, respectively. For the years ended December 31, 2024, and 2023, the Plan paid qualified administrative expenses out of the ERISA account totaling \$0 and \$13,904, respectively.

The Plan also holds funds in an unallocated asset account. For the years ended December 31, 2024, and 2023, the plan had unallocated assets totaling \$10,503 and \$9,990.

**Administrative Expenses**

Administrative expenses of the Plan, except certain investment and administrative fees, are absorbed by the Plan Sponsor.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting. Contributions from plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

**2. Summary of Significant Accounting Policies, continued**

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan's Administrator to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results may differ from these estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value (except for the fully benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The net appreciation (depreciation) in fair value for each investment option was determined based on quoted market prices and is included in investment income in the statement of changes in net assets available for benefits. The net appreciation (depreciation) in fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Payment of Benefits**

Benefits are recorded when paid.

**Management's Review of Subsequent Events**

The Plan has evaluated and considered the need to recognize or disclose subsequent events through July 30, 2025, which represents the date that these financial statements were available to be issued. Subsequent events past this date, as they pertain to the year ended December 31, 2024 have not been evaluated by the Plan.

**3. Investments**

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$1,612,744 as follows:

FASB ASC 820-10 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following is a description of the valuation methodologies used for the investments measured at fair value. The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds*

The fair values of mutual funds are valued at quoted market prices, which represents the net asset value of shares held at year end. The mutual funds are deemed to be actively traded.

*Self-Directed Brokerage Accounts*

The fair values of self-directed brokerage accounts are based on the underlying investments. Mutual funds are valued at quoted market prices, which represents the net asset value of shares held at year end. The mutual funds are deemed to be actively traded. Common stocks and other equities are valued at the closing price reported on the active market in which the individual securities are traded.

*Money market fund*

Money market funds are stated at fair value, which approximates cost.

**5. Fully Benefit – Responsive Investment Contracts**

The Plan has a group unallocated annuity contract with Empower Trust Company, LLC. Empower Trust Company, LLC maintains the contributions in a general account. This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. There is no minimum rate. The crediting rate is reviewed on a quarterly basis.

The deposit administration contract was included in the financial statements at contract value of approximately \$2,171,093 and \$2,186,690 as of December 31, 2024 and 2023.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no unfunded commitments.

The Plan may discontinue the contract at any time, upon written notice. In addition, certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

**6. Transactions with Parties-In-Interest**

During the year certain Plan investments were shares of funds managed by the Plan investment advisor, Fifth Third Bank. During the year, the Plan also held a fully benefit responsive investment contract with Empower Trust Company, LLC, the Plan's trustee. Therefore, these transactions qualify as party-in-interest.

**7. Information Prepared and Certified by Trustee**

Investments on the statement of net assets available for benefits and the schedule of assets (held at end of year) and investment income and related activity reported on the statement of changes in net assets available for benefits, with the exception of one self-directed brokerage account that had earnings of \$167,564 during 2024 and was valued at \$1,292,732 and \$1,008,644 as of December 31, 2024 and 2023, respectively, has been derived from information prepared and certified as complete and accurate by the trustee of the Plan, in accordance with Section 2520.103-5 of the Department of Labor rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

**8. Tax Status**

The Company adopted a prototype non-standardized profit-sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service on March 31, 2008, which stated that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**9. Risks and Uncertainties**

The Plan provides for participant directed investment options in any combination of twenty-four funds and self-directed brokerage accounts. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of the investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

**10. Priorities upon Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, the rights of all affected participants to amounts contributed by them and the sponsor and related earnings thereon would become fully vested.
